

Annual Parish Assembly - Sunday, February 9, 1986

Meeting was called to order at 1:15pm by Keg Giragosian. An opening prayer was offered by Der Hayr. Roll call of paid members present was read and a quorum was established.

Officers of the day were as follows: Kachie Bogosian, chairperson and Pat Hakalmazian, recording secretary. Gary Mazian was appointed parliamentarian. A ballot committee was appointed consisting of Irene Merijohn, Lottie Mikaelian, Edma Doumanian.

In order to have a shorter and more constructive meeting, the annual reports of the subordinating organizations were handed out to all members prior to the meeting.

Mr. Bogosian asked for questions from the floor on the annual report - there were no questions. Council activities - no questions. Budget - Mrs. V. Bogosian raised the question "We have more members this year, why are the dues \$2,600 shorter than last year?". - Andy Sahagian explained that Church books were closed with the fiscal year ending Dec. 31, 1985. Many people paid after this date.

At this point, Mr. K. Boyajian stated bills for annual dues were not sent. Mr. Sahagian answered that statements had been sent out. Dr. A. Yeretsian moved to approve the 1986 budget. Seconded by Mr. K. Tarazoff. Motion carried. Mr. Bogosian, the trustees and parishioners thanked Mr. Sahagian for a job well done.

Comments or questions on the organizational reports were asked of those present, with the following result: Women's Guild - no questions, Sunday School - no questions, Choir - no questions, ACYOA - no questions.

Mr. Bogosian asked if there were any objections to voting at this time and taking up the other reports and new business after the elections were finished. Mr. R. Auer moved to close nominations. Seconded by Mr. G. Hakalmazian. Irene Arakelian. There were no further nominations from the floor. Elections by secret ballot took place. Votes were counted as follows - five required: Dennis VanderMeer, 50, Sonya Doumanian, 47, Garbis Meguerian, 44, Rosey Yeretsian, 40, Liz Sahagian, 35, Berj Gureghian, 23, Irene Arakelian, 13.

The slate of candidates for nominating committee was presented.

Four were needed. Gregory Srebian, Gregory Hakalmazian, Robert Auer, There were no further nominations from the floor. Mr. D. Vander Meer moved to accept the nominating committee and not vote by secret ballot. A second by Mr. Charles Terzian. The motion was carried.

The slate of candidates for auditing committee was presented as follows: Martin Randall, Raffy Hovanessian, Denise Stachowiak, and Pat Hakalmazian. Mr. D. VanderMeer moved to accept all four individuals for the auditing committee. Mr. Charles Terzian seconded. The motion was carried. Shunt Madanyan took this time to ask for help with sports weekend.

Mr. Keg Giragosian discussed the possibility of getting either a copy machine or a computer.

Mr. Martin Randall moved that all committees keep their book according to a curriculum set by the parish council and submit to the auditing committee. Seconded by Mr. D. VanderMeer.

Mr. Keg Giragosian said there will be a second annual dinner dance on Saturday, May 17.

Mrs. Lottie Mikaelian asked if the men could get together and help donate money to the Church, as the Ladies do.

Mr. Chuck Gederian asked if the entrance and exit signs could be put back in front of the Church.

The meeting was adjourned with a prayer offered by Der Hayr at 3pm.
