
Your Eminence,

We have received the Accounts Receivable Aging from the Diocesan Council Treasurer's office which shows a balance in the amount of \$1,000.00 from last year. We kindly request that the Diocesan Council with your advice take this matter into consideration since our budget was cut drastically last year by the loss of income from the lease with the Dade County School Board. We have thus far not been able to make up that loss of income in our budget and therefore it causes a hardship on our Council Treasury situation. We are trying to keep 1996 Diocesan Assessments up to date even though our financial situation has not been stabilized as yet.

We therefore request your Eminence to convey our request to the Diocesan Council to waive any balances due from 1995. We await your response on this matter. Should you have any questions or need any further information please do not hesitate to contact us.
