Dear Mr. Hagopian:

We have what we feel is an ideal solution for the needs of your Parish. We are planning the appointment of Rev. Papken Maksoudian currently the pastor of the Holy Trinity Church in Cambridge, Mass., as pastor of the St. John the Baptist Church of Miami.

Rev. Maksoudian is one of our outstanding clergymen who has served the Boston parish for 17 years, in the course of which a great new church was built. He is highly regarded, but for some time has expressed the wish for a change, principally for reasons of climate.

His is one of our largest parishes, and we feel he will be even more effective in the relatively smaller Miami community.

With regard to stipend and other considerations, it would be most appropriate that he be remunerated at the rate of \$140-150 a week, with which he would maintain himself completely. The Parish Council would also take care of his social security (approximately \$480 a year) and half of his clergy insurance (\$320). Finally some arrangement should be made about a car, with the Parish Council either providing the car and Father Papken undertaking the other expenses, or Father Papken providing his own car with the Parish Council undertaking the insurance and repairs.

Arrangements on this basis will, we feel sure, best serve our Miami church, and this appointment can be made effective with the first of the year.

Dear Mr. Hagopian:

We regret very much that the tentative arrangements initiated for providing your parish with a permanent priest had no positive results. Rev. Papken Maksoudian is not available for service elsewhere, and will continue in his present parish.

However, we do have an application from Rev. Kourken Koudoulian from Visalia, California, in the Western Diocese. Because Rev. Koudoulian does belong to another Diocese, certain procedures must be followed.

First, your parish should communicate with him, without making a final commitment. If agreement is reached on conditions of service, Rev. Koudoulian must apply to his Primate requesting release from the Diocese. Once this is secured, he will apply to our Diocese for admission; and only after this procedure may we appoint him to your parish.

The enclosed letter details Rev. Koudoulian's record of service and qualifications.

We would like to know your plans in this regard at your earliest opportunity.

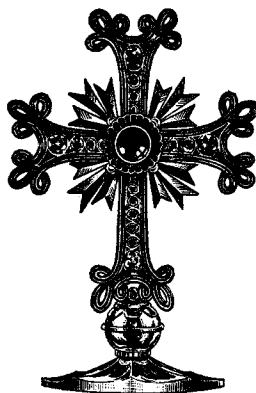

Dear Mr. Hagopian:

Deacon D. Basralian called me about a planned wedding between an Armenian young man and Puerto Rican girl. We were to inform Mr. Basralian about permission for a Catholic priest who is a relative of the girl to perform the wedding ceremony in our Church, since at present we do not have an Armenian priest in the Parish.

We could not call Mr. Basralian, and in a few hours we have to leave for Washington, D. C. to attend the General Board Meeting of the National Council of Churches.

Considering the circumstances, we may permit a Roman Catholic or any Orthodox Church priest to perform the wedding ceremony in the Armenian Church on the following conditions:

1. The priest should use the English translation and the ceremony of the Armenian Church.
2. The priest, with the assistance of an Armenian deacon, should study the Armenian Church wedding ceremony, follow the instructions, the rubrics printed in the wedding book, and agree to perform a wedding according to the practices of the Armenian Church. He can, with the assistance of the deacon, decide on passages that can be eliminated.
3. Marriage certificate of the Armenian Church should be completed and given to the couple.

There apparently is some confusion concerning our correspondence to your parish. As a rule, we address our letters to the pastor of the church who is also President of the Parish Council. All such letters are official, not personal. They are directed to and are the property of the Church when addressed to the pastor as President. This applies to our correspondence with Father Hmayak Intoyan.

On August 15th, Father Hmayak travelled to Miami as pastor to celebrate the Divine Liturgy; this was done with our knowledge. The expenses incurred during his trip were \$141.69, all of which should be reimbursed to Father Hmayak.

We have been informed that Father Hmayak has conferred with Mr. James Pilafian who has reconsidered and withdrawn his resignation, and will continue as Chairman of the Parish Council. Father Hmayak himself will return to Miami on October 1st and will perform the badarak regularly from October 3rd until next summer.

With Father Hmayak's service as pastor and with the cooperation of the Parish Council and church organizations, this will surely enable our church to continue and develop its sacred mission in the Miami community.

We are pleased to appoint you Pastor of the St. John the Baptist Armenian Church of Miami, as per our earlier conversations.

You will assume your new pastorate with the celebration of the Divine Liturgy on October 8. Your final Liturgy in Bridgeport will be on October 1.
