#### Gentlemen:

I contratulate you on the second anniversary of the consecration of St. Vartan's Armenian Cathedral and enclose a small donation . I hope someday to see the cathedral but from the pictures it is very handsome.

Although I would ordinarly not write, I would in this instance add a voice from the Minterlands. My late father was active in church and community affairs and we have had many priests of the church as visitors including the late Archbishop Tourian and Archbishop Tirayre. So that I am quite aware of the background of the split in our church and our small community. And I am not naive enough to ask for immedate "miutuyn."

However, later in the Armenian Reporter there has been a running controversy on the "where" of Armenian weddings when the bride and bridegroom belong to diverse affiliations of the church. There have been such facetious solutions as going to city hall, an "odar" church and clergyman; no church; or bringing about an independent Armenian church.

It seems that when we take pride that the Armenians became the first Christian nation, we should also try practicing the Christian virtues first and politics second.

So, in the spirit of <sup>C</sup>hristianity, I think it would be to the glory of the Armenian church as a whole to have priests of either the Etchmiadzin or *illician liocese* to participate together in wedding ceremonies in whichever church they are held -- if this is the wish of the bridal couple. Fortunately, our services are so elaborate that any number of priests can take part. ( I realize this is not the problem).

My father was an Armenian and a Dashnagtzan and we belong to the "other church" in Syracuse. However, I have visited both Etchmiadzin and Cilicia in Lebanon. Both have historidand current significance. I personally believe that Etchmiadzin is the mother church but I believe that in some centuries, Cilicia also had leadership. So I see no reason why they cannot and should not cooperate to this extent.

In the instance of weddings and funerals, too, I believe that this cooperation is not asking too much.

At a recent funeral in Syracuse of a leading musician (non-Armenian) the Catholic Cathedral was the site of the service. Taking part with the Catholic clergy were those of the Jewish faith, a layman and Protestants. So that requesting Armenian priests-- though they be affiliated with different diocese-does not seem asking too much in this day and age.

I submit this respectfuldy and hope that some overtures be madein this instance.



Your Eminence,

Per our telephone conversation as of the last week in July, this is to inform you and the Diocese that St. Paul's Armenian Apostolic Church of Syracuse, New York no longer desires to pay for the services of officiating deacons, and therefore would encourage an end to the Binghamton/Syracuse contract. We will leave the situation "status quo" until the end of September, as you suggested earlier.

The parishners, who are comprised mainly of the older generation, have expressed a desire for two (2) Badaraks a month, with the exception of the summer vacation months of June, July, August and September, which will include only one (1) Badarak a month.

Presently a marked emphasis on interesting the youth into church oriented activities is taking place. This takes time, patience, and money. The treasury is definitly not overflowing plus has given way to necessary expenses, which have greatly exceeded any intake in recent months. In addition, the building itself is in need of major repairs. A money factor is indeed the major reason for our request to break the contract.

Referencing your letter dated September 26th, 1973, the parish of St. Paul's Armenian Apostolic Church, Syracuse, New York, have participated in an all important meeting this past October 24th, 1973. Thirty (30) members were present, of which, seventeen (17) voted favorably to accept Deacon Manoug Kelegian as "Deacon in Charge" of the Syracuse parish. It was noted that some of the known "unchangeables" did, in fact, alter their decisions, realizing that plodding along as we are presently, could spell an end to our church's resources within a relatively short time.

Financially speaking, it is evident that our treasury cannot afford this expense on a continuing basis, so a lot will depend on renewed and increased support from the parishners, and how results oriented the new deacon proves to be.

You will remember, Archbishop, that I had written to you previously stating that the parishners preferred two (2) Badaraks per month during autumn, winter, and spring. This decision is definitely <u>not</u> to change even with the addition of Deacon Kelegian! A solution to this extended expense was aired and agreed upon during the latter part of our recent meeting. St. Paul's would now appreciate some return support from the Binghamton parish, by asking their participation in an "exchange" plan. Since Deacon Ray has been ordained, and the Syracuse people want Badarak twice monthly, let us trade Deacon Manoug twice a month to perform services in Binghamton, while, during these same Sundays, Father Kevork celebrates Badarak in Syracuse. No money to be exchanged! Please let us know if this plan can be effected. The Syracuse parishners are excited and seem impatient to welcome our new deacon!



Some years ago the Binghamton parish, located in a relatively small community and eager to be able to afford a full-time pastor, had the happy idea of establishing a pastor's fund. The church leaders felt that it was imperative to have a full-time pastor for the welfare and natural growth of the community. But the limited resources of the small community seemed to discourage such a prospect.

To counter this circumstance, the pastor's fund was created and in a relatively short time more than \$10,000 was accumulated, at which time petition was made to the Primate for a full-time pastor. As a reserve, the fund made this possible.

The Binghamton example is one that other of our smaller parishes can follow with benefit. We urge your parish Council to give serious consideration to the idea which can be a boon for the future of your community.

Even if it takes three or four years to put together a fund that could encourage your parish to seek a full-time pastor, it will be well worth undertaking. We cannot recommend such a step too highly.


