Dear Paul:

The establishment of an ACYOA Alumni Group would be of tremendous value to the ACYOA as well as to maintain an outlet for adults who are no longer actively involved in the ACYOA, but identify with its purposes and wish to support it actively. If you recall, the initial attempt was made in Providence in 1977, but no follow-up took place.

Enclosed is a rough outline of a proposed Alumni Association. As you know, the idea of forming an Alumni Group was discussed at the General Assembly last August and the Assembly did decide to embark on an Alumni program.

I have spoken to several "would-be" ACYOA Alumni and all of them have a very favorable opinion of the idea and are interested in getting involved. Can we set a target date of having the first Alumni session on the Saturday of the 1980 Sports Weekend? This would fit right in since the traditional Alumni Dinner Dance is on the Saturday night of every Sports Weekend. We have talked about this in a recent Sports Weekend Committee meeting as well, and the Committee felt that a good arrangement would be to have an Alumni Session on Saturday, followed by an Alumni Cocktail Party, and then the Alumni Dinner Dance.

Please put this proposed draft of the Alumni Association on the agenda for the next ACYOA Central Council meeting. This is by no means meant to be a finished set of by-laws, but a tentative outline. I would be willing to form a committee and pursue this further, and lay the groundwork for the Alumni Group. We will need something temporary to go on that can be reworked if necessary and then ratified by the first Alumni session. Then we will have to work on a mailing list with the objective of getting as many alumni as possible to attend the first session on August 30, 1980. This will also attract more people and families to come to Sports Weekend, something we've wanted to achieve for years.

Dear James:

I received your correspondence of February 12 and regret the late reply. However, I have several comments which, for clarity's sake, are outlined below:

1. You mentioned drafting letters for a financial appeal. Please do so at once; we really cannot afford to wait.

2. With regard to mail sent from the Diocese, any letters addressed to you are forwarded immediately, so this should not cause any major delays. Also, all mail is sent first-class unless it is a bulk mailing or particularly heavy. Lastly, please keep the use of your personal address to an absolute minimum; I know it may be inconvenient at times, but it would be more appropriate to keep headquarters in New York as the official corresponding address for the A.C.Y.O.A.

3. Petty cash needs should be arranged with the A.C.Y.O.A. treasurer. Perhaps they can forward you \$100. periodically which can be justified later with receipts.

4. Concerning the "Certificate of Recognition," the design struck me as a bit unimaginative and old-fashioned. Also, what is the criteria for winning such a certificate? It was not clear.

5. With regard to the A.C.Y.O.A. emblem, I felt we should wait until the Canadian Diocese is officially separate and then with a "design contest" embark on a revamping of the design (i.e. removal of the maple leaf, etc.). Also, why change the color?

6. Suggestions for new stationery do not seem to be much of an improvement on the old - in fact, from the samples you submitted, the old design had a better appearance than the new. Any name added to the stationery, by the way, should not appear under the Primate's, but should appear at the bottom, perhaps on the same line as "Central Council" is. I do think it is an excellent idea to have each chapter add its own name to the stationery. Also, the Junior A.C.Y.O.A. stationery should not be the same as the Senior; the age groups and interests are completely different and this should be an Assembly decision.

7. Concerning Item IV - on the lecture-discussion program - I would be in touch with Nancy Basmajian. She has set up a very good program with the Juniors, advising them of meeting ideas, fund-raising suggestions, and cultural activities they can plan and organize in their parishes. This kind of thing with different areas would be good for the Seniors.

8. Membership cards seem to be fine. I think they should retain the distinctive A.C.Y.O.A. purple color; plastic-coating is too expensive and not really necessary. As for the <u>Sacraments and Prayers</u>, a committee of clergy, youth, artists and publicity people should be organized to see the project through and present a final outline to the Primate. Earlier presentations and changes for its reprinting were begun by Valerie Goekjian and Edward Kaiserian and should be on file. Also, funding for the project should be sought. Perhaps a former A.C.Y.O.A. member who may be a professional printer could do it for free?

9. Lastly, concerning the Armenian Studies Program, where is the corrected flier? (You enclosed the old one.) There should be more advertising with more details concerning who can join the trip, ages, qualifications, etc. There was a list of donors to be contacted for financial assistance. What is happening with that?

That is it for the moment. I am truly sorry for the matter-of-fact outline, but it seems the best way to cover all comments and questions long-distance.

This letter is in reference to your memorandum dated February 11, 1981. I am in favor of the Certificate of Recognition and the Lecture-Discussion but am strongly opposed to the rest of the proposals.

The Certificate of Recognition is a nice way of saying thankyou to not only Central Council Members (both past, present and future) but also Chapter Chairman. It is these people who do quite a bit of work and very seldom receive recognition for it. People forget that a simple thank-you means alot.

The Lecture-Discussion Program also seems like it would be very beneficial but why do we have to make it in the form of a proposal? It seems as though the Central Council can just implement this program on their own.

I know many chapters who would like to have such a program but are not aware as to how it should be set up. If we can give them explicit guidlines to follow, I feel this would be very beneficial to many chapters.

I am totally against the re-designing of the A.C.Y.O.A. emblem. Our organization designed this many years ago and I feel it should stay as is. You may look and say, "Well times are changing" but that is not the answer. Are they converting the Armenian Services in our Church to all english because the majority of the young adults today cannot speak the language, No! We should keep our original identy and not try to modernize it or change it.

This also would involve alot of printing for various forms and at the present time we do not have this type of money to play around with. This is our emblem and I feel it should stay as is.

Another thing which I am quite surprised that would <u>even</u> be <u>considered</u> is the reprinting and design of our stationery. Our stationery is beautiful the way it is and it fits the needs perfect. We should have plenty of it. I know myself, I have over 500 sheets.

If we print it with the Executive Secretary's name on it, what happens in the event the Executive Secretary should take on another job in years to come and the Central Council is without an Executive Secretary for another two years. Does that mean the Central Council would have to print more stationery with no name on it and then when the new Executive Secretary is found, re-print new stationery. This seems very wasteful and unrealistic. The simpler the farther it will go. Also, as I have mentioned before, we do not have the money to spend on this. If we have the money to print on the stationery than I feel all Central Council members should attend the Chairman's Roundtable meeting. After all, we are the ones who are implimenting the program and we all should be there to help our Chapter Chairman out. Also, at this time we can talk to our Chairman in our particular regions. But looking at it at a realistic way, we decided not to send two Central Council members because of the financial cost which I feel was done to the best interest of our organization. But printing and re-designing of our stationery is a wasted expense! If the delegates want us to revise and redesign the stationery fine, but we have no authorization to do it on our own.

Also, membership cards may be needed but do we <u>really</u> need them this year? We should ask ourselves how many people use them. This again is an added expense which we do not have the money to waste on.

The A.C.Y.O.A. Banner and Poster again sounds like a crazy idea. How old are we? Things like that are more for the juniors. How many people are going to use it? Would you hang a banner in your home, car, etc.? People may buy them and look at it for a month but it will probably then be put into the drawer or thrown away. At our last meeting, if it wasn't for the Diocese subsidy, we would not of had enough money to pay for our own personal operating expenses. Where will the money come from to design and print these? We can barely meet our bills now!

I am sorry I am sounding so negative on the majority of the programs but I feel it is my duty to represent the organization to the best of my ability. If these programs should go through, the General Assembly will be informed by myself that it was not through a majority vote!

After our last meeting I am very shocked about these proposals. It was also noted in the memorandum that the Executive Secretary was to have stationery printed very soon. If that is the situation I would also like to request to have my own personal stationery. Mr. James Magarian March 2, 1981 Page 3

The Central Council and Executive Secretary should sit back and think twice about what we are doing before we jump into it.

ATTACHMENT: ISSUES OF CONCERN

The analysis which follows will present several questions and my viewpoints regarding them. It is hoped that the discussion will not be taken personally, and that it will provide some food for thought, and eventually, some action.

I THE ROLE OF ACYOA WITHIN THE DIOCESE

What is the interrelationship of the ACYOA with the Diocese and its organizations? For what is ACYOA responsible and for what are the other organiza tions within the Diocese and parishes responsible?

According to the ACYOA Constitution, which was approved by the Diocesan Council, our primary explicit responsibility is to the youth of the Church, who are aged eighteen and older. Yet, at the past several Central Council meetings we have also become responsible for other areas of concern within the Diocese. This raises the conceptual issue of the role which ACYOA <u>should</u> play within the Church.

I contend that ACYOA cannot be expected to provide the solutions for everyone or everything. The organization cannot be expected to provide its limited human and financial services to assist other Diocesan/parish organizations/ventures if it is to the detriment of the ACYOA. Furthermore, we cannot be short-sighted. Although our assistance in a certain area might be beneficial for the ACYOA in the long-run, it might hurt it enough in the shortrun to ensure that ACYOA no longer exists when the distant future arrives.

Thus, I find it confusing to listen to arguments for ACYOA to be doing work for the Juniors. They have a person at the Diocesan level working halftime; in a sense we would be usurping her authority. Moreover, why should we assume that ACYOA Seniors can better deal with the problems and desires of the Juniors than another organization within the Diocese? The best advisors for Juniors on the local level have always seemed to be the somewhat more "veteran" ACTOA alumni...from the 50's and early 60's. Additionally, I do not find it wise for any organization to overextend itself. The risks involved with spreading too thin are too costly. We are in danger of not doing anything well; we risk failure on all fromts instead of successes on a few well chosen ones. What good will it do the Juniors if we help them now but cannot assure them that a Senior organization will exist when they come of age?!

The amount any organization can accomplish is a function of its human and financial(capital) resources. The maximum output of ACYOA is similarly constrained by such resources. The solution is to retrench, cut-back, and properly direct our energies and material strength. First, ACYOA should do what it was set up to do originally. Then, once this is accomplished SUCCESSFULLY, it can expand to other pastures. An organization should only spend and provide according to its means. It is not only a question of efficiency but that of EFFECTIVENESS. We could be very efficient in allocating our resources, but completely ineffective in doing so in light of our missions and objectives.

Right now, I do not see ACYOA meeting the challenges of the market which it is supposed to serve, according to the Constitution. Until we have met these challenges and have them under control, we should mind our own business, and our business only. If every organization within the Diocese did so, there would not be a problem of the interrelationship of these groups.

II THE PURPOSE OF THE ACYOA

Once the interrelationship with the Diocese has been delineated, clearly established, the Central Council of the ACYOA can begin to determine the e 3


its missions/goals/objectives....both short-term and long-term.

What do we, as an organization hope to accomplish in the next year? in the next two years? five years? twenty years? I am not talking about the specific programs/activities, but in general terms, WHY DOES ACYOA EXIST? What do we hope to accomplish through these activities which we so diligently plan and promote? Are we trying to make the youth aware of their Armenian heritage? Are we trying to teach them the traditions and doctrine of the Armenian Church? Are we trying to propagate the Armenian Church? the Armenian race? What is our MISSION?

Whatever our goals are for the long run, we must determine them, prioritize them and then establish programs specifically intended to help us ment those goals. We must also set up some specific short-term goals, with the relevant programs.

Unfortunately, I do not see the Central Council of the ACYOA, which is the primary planning body for the organization, doing any such long-range and short range planning !! We just deal with the operational , days to day, issues of ACYOA. Well sorry folks, I cannot see how you expect an organization to progress and grow in such a haphazard manner. Even when a person plans a family these days we are talking about weeks, months , years of planning. Should we be any less therough in the work of the Church Youth Organization?! We sponsor activities, but do we all have some understanding as to why we are sponsoring activities? If we could determine the underlying basis for the programs we suggest, and discuss THESE ISSUES, then we could easily prioritie our programs; the prioritization would proceed by what they hope to accomplish (benefits), rather than by financial costs. To base our decisions, as we have been doing in the past few meetings, on the financial considerations only is the worst thing for a non-profit organization to be doing. Not everything can be measured in dollars and cents. We should be talking about what our goals are and how this program will help to achieve those goals.

For example, we should not be discussing the Armenian Studies Program in and of itself. What we should be thnking and saying is that we have a <u>long run goal</u> to make the Armenian youth more aware of their heritage. Then, we say that we intend to increase this awareness by the Armenian youth by 25%, in the <u>short run(</u> in the next two years). Based on these two missions, we are ready to consider alternate strategies for accomplishing them. One such strategy could be to target our activities to those who are ages 21 and older. Another could be to target them to those whose names begin with the letters A through H. Then, we select the most appropriate program for the particular group with which we are dealing. So, we might decide to have a program for members aged 21 and up called the ASP, then we worry about the actual tactics of the activity...the definition of the program to the last detail.

one there will have have In the instance of the way the Central Council does its planning now, the arrows in my diagram would be reversed. It is a very illogical way of doing things. It wastes a lot of time, and enangy of the CC members. It keeps us tied up with trivial matters and LEAVES US WITH NO TIME TO CONSIDER THE REAL PROBLEMS FACING THE ORGANIZATION V Five years ago, ACYOA had a long range plan because the organization had just been reformed and there was a sense of direction. Now, we have reached a stage in the development of the organization to re-evaluate our long range plan and make up a NEW IMPROVED LONG RANGE PLAN. This year is a CRITICAL YEAR for the Central Council.

The benefits of directing our offorts toward the planning and logical analysis of ideas are numerous. If the chapters and membersip see the CC and ACYOA progressing in such a manner, they might have more respect for what ACYOA and the CC are doing. The CC could actually LEAD and GUIDE the ACYOA out of mediocrity. If we fail to set the example, how can we expect chapters to do things any less RANDOMLY AND HAPHAZARDLY than we are? So, at the General Assembly in 1981, I certainly hope that we present a report on behalf of the Central Council which shows a logical basis for our actions AS WELL AS outlines for the long range and short term development of the organization. If we cannot make a statement regarding the direction of the ACYOA, who can?

Finally, it should be noted that IT IS THROUGH OUR GOALS/ MISSIONS/ OBJECTIVES AND STRATEGIES THROUGH. WHICH WE CAN DIFFERENTIATE OURSELVES FROM THE COMPETITION NOT THROUGH OUR TACTICS For example, Hye Travel and ACYOA could both offer the exact same tour of Armenia. The difference between our program and theirs would be the difference between our goals and their goals. Believe me, the general Armenian public is quick to see through to these underlying goals, being as paranoid as Armenians are. So, if the goal matters to them, they will pick that tour. All we have to do is make sure that people can read between the lines to get the point.

IN SUMMARY, I would therefore like to see a significant portion of our next meeting devoted to the issues of GOALS. We need to define our direction before we inadvertantly run ourselves into the ground.

III THE ROLE OF THE EXECUTIVE SECRETARY AND CENTRAL COUNCIL

What is the function of the Executive Secretary? What is the function of the Central Council? In what manner do they interact, interrelate? Who is responsible for what?

It has been my understanding that the Executive Secretary is a STAFF position, as opposed to the LINE position of the Central Council. In other words, decision-making is done by the Contral Council(line authority) while supporting functions are carried out by the Executive Secretary(staff functions). An analogy in the business world would be the difference between a Vice-President of the XYZ Division (line) versus the Assistant -to-the President(staff). The Assistant merely investigates matters for the President and the other line -managers. He considers alternatives, presents them, and makes a recommendation. The final decision restauth the Division Managers This is exactly how I had envisioned the relationship and the President. between the Central Council and the Exec Sec.

What I am actually seeing, however, is a great deal of "decision-making" occurring at the Exec. Sec. level. What I am seeing is a lack of alternatives being presented regarding each issue raised during meetings. What I am seeing is a lot of things being forced down the Central Council's threats! This irritates me, frustrates me, and causes me to believe that I am not being al-lowed to perform my obligations to my "constituents"; I am not making any policy decisions; I as not guiding or leading the organization. The Exec. Sec, has become the de facto leader of the organization. This seems to be a VERY INTERESTING turn of events.

If everything has algeady been predetermined, why do we need a Central Council? to do someone else's grunt work? I thought is was a position of leadership and not one of serfdom! True, there is a certain amount of work that Central Council members must do, but I see nothing different between the work I do now and what I was doing a year ago. So WHY DO WE HAVE AN EXEC. SEC.? WHAT EXACTLY IS HE DOING THAT WAS NOT GETTING DONE BEFORE?!

I had anticipated, for example, the following interrelationship between the CC and Exec. Sec.:

The Central Council decides that , in the long run, we should strengthen the understanding of our Armenian heritage among the membership. In the short run we determine that we want at least 25% of our current membership to be involved in a program of activity which will achieve this long term goal. Finally, we suggest a few ideas for programs which might be the means for achieving our aforementioned goals. At this point the Exec, Sec. goes to his drawing board. He not only investigated the alternative programs proposed, but thinks of otthers as well. He develops several options (PLAN A, PLAN B, PLAN C, ETC) and presents them to the Council at the next CC meeting, with his recommendation. Then, the CC determines whether it has enough information to make a final decision regarding the matter. If not, the Exec. Sec. goes back to the drawing boatd. If yes, then a decision is made. Bear in mind that the Central Council members will asist the Exec. Sec. in gathering the necessary information for his presentation. They will also help the Exec. Sec. further develop proposals they had suggested, by further elaborating on them. But, the bulk of the work is done by the Exec. Sec.

The Central Council will thus be freed up to do their particular assigned tasks and will spend less time worrying about developing the operational issues. They will have more time for Public Relations and Chapter Visitations; this will help the local chapters develop. They will be able to lead and guide these chapters and develop the creativity within each chapter. It is only by strong leadership that the GC can hope to achieve some respect. Right now, we are not providing this needed leadership because we he belabored with the tactical problems.

It worries me tremendously when the Exec. Sec. comes to a meeting with only one alternative developed (without costs and benefits considered, at that!). Of course, the Central Council will proceed to rip it apart because

- 1) they do not see the reasoning behind the single proposal,
- 2) they assume that the other algernatives were not thoroughly considered,
- 3) they were not shown how any of their bright ideas just would not

work. given the circumstances.

The time spent in knocking down suggestions is unbelievable! And of course, after tearing down the Exec. Sec's suggestions, in order not to delay decisions further, we proceed to develop the other alternatives on the spot. That is really ridiculous. Quick decisions should not be thoughtless decisions. What we end up doing is making a rash judgment without considering the numerous ramifications of our hasty decision. Tempers flare and we begin to form coalitions to defend our arguments ... in a group of 6 people. We are forced to make these rash decisions because they cannot be delayed any further. We are caught in between a rock and a hard place! If we do not make a decision, we will be accused of inactivity, indecisiveness. If we make the decision, we risk making a grievous error. In the long run, the result of our actions will be disastrous. Personally, I would rather remain stagnant than move backwards. Not all movement is positive.

In conclusion, I consider the Exec. Sec. as a staff member to the President of our organization, the Primate. He assists the President and the Central Council in developing ideas, alternatives and options...THOROUGHLY. He is not a decision maker. He is not the one who will get blamed if things go awry. The Central Council is always the one body who is ultimately responsible for Attachment p.5

the mistakes, not the Exec. Sec. THIS UNDERSTANDING IS CRUCIAL TO MY DECISION TO REMAIN ON COUNCIL. I suppose I could live with no long range planning, but the relationship between the CC and Exec. Sec. must be cleared up before things get out of hand. If it is not, I simply cannot afford to waste my time and energies. I am not doing what I was elected to do, nor what I think I ought to be doing, as a Central Council member. Quite frankly, when my personal future is at stake, my priority must lie in assuring myself a future. If I were to be forced to drop out of school, or drop a class, is ACYOA or the Diocese going to pick up the tab? Certainly not! An individual can be selfless only to a certain extent... to the point where he/she begins to lose his/her identity. I would be totaly useless, no matter how devoted I am, to the Church and ACYOA, if I lose my identity.

Those that nobody has taken offense, but I had to express these thoughts. It is always in the interest of the Organization. Otherwise, I would not even bother to spend time and effort in developing these very lengthy arguments. I would appreciate a response, in the interest of the ACYOA and the Church.

Your Eminence,

I respectfully request that you and the Diocesan Council reconsider approval of the ACYOA magazine fund raising program operated by Maynard Merel.

One Reason to reject this campaign is that legal problems for the Diocese may develop from using names of those on the Diocesan mailing list for business purposes. Individuals allow themselves to be on the mailing list to receive Diocesan news and religious material. They do not expect business solicitations. This does not seem to be an appropriate use of the mailing list or an appropriate function of the Diocese. Surpazan, the Diocesan Council, ACYOA Central Council, and James Magarian may be subject to lawsuits if the Diocesan mailing list is used in this manner.

A second reason for rejection even more important than the first is that valuable information about the Armenian population may be gathered by Maynard Merel. Each subscription will ultimately be forwarded to him. He will be able to compile lists of Armenian professionals, such as doctors, lawyers, business leaders, artists, etc. This infomation will easily be known by the type of magazines and by those ordering for their offices. This is exactly the same kind of information the Turks used in effecting their massacre of the Armenians. Addresses will be known, and if people move they can be kept track of as they change their mailing addresses on subscriptions. This information will probably be made availabe to anyone who pays. To prove that the information was sold would then be nearly impossible.

Not much is known about Maynard Merel or about his business. He has revealed practically nothing. He is willing to spend money to get our business and he is also willing to alter his program to gain our business because the information that he will gain is important.

Please do not rely on the business judgement of James Magarian or ACYOA Central Council members or delegates. It is too easy for them to be convinced by the lure of a few thousand dollars. It would be easier to seek donations than to sacrifice the security and privacy of our community, which we might be doing for a few dollars. Even the level of work required is too much.

I hope that you will have the wisdom not to underestimate the deviousness of people these days, and will recognize that the information which can be potentially gathered by this program will, at the very least, be a violation of our community's privacy and can be a real threat to our security if given to the wrong hands as it most likely will be.

Mr. Steinberg's target was the controver-sial and still widely used practice of pre-screening. Typically, this is a means by which companies can narrow their target audience for a direct-mail campaign when they are marketing a product or, as m the case of Bank of America, a service.

This is how Bank of America used presrented a huge list of names and addresses from Reuben H. Donnelley Corp., a firm that gathers names from public records, publish-ers' mailing lists, mail-order houses and the like,

like. The bank turned over this list to TRW Credit Dula, a division of TRW of Cleveland and one of the nation's largest credit bu-reaus. These firms are rather like libraries, collecting and storing information on con-sumers from lenders. reau's files are examined without either the reaus files are examined without either the knowledge or the consent of the people on the list, prescreening is a dangerous inva-sion of privacy. Mr. Steinberg uses earthier language: "It's a rape of our files because nobody even bothers to ask." Byen the Federal Trade Commission has expressed elevativity in the next chergit the

Even the Federal Trade Commission has expressed skepticism in the past about the practice. In 1972, when Congress was consid-ering the Fair Credit Reporting Act, it asked the agency for an interpretation of the legts-lation. The FTC said it felt the act banned prescreening in all direct-mail solicitation. But a year later, apparently under pressure from the credit industry, the agency changed its mind. Prescreening, it said, "results in no significant harm to consum-ers" and is permitted by the act. Although

"results in no significant harm to consum-ers", and is permitted by the act. Although the agency's opinion in this case has no force of law, it is generally considered to be significant in the event of a legal challenge. When Mr. Steinberg received the Bank of America credit-card offer, he didn't know anything about the credit-reporting act or even how the bank had found his name. His first step was to call his own bank, which suggested that he contact the two largest credit bureaus in San Francisco; tederal law requires credit-reporting agencies, if law requires credit-reporting agencies, if asked, to disclose the names of recipients of a report on a consumer during the previous six months.

But both credit agencies, one of which was TRW Credit Data, said they had given no report on Mr. Steinberg to Bank of Amer-ica. Raffled, he fired off an angry letter to the bank.

The bank's reply identified TRW Credit Data as the source of the information and said that Mr. Steinberg's name had come up said that out of prescreening. "The only infor-mation provided us is your name and ad-dress and the fact that you have an excel-lent paying record," the bank wrote. "No confidential information has been pro-reded."

vided." Mr. Steinberg didn't agree, insisting that his payment record, excellent or not, is conhis payment record, excellent or not, is con-fidential information. After a great deal of research into the law and into the practice of prescreening, Mr. Steinberg hired a law-yer, and in April 1977, he sued TRW Credit Data for \$3 million alleging, among other things, Invasion of privacy. He asserted that the credit company's prescreening of him for Bank of America violated the credit re-porting act and that TRW also had aread her.

for Bank of America violated the credit-re-porting act and that TRW also had erred by not disclosing that it had made a "consumer report" on him to the bank. TRW's response cited the FTC's opinion that the act permits prescreening. The credit firm said it hadn't made a consumer report on Mr. Steinberg by merely giving UB Bank his pame and address. Its argu-ment ran that if every inverses inputs. ment ran that if every prescreening inquiry on a consumer were to be noted, it woul

make it appear that the consumer's pay-ment record was constantly being chal-lenged or inspected.

By this time Mr. Steinberg also was in touch with the FTC. The agency's lawyers, touch with the FTC. The agency's lawyers, he says, had informally encouraged him to go ahead with the suit. Any consumer re-porting agency using prescreening should be prepared to defend the practice if chal-lenged, Mr. Steinberg was told by the FTC. Mr. Steinberg was told by the FTC. Mr. Steinberg says he robuiled TRW when the credit agency first tried to settle out of court because the settlement didn't

out of court because the settlement didn't say that any changes would be made in the

Say that any charges would be made in the way credit records are screened. Within several months, in late 1977, how-ever, Mr. Steinberg and TRW came to terms. The credit firm admitted no hability on any of Mr. Steinberg's charges, but it agreed to pay him \$20,000 (which is tax-free) and to pay his lawyer's fees of \$15,195.

Instead of sending the screened list directly to a bank or to any other lender, the company now turns the list over to an independent mail-solicitation firm that doesn't have any information on the credit criteria used to cuil the list. This firm then sends out the credit offer to the pro-spective customers. The first time the lender has any information on a person is when it is contacted by the consumer. A spokeswormen for TRW Credit Data.

A spokeswoman for TRW Credit Data, Julie Wright, concedes that Mr. Steinberg's

Bruce Steinberg, the plaintiff here, who objected."

- 1. Twice a year, on February 10th and August 10th, a complete listing of all names on the National Armenian Youth Listing will be prepared and printed and sent to the following:
 - 1. Executive Secretary
 - 2. All ACYOA Central Council Members
 - 3. Host Chapters of National Events (as designated)
- 2. These semi-annual copies of the entire listing assumes a revision (including corrections, additions and deletions) prior to the printing.
- 3. Also, on August 10th, an <u>alphabetized listing</u> will be sent to the Executive Secretary and ACYOA Central Council Chairman, every year.
- 4. Also, on August 10th, a <u>dues paid listing will be sent to the Executive</u> Secretary and ACYOA Central Council Chairman, every year.
- 5. In October of each year, a copy of individual parish listings will be sent to the parishes of the Diocese of the Armenian Church for the purpose of review and revision by the specific parish. The parish will be asked to update the listing and send it back, whereafter an uptodate parish listing may be forwarded to the parishes if they so desire. A November 1st deadline will be designated for the revised parish listing to be returned, in keeping with the current deadline for the National Youth Listing.
- 6. The ACYOA Central Council member assigned to the National Youth Listing project will work in cooperation with the Executive Secretary and with the agency or contact who will maintain the listing.
- 7. Printouts should be as follows:
 - 1. Address-label format for zip code order listings.
 - 2. Single-line format with ascending numbers for alphabetized and dues paid listings.
- 8. As general youth listings and dues paid listing are received by the ACYOA Central Council, they shall be handled by the Council Member assigned to the Youth Listing Project and forwarded to the agency or contact maintaining the listing.
- 9. Copies of the National Youth Listing will not be made without the prior consent of the Executive Secretary and ACYOA Central Council, to ensure that the listings are kept private and not part of a mailing-house, commercial use or any other purpose other than that of the Armenian Church. All requests for copies of listings must be made in writing to the ACYOA Central Council.
- 10. When possible, the listing will be set up according to "year of birth", and will be maintain as such, with a single-line format printout available for revision and addition purposes.

Dear Mark,

This letter is written to express my concern that the delegates to this year's General Assembly will be unable to exercise their responsibilities completely and in an informed manner due to the fact that the complete minutes of the 1981 General Assembly have not been made available to them.

As you know, this year's minutes were probably more accurate and concise than they have been in the past because of the new method of approval that was instituted at my suggestion during this 1981 Assembly. In addition, the minutes were made available to the national organization earlier than in previous years.

Please note that the Constitution of the ACYOA calls for a mailing of the complete minutes (this would include all appendicies) prior to the next General Assembly. To my knowledge, this has not been done. Failure to include all appendicies with the minutes of the 1981 General Assembly is a breach of the Constitution and speaks ill of the Assembly Secretaries whose responsibilities would not have been complete without the inclusion of those appendicies.

Therefore, I request an effort be made to make available and distribute, in accordance with the Constitution of the ACYOA, the entire Minutes of the 1981 General Assembly prior to this year's Assembly.

I note with interest that many new and revised Administrative Tools have been developed along with other Guidelines and Reprintings. See the Annual Report of the ACYOA Central Council pages 2 and 3. I would assume that all these tools will be available at this year's General Assembly for those delegates wishing to have a copy. Since Assembly Delegates are a major line of communication between the National Organization and the Local Chapters, their free access to this material I would consider vital. Tools and guidelines are of little use if they are not distributed. The delegates of this year's General Assembly are the future leaders of the Organization. They have, by accepting the responsibilities of Delegate established themselves as leaders within their local chapters and they are our best hope for the dissemination and implementation of these tools,rules and guidelines in the future.

As a A.C.Y.O. junior member I did not want to write this letter but as a good A.C.Y.O. junior member I had to write this letter because <u>I'm very unhappy</u> about what is happening to our A.C.Y.O. juniors. I hope you'll take this letter as a constructive criticism of what is happening to us.

Last year we were a very strong and active organization, we worked the group up from 20 members to 50 and it wasn't very <u>easy!!!!</u>

Here are some of the things that has happened to us: 1. On December 6, we were going to go ice skating at Fairlane Town Center in Dearborn. We were going to get 3 to 4 drivers but Hysorp told us " Don't worry about getting drivers I'll get them for you." but when it was time to go <u>12</u> of us kids had to pack in Paul Andonian's car just because Hysorp didn't take the time to get us drivers. Now how would you like <u>YOUR</u> kid to pack 12 kids in his car?!! What would have happened if we had gotten in a accident, or what if the police had pulled Paul over, where was our chaperons who are <u>supose</u> to be at all our meetings to stop this kind of stuff?

3. We wanted to have a christmas party afew weeks before Christmas, Hysorp said he would get the A.G.B.U. building for us, but he did not !!! Then on Dec 20 I heard that for Dec 27 were going to have a Christmas party, which our president didn't even know about!

4. Why are we used for the fish dinners and for the old age home? I don't mind the lent dinners or the old age home, but there should be other activities that are just as <u>important</u> to us young people.

5. The Hysorp is to busy and doesn't have the time for us, we would rather have someone like Father Donikian who will take the time to help us and who can relate to us!!!!!!!

It's been over thirty days since the last letter I sent to you about our problem and the parish council's problem. We have not had a meeting since December. I would like to know how come nothing's being done to help save the youth of this church. I am going to send a copy of my first letter dated Dec. 20, 1981 to His Eminence Archbishop Torkom Manoogian, and if we do not get a respond at our membership meeting with our parents , where we can sit down and talk this thing over like good christian people should, I will send a copy of both these letters and another letter to the next Armenian diocese assembly which will be held sometime this year.

Lent dinners are approaching in mid Feb. and are we <u>once</u> again going to be used by Hysorp when we have no other activities?

As elected parish council members, elected by our general membership (my mother and father have elected various members like yourself to represent the general membership to run the affairs of St. John's) <u>Why are the council members abandoning the youth the</u> <u>backbone of our church!!!!!?</u> We are up and coming Armenian youth, who would like to carry on what our parents have taught us, to be good christians. My parents have always told me to fight for what I think is right!!! I don't always agree with my parents but they listen to my side and we work out the difference.

I know 95% of us kids have discussed and talked among ourselves, and we think that Hysorp should step down and give the job to Derhayr who would be willing to help us, without a bunch of phony promises!!!

How come A.Y.F. is so strong? How come they have meetings? How come they have <u>so</u> many activities going for them? How come they have jackets to show they belong to A.Y.F.? At one of our meetings Kirk Norian brought a brochure that Mr. Lafian had given Kirk because he knew how much we wanted jackets, and Kirk showed Hysorp, and Hysorp didn't let us order any because <u>he</u> didn't want , them. He is not a youth, he does not know our thinking and he can't relate to us!!

Why doesn't the parish council do something to save us? As elected parish council members you owe it to our youth.

If nothing improves I will quit the juniors and anything that has to do with the church, and others are also talking this way if nothing will be done to help!!!!!!!

It was nice to see you again at the recent Regional Conference of New Jersey Parishes. As you mentioned, these are the "lean" months of our Camp Program, yet there is so much that must be done.

We should like to inform you of the role and areas of responsibility of appointed directors of ACYOA Programs. Like the Armenian Studies Programs or ACYOA Mission Program, the ACYOA Camp Program has appointed directors. All appointments are made by the Primate, with some consideration given to suggested candidates of the Executive Secretary, as well as the Central Council.

All directors are responsible to the Executive Secretary and Central Council, and ultimately to the Primate himself. All programs and related materials are the property of the ACYOA, and ultimately of the Diocese itself. The directors are requested to prepare proper reports following the conclusion of their programs, at which time evaluations are made, thereby allowing for development, evolution, or cancellation of our programs. All financial records and funds are turned over to the National Organization (ACYOA) unless operating funds are needed. Likewise, all samples of materials produced, outlines of programs and work, are also place in the Program's file for reference purposes, as well as record keeping purposes.

Perhaps we have been remiss in not "spelling out" the areas of responsibility, including what is expected, of our directors. We are in the process of developing guidelines for our directors to follow when appointed to a specific program of the ACYOA, and we hope that this will eliminate any "gray" areas so that a proper understanding is achieved.

We note that none of the above is open for debate, and in the future, we expect that all directors shall meet our expectations and fulfill their obligations to the best of their ability. Our primary concern is the program, however the organizational aspects must seriously be brought into the picture if we are to realize our goals.

Regarding the Camp brochure, we expect to review the master copy <u>before</u> it is sent for printing.

PROPOSED REGIONAL PROGRAMMING STRUCTURE

Diocese to appoint a person to carry out programs and act as a significant resource within a given region of the Diocese. At this point, let us use the New England region, with its 10 or 11 parishes as a model.

This person would be a paid employee of the Diocese and work within a given region, from a home-base parish, or home. This person would be immediately responsible to the department head under which they work, and ultimately responsible to the Primate and Executive Director of the Diocese.

If this person was primarily a youth worker - field worker the schematic might be the following:

The Field worker would be responsible to the Directors of the ACYOA Junior and Senior Divisions, and be responsible for the following:

- Become aquainted with the demographic make up of the region. The largest concentrations of youth; 3rd,4th,5th generation; percentage of assimilated youth; educational backgrounds; professional backgrounds; economic backgrounds; etc.
- Compile a complete listing of all Armenian youth within the given region - for instance New England with its ll parishes (including Watervliet, N.Y., but excluding Trumbull,CT), plus many scattered Armenian Families living outside of local parish jurisdictions.
- 3. Strengthen existing ACYOA Chapters both Juniors and Seniors. Build up inactive Chapters and create new ones. Chapters should exist in communities that have enough youth to support a chapter -20-25 names is sufficient.
- 4. Organize regional conferences of all Chapters to deal with regional activities and programs as well as promote national participation and growth within the structure of the national Youth Organization.
- 5. Develop programs and events to meet the needs of the youth within the region. This person should be aware of the needs - shortcomings, assets, etc., and utilize this knowledge to prepare timely and interesting programs on the local and regional level.
- 6. Present workshops for the youth, to better prepare them for active participation in the Church both while they are young, and when they are older.

For Example: Workshops in Chairing meetings. Taking minutes. Basic Bookkeeping procedures. Preparing brief but informative reports. Public relations. Photography. Organizing an activity Motivating groups. Goal orientation. Etc.

- 7. Promote adult participation in youth programs, and solicit their support for scholarships, awards, educational programs, etc.
- 8. Develop a regional athletic program for both men and women.
- 9. Understand the resources of the region, both in terms of social and educational interests, as well as athletic, entertainment, and significant sites.
- Understand and utilize the Armenian resources of the region in terms of facilities, people, current organizational structures and non-Church structures.

The development of this person and this position can be quite exciting. It is certainly more efficient than one, or two, persons trying to handle the affairs of the youth within the vast dimensions of the entire Diocese. The work of the Directors would be greatly impoved with the assistance of regional field workers to help follow up situations that might ordinarily need to be passed up due to other priorities.

This same schematic could be used at other levels - this person (or another person, perhaps) could organize workshops for parish councils, Church School, Armenian School, Church Office Secretaries, Deacons & Acolytes Training, etc., etc.

If the New England Region had such a resource person, working full or part-time, many, many more activities and programs could begin to move from the "idea" stage into the "reality" stage and start to fully develop. The New York City and New Jersey area is another region in desparate need for full time assistance.

Once the field worker has a basic understanding of the resources within the given region, programs and activities can more readily be implimented. Moreover, the design of the programs and their impact can be more deliberately planned once we know the needs of the region, and what will be most effective.

To initiate the field worker program, the following is suggested:

- 1. A study be undertaken to make up a list of potential field workers who have the proper educational and religious background for the position. This may be accomplished through contacts in parishes and other resources.
- 2. At a regional Assembly of parishes, the Primate (or the Diocesan Executive Director as the Primate's spokesman) may introduce the program, defining the various aspects and structure, and initiate first stages.
- 3. The parishes of the region should be solicited to support the program, and form an advisory committee to assist, support and promote the work of the field worker. This is necessary of the field worker is to have any cooperation from the parishes of the region.
- 4. Make appointments. Begin Field Worker orientation.

TUPICS TO BE DISCUSSED / ADDRESSED:

1. Archbishop Torkom Manoogian Basketball Tournament: Each year the ACYOA offers this tournament just prior to Great Lent, or immediately following Easter. One year it is in New York City, the next it takes place in a designated region.

This year it returns to New York and the Diocese. However, the costs of running the dournamene in the City is almost prohibitive. Last year it took place in Palos Heights, IL, where the Host ACYOA Chapter made \$4,000.00 - which is split with the ACYOA Central Council. Needless to say, the Council needs this type of funding at that time of the year when funds begin to run low.

It was suggested that a Chapter outside of the fity host the Tournament, that thus lower the costs for the participants. However, the point of having it in N.Y. is for the Diocese to be a focal point. Moreover, the award banquet and dance should take place at the Diocese, but the rental fees for Kavookjian Auditorium might prove too costly.

- 2. What is the chance of increasing the expense account of the Executive Secretary for the coming year? Walt is the chance of the proposed \$10,000.00 budget for ACYOA Senior Division bing met?
- 3. Regional Programming Plan.
- 4. Bookkeeping procedures. Harry Tavitian, a member of the ACYOA Auditing committee approached me at the ACYOA Assembly in Chicago and suggested with change the method of bookkeeping currently used by the ACYOA. He is a member of the Westchester Chapter and isid he could come to the Diocese to discuss it. He questioned how the Diocese does it, since many of the items are somewhat similar. 5. Cost of Living increase.

I would like to know some type of time schedule as to when salary increases will occur, and thereby be able to plan my family accordingly.

Dear Serena:

This letter is to advise you and the delegates of the Detroit Chapter of ACYOA that the Central Council is in receipt of your chapter's letter dated July 6,1981. Traditionally, the Detroit Belegates have always been active, dedicated participants of the General Assembly. We hope that the concern expressed in this correspondence by the Detroit Delegates continues to be supportive of the efforts of the Central Council in its administration of the ACYOA.

This correspondence is in response to the concern expressed in your letter. The Central Council has spent much time addressing its financial problems. The topic of Fund-raising activities has been discussed many times. A review of our January 1981 meeting minutes will show that this question was addressed in depth and the Constitutional right and responsibility given to the Central Council (Article 13 Section 7) was mentioned. The feasibility of a number of alternative solutions was to be considered prior to exercising this right.

The question raised concerning outstanding financial obligations is being addressed by the council as it applies to all chapters, not just the 1980 Sports Weekend. Again, based on the Constitutional Article which was cited, the Central Council has developed a procedure for implementing this article in order to insure full compliance and completion of the outstanding obligations and full participation of the General Assembly by all chapters.

At our July meeting, the Central Council reviewed the Constitutional amendment which the Detroit Delegation is proposing in order to secure a permanent record of the activities of the General Assembly. The question of the method of election of the General Assembly Secretary was discussed. It is the opinion of the Central Council, President presiding, that the office of the General Assembly Secretary should continue to be elected. As it is our organization, it is stated that we should be responsible enough to administer to its needs. Therefore, We are asking that the Detroit Delegates consider

TO ALL CENTRAL COUNCIL MEMBERS:

Enclosed is the new ACYOA pamphlet that marks the first pamphlet printed about the National Organization in over a decade. Although it is general, it describes the Organization and its purpose. We hope that both Armenian and non-Armenian will find it informative. The Diocese is paying for the printing, and is currently considering other pamphlets for the various departments of the Diocese, including the ACYOA. (This particular one had to be prepared quickly while the typesetting equipment was still available to us.) New pamphlets will go into more detail, use polished stock, include photos and graphics, and some color. It all depends on money - as usual.

Chapter monthly fact sheets have gone out for the new year. We have been receiving some from chapters who had received the forms during visitations and at regional conferences. Included in the mailing were copies of the new pamphlet. Pamphlets will be sent to all pastors for public display and availability. They will also be on hand at the Assembly.

All Council members should be in touch with their respective chapters and parishes encouraging participation in the Assembly and Sports Wkd. Also, fulfillment of obligations to the Central Council should be stressed.

Fr. Nersess Jebejian, who was appointed Dean of the Theological Seminary of the Armenian Patriarchate of Jerusalem last year, has requested some time during the Assembly to make a presentation on the Seminary and the Patriarchate. This will involve slides and remarks. The intent is to expose the importance of the Patriarchate and Seminary, as well as encourage those interested to pursue religious vocations. This is an important area that has been neglected by the ACYOA in recent years. The Primate has granted permission for this presentation - but His Eminence has instructed that all plans be made through the Central Council (in terms of time allowed, place on the agenda, etc.). 20 to 25 minutes should be the maximum time allowed. Perhaps Wednesday evening is appropriate if enough of the delegates are present. This might complement the presentation on the Audio-Visual Educational Series...work is continuing to have it ready for the Assembly.

If anyone has extra ACYOA Stationary, kindly send it to 180 Olde Westford Road, Chelmsford, MA 01824 - as you can see we have run out. More stationary will be printed in September so as to not incur the expense while the current Council's books are still open. By now all Council Members should have been assigned committees and begun preparing outlines for committee discussion. Kindly send your first draft to the Executive Secretary before printing/copying. Comments will be made and it will be sent back to you immediately.

Work continues on the certificates ("Recognition" and "Sam Nersesian"). Certificates are an expensive item - especially when the typesetting is done outside. We are currently working on having the certificates ready by the Assembly as inexpensively as possible. Remember, only one certificate is given out each year for the Sam Nersesian Award recepient (<u>if</u> a nominee is worthy and selected), and only a few given to out-going CC Members, and perhaps one outstanding supporter of the Organization. This raises the cost - printing a few, but making them attractive.

Following the Assembly, the traditional Central Council meeting that takes place for transition purposes should have an appropriate room, and not use the room of the Primate if it is possible. All CC Members should prepare to inform the newly elected members of their duties and of the many problems and frustrations that can occur - as well as the many good feelings of accomplishment at the completion of a program and in serving the Church in general. Elections will be held, and out-going CC Members will be allowed to leave. Out-going members should not be present during elections or during any new business that the new Council may decide to take up if it is necessary and time allows.

Early Friday evening, a private reception shall take place for all Clergy, CC Members (out-going, current and newly elected), and Chapter Chairmen. Letters of invitation shall be sent out soon to the respective persons. The idea of a reception is part of an effort to increase communications and good relations between the three groups - clergy, council and chairmen. The coming year will see a greater emphasis on this on the part of the Executive Secretary (who is initiating the reception idea) and the Central Council.

Also, out-going CC members should speak with the newly elected CC members and encourage them to be responsible, deliberate and in touch with their respective chapters. Making them feel comfortable and secure in their position is an important role the out-going members should take on.

The Handbook proceeds slowly with the additional work and preparation necessary for the Assembly. It <u>might</u> be ready for the Assembly. As of this date, we have not received the minutes, nor have we received information on those chapters who have responded to the letter regarding their outstanding obligations. We must enforce those rules that are important to the stability of the National Organization. Let's try not to be too permissive in the event of irresponsibility.

If anyone is having any problems, we would like to hear from you if not, we look forward to seeing at the Assembly in Chicago !!

Your Eminence:

I should like to submit the following information for consideration:

In the past year, as I have visited a number of parishes, I have noted that in most cases, an accurate and up to date youth listing does not exist. At best, most have a Church School, Armenian School, or ACYOA listing, usually inaccurate and out-dated. It would be safe to guess that most of our parishes do not know how many Armenian youths they have within the limits of their jurisdiction.

In Chelmsford, with the assistance of the Pastor's Secretary, I have developed an efficient means fo establishing a workable master youth listing. With Your Eminence's permission, I should like to introduce this method (which is really simplistic) to parishes for their use and for our reference and use as well. Enclosed is an example of a standard means of maintaining an accurate and efficient master youth list.

However, in developing the methodology, and compiling the list, we discovered two interesting statistics. One, that we have at least 50 percent more youths within the parish than we knew of, and two, that there has been a startling decline in the birthrate over the past seventeen years.

I am not aware of any program in the Diocese that deals with vital statistics (births, deaths, baptisms, marriages, etc.). I feel that this area should be addressed and given consideration as we plan educational and youth oriented programs. The enclosed sheet provides some of the statistics regarding the drop in the birth rate.

I should like to introduce the standard master youth listing system as soon as possible. As I do not anticipate a dramatic response or immediate institution of the system, the sooner the research is begun the sooner we may up date our out-dated mailing lists.

One of the young men there; Harry Der Assadourian, son of Der Hayr Vartan Der Assadourian, of New Britain, Connecticut, is giving a trophy to the ACYOA in memory of your son Samuel W. Nersesian. The trophy will be given Annually to the ACYOA member who most closely displays the Christian qualities that Sam had.

In addition, the Chairman's Roundtable has recommended to our General Assembly that Annually two scholarships be provided in the memory of Sam for the Saint Nersess Deacon's Training Program. This will be discussed at the General Assembly Labor Day Weekend in Wisconsin, and I am positive it will carry through.

Mrs. Nersesian, I had the priviledge of meeting your son on the two occasions I visited with the Holy Shoghagat Armenian Church. As I write you I picture him as he was during the Consecration of your Church last November. I truly liked Sam and promise I will never lose the image I had last November when I saw him, and now as I write of him.

At present, I receive my salary checks from the Diocese, but expenses/reimbursements come from the Central Council. This has been a problem due to financial considerations on the part of the Council. Many times, I have been forced to to carry-over several hundred dollars while the Council tries to find money to cover their obligations. My financial situation does not allow me such a practice, and many times I have been left very tight. Like the other Diocesan Staff members, I feel that reimbursement of my expenses should come from my employer. Ι would like you opinion on this matter. At the moment, I am waiting for a check from the Council for expenses incurred during the month of January. This is not the proper way of transacting such financial situations. For me to schedule parish visitations, as well as make materials purchases, etc., I must be able to administer and budget the expense allotment and be reimbursed within a reasonable amount of time.

TO ALL CENTRAL COUNCIL MEMBERS:

Enclosed is the new ACYOA pamphlet that marks the first pamphlet printed about the National Organization in over a decade. Although it is general, it describes the Organization and its purpose. We hope that both Armenian and non-Armenian will find it informative. The Diocese is paying for the printing, and is currently considering other pamphlets for the various departments of the Diocese, including the ACYOA. (This particular one had to be prepared quickly while the typesetting equipment was still available to us.) New pamphlets will go into more detail, use polished stock, include photos and graphics, and some color. It all depends on money - as usual.

Chapter monthly fact sheets have gone out for the new year. We have been receiving some from chapters who had received the forms during visitations and at regional conferences. Included in the mailing were copies of the new pamphlet. Pamphlets will be sent to all pastors for public display and availability. They will also be on hand at the Assembly.

All Council members should be in touch with their respective chapters and parishes encouraging participation in the Assembly and Sports Wkd. Also, fulfillment of obligations to the Central Council should be stressed.

Fr. Nersess Jebejian, who was appointed Dean of the Theological Seminary of the Armenian Patriarchate of Jerusalem last year, has requested some time during the Assembly to make a presentation on the Seminary and the Patriarchate. This will involve slides and remarks. The intent is to expose the importance of the Patriarchate and Seminary, as well as encourage those interested to pursue religious vocations. This is an important area that has been neglected by the ACYOA in recent years. The Primate has granted permission for this presentation - but His Eminence has instructed that all plans be made through the Central Council (in terms of time allowed, place on the agenda, etc.). 20 to 25 minutes should be the maximum time allowed. Perhaps Wednesday evening is appropriate if enough of the delegates are present. This might complement the presentation on the Audio-Visual Educational Series...work is continuing to have it ready for the Assembly.

If anyone has extra ACYOA Stationary, kindly send it to 180 Olde Westford Road, Chelmsford, MA 01824 - as you can see we have run out. More stationary will be printed in September so as to not incur the expense while the current Council's books are still open. By now all Council Members should have been assigned committees and begun preparing outlines for committee discussion. Kindly send your first draft to the Executive Secretary before printing/copying. Comments will be made and it will be sent back to you immediately.

Work continues on the certificates ("Recognition" and "Sam Nersesian"). Certificates are an expensive item - especially when the typesetting is done outside. We are currently working on having the certificates ready by the Assembly as inexpensively as possible. Remember, only one certificate is given out each year for the Sam Nersesian Award recepient (<u>if</u> a nominee is worthy and selected), and only a few given to out-going CC Members, and perhaps one outstanding supporter of the Organization. This raises the cost - printing a few, but making them attractive.

Following the Assembly, the traditional Central Council meeting that takes place for transition purposes should have an appropriate room, and not use the room of the Primate if it is possible. All CC Members should prepare to inform the newly elected members of their duties and of the many problems and frustrations that can occur - as well as the many good feelings of accomplishment at the completion of a program and in serving the Church in general. Elections will be held, and out-going CC Members will be allowed to leave. Out-going members should not be present during elections or during any new business that the new Council may decide to take up if it is necessary and time allows.

Early Friday evening, a private reception shall take place for all Clergy, CC Members (out-going, current and newly elected), and Chapter Chairmen. Letters of invitation shall be sent out soon to the respective persons. The idea of a reception is part of an effort to increase communications and good relations between the three groups - clergy, council and chairmen. The coming year will see a greater emphasis on this on the part of the Executive Secretary (who is initiating the reception idea) and the Central Council.

Also, out-going CC members should speak with the newly elected CC members and encourage them to be responsible, deliberate and in touch with their respective chapters. Making them feel comfortable and secure in their position is an important role the out-going members should take on.

The Handbook proceeds slowly with the additional work and preparation necessary for the Assembly. It <u>might</u> be ready for the Assembly. As of this date, we have not received the minutes, nor have we received information on those chapters who have responded to the letter regarding their outstanding obligations. We must enforce those rules that are important to the stability of the National Organization. Let's try not to be too permissive in the event of irresponsibility.

If anyone is having any problems, we would like to hear from you if not, we look forward to seeing at the Assembly in Chicago !!

Dear Syraun,

During the last Central Council Meeting held in New York, you had assured me, and the rest of the Central Council, that I would be receiving a copy of all of the bills which were paid by the Diocese(from January 1, 1980-December 31, 1980) on behalf of the ACYOA Seniors. To date, I have not yet received these bills.

In order to properly account for the balance of our Diocesan Subsidy to the General Assembly, these bills are of utmost importance. Without them, the Gentral Council cannot adequately reply to the many questions which will most likely, be directed toward this point. A proper financial report must also contain an explanation of unusual income, expenditures, and otherwise inusual occurrences. The reduction of the ACYOA subsidy by the amount of bills paid by the Diocese on behalf of the ACYOA would qualify in this category.

I must also conclude that the Diocese has not spend any monies on behalf of the ACYOA during the time elapsed in 1981, until such bills are received. In actuality, the <u>Diocese should not even be paying these bills; they should</u> <u>be forwarded to the Central Council Treasurer who will then make the payment</u>. I would greatly appreciate if this procedure is followed. It would enable the Central Council to more accurately determine its actual expenditures, and projected budgetary limitations. Otherwise, the ACYOA budget becomes a useless burden.

The financial reports for the months of January and February, 1981 have been delayed because of the fact that the Monthly Statements from the bank and broker have not yet been received; without such statements an accurate accounting of our funds sannot be made. It is far better to provide the Discess with accurate information. I have taken action regarding the proper forwarding of these aformentioned statements; I was told that Mr. Magarian would be forwarding them to me. However, if he must come to New York to do so, I was wondering whether it was possible for the Diocesan Offices to forward these financial statements to me. In this way I would not have to depend upon the Executive Secretary to

make a special trip to New York to obtain the necessary materials. Please advise.
