I can understand your concern over the recent cancellation of the Armenian Church Program. In response to our phone conversation earlier today, I had enclosed backup material relative to the cancellation fees incurred.

You will notice by the enclosed that Mr. Najarian's signature is directly below our standard cancellation clause. It is this cancellation clause that protects us from substantial lost revenues due to late cancellations. Also enclosed is a copy of the phone memo that advised me of the cancellation. As you can see, I did not initially directly speak with Mr. Najarian regarding the cancellation.

During our conversation, you were correct in mentioning that I had affected the cancellation. That was done in an attempt to resell the rooms we had been holding. We were incapable of doing so, hence the cancellation fee was applied.

I did call Mr. Najarian to advise him of the cancellation fee of $(\$4,320 \times 80\% =) \$3,456$ based on the schedule. He mentioned he would speak to you and advise me of the conversation. He did not do so.

Let me assure you that I am following policy and procedure in this matter. It is unfortunate that you have personally been caught up in these circumstances. Please call should you have further questions.



At the present our social and political life is becoming stabilized, the Committee of Youth Organizations of Armenia is undergoing a renaissance, and vast possibilities are being created for the strengthening of ties between the Armenian youth of your country and Mother Armenia. In our opinion, the reestablishment of ties between the Committee and your organization can play an invaluable role in this matter. These reciprocal relations can be of many types and many ways, since the Committee, which is formed of many different youth organizations, is now independent.

We present to your attention several types of possible ties between our organizations: exchange of delegations of representatives (these groups can have specific orientations, such as being composed of young painters, doctors, architects, athletes, students, and so forth, or can be composed of representatives of various fields), the hosting of newly formed young families, the organization of many types of cultural ties through exhibitions, displays of merchandise, theatrical pieces by visiting performers, concerts, sports events, and other events, and economic ties. Exchanges are to be carried out on the following basis: aside from travel expenses, all remaining expenses will be borne by the receiving organization. The Center has the possibility to develop economic activity in the most diverse ways, even to immediately establish joint ventures.

We hope that our various proposals are of interest to you. In turn, the Center is ready to consider all your feasible suggestions. As a first step, we are already prepared at the beginning of 1991 to accept a delegation of three or four representatives from your group or to send a similar group in order to examine the details of our cooperation.
