Attached is the proposed schedule for the forthcoming visit of Archbishop Keshishian May 5–19. Thank you for your interest in serving as his host.

Please check the schedule and contact my office for any needed appointments.

Regarding his travel expenses (from Geneva and return), both the Ecumenical Development Initiative will cover. My assumption is that you will handle the hospitality arrangements and costs for the Archbishop and a person from our staff accompanying him during his stay with you. If, in addition, you can contribute toward his travel costs, through honoraria for speaking, discretionary funds or direct contribution, that will of course be helpful to both the WCC and the NCCC, EDI's sponsors, and will be much appreciated. However, his visit with you is not dependent on a financial contribution from you.

Further, at each stop there are possible "windows" of uncommitted time when the Archbishop might have contact with potential donors to the councils through the Ecumenical Development Initiative. When you have had time to fill out his time with you in detail, let me know and I will perhaps negotiate with you concerning his uncommitted time. Additionally, of course, I want to prepare for him a detailed schedule.

Thanks again for your cooperation in making the best use of his presence here. We are in the Archbishop's debt for undertaking such a visit.

## **ARAM KESHISHIAN**

Born: 1947 Residence: Lebanon Citizenship: Lebanese

Church: Armenian Apostolic Church (Oriental Orthodox), Catholicossate of Cilicia

Aram Keshishian, elected Moderator of the World Council of Churches Central Committee at the Seventh Assembly (Canberra 1991), is Archbishop of Lebanon, Armenian Apostolic Church.

He has studied theology – specializing in philosophy, contemporary systematic theology and Middle Eastern church history – at his church's theological seminary in Antelias, Lebanon, the Near East School of Theology (Beirut), American University of Beirut and Fordham University (New York), from which he earned a Ph.D. degree. He also attended the WCC's graduate school of ecumenical studies at Bossey, Switzerland, and has done theological research at Oxford University.

He was ordained as a priest in 1968. In 1978 he was named *locum tenens* of the diocese of Lebanon; in 1979 he was unanimously elected primate; and in 1980 he was ordained bishop.

Archbishop Keshishian was elected to the World Council of Churches Faith and Order Commission in 1975, and to the WCC Central Committee at the Vancouver Assembly in 1983. He played an active role in the founding and restructuring of the Middle East Council of Churches. He is a member of the Oriental-Eastern Orthodox and Oriental Orthodox-Roman Catholic Bilateral Dialogues. He is an honorary member of Pro-Oriente, a Roman Catholic Ecumenical Foundation in Vienna. He is also a member of the International Religious Council of the Armenian Orthodox Church, and since 1972 he has served as general secretary for ecumenical relations of the Cilician Catholicossate.

In addition to numerous articles in journals and periodicals, he has published the following books: The Witness of the Armenian Church; With the Determination of Renewal; Christian Witness at the Crossroads in the Middle East; The Will to Be with People; With the Will of Re-building; With the People; and The True Image of the Armenian Church.
