We appreciate your concern about the problems of our community in Houston, Texas, as you had mentioned in your letter to Father Levon Arakelian.

However, considering the fect that we have prepared the schedule of our official visits to the parishes of our Diocese, and that all weekends are taken until 1967 April, please be advised of the following arrangement:

The weekend of November 27 is assigned to Houston, Texas. Therefore, we intend to arrive in Houston on Saturday, November 26, 1966. In due time you will be informed of the details.

We expect first to meet with the Parish Council members sometime between 5-7 p.m. Then the public should be invited to meet with the Primate on Saturday evening at 8 o'clock. Light refreshments may be served. We are confident that this gathering will serve as an eppertunity to disseminate information about church history and discipline; we may also have an informal conversation concerning the life and activities of the community.

For Sunday, November 27, arrangements should be made by the Mariah Council for church services at any convenient place or church building. The announcement should remind the public to inform the Periah Council, if any person wishes to have a Requiem Service, or to receive Mely Communion, or to have his children baptised.

Der Levon Arakelian will accompany us, and from Houston we shall fly to Mismi, Florida, to attend the National Council of Churches Triennial Assembly.

Dear Archbishop Torkom:

Since the arrival of Deacon Dickran, matters are looking up somehow.

The Parish Council, with four members missing, met last week and the Deacon was invited. I also invited Mr. Hovhannes Ohanian and Mr. Hovsepian.

We went over the history of the parish and brought the deacon up to date. He seems to grasp matters easily and I gained the impression that he is not unfamiliar with the difficulties such as we are experiencing here.

Last Sunday the ladies had a coffee; the object being to acquaint the deacon with the community.

Here is the plan. Whether we can put it in operation remains to be seen. We would like and will help the deacon get a job and get situated so that he can work some and carry through with his studies. We are hoping that he can spare a little time each day to devote to furthering the interest of the church and center. This is the end we are working towards.

As I told you previously, I am not going to be able to devote as much time to church affairs due to my back trouble. I am therefore, going to suggest the following changes which I think are necessary to further the interest of the church.

I suggest that the composition of the Parish Council be as follows:

Dear Archbishop Torkom:

Though it has been sometime since I last wrote, I have thought of you often. A great deal has happened since I saw you here.

First, enclosed is a clipping from the newspaper in regard to St. George and its Pastor Rev. Metjian. I am very happy to note that Rev. Metjian has been assigned here and I plan to attend Divine Liturgy ofteh.

Mother's Brother passed away in March. Though expected since he had been ill for quite a while, it was still a shock. Monday before Mother's day Mother went out to play cards. As I picked her up she blacked int on me. We thought it was a stroke, but it was a lack of blood circulation that caused the blackout. Her eldest Sister visited with her on Friday. The next evening she suffered a M ssive stroke and died. It was quite a shock and for a few days we were concerned about Mother. She is okay now, but her illness has shown some effects on her heath.

(elebrated my birthday April 20th with a Folk Mass in my home. Mother's 84th birthday was on the 14th and we had another Folk Mass in the Home and then out for dinner.

No, I never did receive the books that I asked you for earlier.

I have been greatly saddened the past ten days. Two months ago a young man from Yugoslavia came in for an Open Valve Hea at operation. Though we couldn't speak each other's language, somehow within the help of Our Lord we came together. Love knew no boundries and we became very close. He was doing quite well, but took a turn for the worst two weeks ago today, and died on the 11th. He called for me, and I was able to see him before the condition became serious. His death has been felt very deeply.

I'm not against anything that will help persons to live longer, but I do feel that there are many unanswered questions that must be resolve before there can be a 90 to 15 percent certainity that the operation sill be successful.

I'm on my vacation. Had planned a trip, but didn't feel my heart would be in it because of the above circumstances.

Its hand I know to say just when you will return to Houston, but I do hope that when you do, we together with Rev. Metjian.

We wish to inform you that we have planned to visit our parish in Houston from November 27 to November 30, 1970. We hope this date is convenient for the parish also, since it is the only available weekend for this year. You will be notified about the exact time of our arrival in Houston.

Please make the following arrangements and preparations:

- 1. On Friday, November 27, at 8:30 p.m., we shall have a meeting with the Parish Council to consider the programs and activities of the Parish Council and to discuss any arrangements pertaining to the same weekend and a long range program.
- 2. On Saturday, before noon or in the afternoon, we may pay visits to a few of our members if there are any in the hospital or are ill at home.
- 3. If possible, arrangements should be made with local papers or reporters for interviews and publicity.
- 4. Saturday evening at 8 p.m. the choir members should be invited for rehearsal at the Church Center; also the ladies organization and any other committee, or the community, should be invited to a meeting at 9 p.m.
- 5. On Sunday, November 29, the celebration of the Divine Liturgy will start at 10:30 a.m. In the announcement you should mention the following:
  - a. Those who wish to receive Holy Communion should come prepared. Group Confession will be said during the service. Those who paysically are unable to preserve a total fasting may consume a soft drink and a piece of bread on Sunday morning before 8 a.m.

- c. After the Divine Liturgy at 12:30 p.m. a community dinner or banquet will be given at the Armenian Church Center. The congregation will have the opportunity to meet with the Primate.
- d. The Primate will return to New York on Monday, November 30.
- e. If there are children or adults who have not been baptized, the Parish Council members should be contacted. Baptism may be performed either on Saturday afternoon or on Sunday aftern the Church Services and before the community dinner.

Dear Mrs. Sanjakian:

We have received a very disturbing letter from the Parish Council of St. George Armenian Church of Houston, disturbing because of the unfortunate situation created by your refusal to abide by the accepted discipline of our Church administration and our own directives as well. It is particularly unfortunate because it should not have happened at all.

It is our practice that 60% of the funds of our ladies and other church organizations must be turned over to the Parish Council of that Church. Whatever exceptions there are to this rule will be specified by us.

If you have any objection to anything the Council does, you can communicate with us. But in the meantime, you must submit to its directives.

We direct, therefore, that you comply with this ruling, and turn over, immediately, 60% of the funds in the treasury to the Council, and in addition acknowledge the authority of the Council. It is essential to recognize the discipline of our Church. If you cannot do this, it would be appropriate to resign from your position.

Dear Mr. Saxenian:

Father Krikor Hairabedian's plans have been developed to a considerable extent, and we are happy to communicate them to you. Whatever questions remain, he can resolve through direct contact with you.

He will be visiting you with from five to seven young people aged sixteen to eighteen years. They will be traveling by car, and are set to arrive in Houston on Friday evening, March 31, remaining until Friday, April 7.

It is expected that the group will offer an Easter Eve service at 8 p.m. on Saturday, after which perhaps a refreshment hour can be arranged. Easter Badarak will be on Sunday morning at 10:30, with a public dinner afterwards.

The group, in the course of the week, expects to visit families, hospitals if necessary, present bible studies programs, panel discussions, a special evening for youth, and comparable activities, either at the Center or in private homes. Meals can possibly be offered in homes, or even prepared by the group itself if a kitchen is made available to them. They will, of course, need the Center space for sleeping and for programs. Father Krikor mentioned sleeping bags, but this should be confirmed by him.

Your Grace,

On behalf of the Building Committee and various members of the Armenian Community of Houston, Texas, I am writing this letter to inform you of the situation that exists in our inactive and troubled Parish at this time. There is a group that is blocking and discouraging the organization and functioning of a legitimate Armenian Apostolic Church.

As you know, on June 4, 1964, Father Levon Arakelian came to Houston and organized a new Parish, inviting interested Armenians who were eager to establish a Church of our own fath. In 1965, a two acre lot with a house already on it, in one of the finer sections of town was found. Father Arakelian, accompanied by Mrs. Rose Sanjakian, went to see Mr. Sam Harrison, an Oil man of Armenian descent, who, after much persuasion, agreed to contribute the money for the down payment, and further promised that he would clear up the mortgage within five years. Father Arakelian promised Mr. Harrison that the Church would be named after his father, George Harrison.

In 1966, the St. George Armenian Church was Consecrated and Father Arakelian visited us at least twice a year to give guidance to the Parish, and administer the necessary Sacraments. We were on the road to achievements and Mr. Harrison was well pleased with the shown interest and enthusiasm.

The real trouble began after the Easter of 1968. The new Parish Council, appointed by the Archbishop, began to undermine the progress of the Church, because they were unhappy that the deed of the church was in the name of Etchmiadzin. At the time of purchase, Father Levon had cleverly and with foresight, made certain that the deed was recorded in the name of the Diocese of the Armenian Church.

These appointed people blocked and stalled every attempt to keep the church in operation. At the end of 1970, Mr. Hrant Bardoony and Dr. Ardzroomi Packchanian visited Sam Harrison and tried to persuade him to establish a Trust Fund for the church. He promised that he would donate \$39,000: \$20,000 for a Trust Fund and \$19,000 to finish off the mortgage. Afterwards, Mr. Harrison abruptly changed his mind, and it was evident that pressure had been applied by the group initially opposed to the formation of the church.

On Feb. 8, 1971, a letter was sent to the Parish Council by Mr. Alex Manoogian of Detroit, and the A.G.B.U., in which he promised to give a generous contribution toward the building of a Chapel on the church property, provided that the mortgage remaining on the property was paid off.

This letter was read by the Archbishop, in the presence of a large Assembly of people gathered at a dinner. It was at this dinner that the Archbishop asked the Parish Council to form a Committee for the purpose of paying off the mortgage. Nothing has been done to follow up this request at the present day by the so called "one man" Trustees.

Money was collected at one meeting to pay for bringing in water from the city, but no one seems to know what happened to the collected money, and so far our church survives on borrowed water from the next door church.

Notices have been received by the Armenian residents of Houston, asking for pledges to the St. George Armenian Church and Center, but no one has cared to sign or type his name under these notices to make it official.

The church has never been organized as a regular Parish with proper committees and functions.

By-Laws do not mean anything and the very few who are appointed to become Trustees do not know and do not adhere to any law or church regulations, except their personal egos.

No one recognizes the existence of an Armenian Church, signs are covered up by the chairman, as if he is ashanbed of our existence and these signs are uncovered when a clergyman is about to visit.

Trustees are not concerned to invite clergymen and hold functions for the community, for obvious reasons.

We have failed in our original purpose of establishing an Armenian Apostolic Church and disappointed the believers and contributors.

No dues are collected, no efforts made to create a community life.

No worship or meetings held (except when a priest forces himself on them).

No attention and care afforded to the maintenance and improvements on our property.

The Building Committee who originated everything has not even once been called to a meeting or consulted for the benefit of our project.

The Ladies Auxiliary, who was the right arm of Father Levon, is abandoned and had not met the last 18 months, but lately put together with 3 ladies on the Executive Body including a Roman Catholic who does not even believe in our church, and is the treasurer.

The Church Hall is the private gathering place for some students and young men who use it gratis and in any way they please; even when Serpazan was here for Badarak, they insisted to hold a dance till late into the night and the next day not one showed up for the Badarak.

Church utensils purchased for church functions are only used for private parties by a few, who have the control of the church and do not pay for them or for the use of the church.

If there is a function, church uses paper plates. If it wasn't for the rental to the Nursery School, no mortgage payment would have been made and the entire thing would have collapsed.

These facts are matters of life or death to us. With best intentions, we helped Father Levon to make our dream come true; now this dream has become a sad memory, a nightmare, and brought to its finale by a few people who never believed in the project from the first day, from its inception.

We implore the Diocesan Board to seriously consider these problems, and help us bring these matters to a just and fair conclusion, providing us with the means to continue toward the realization of our original dreams.

We would be very grateful, if Father Levon Arakelian would come to Houston and stay for a short time with us, in order to help us re-establish and revive our Church, since he is the only one who knows these people well, and understands our situation from the beginning, and is a very close and dear friend of Mr. Sam Harrison. We are willing to undergo all the expenses involved, with no cost to the church, whatever.

Because of the negligence on behalf of the Diocese, to pursue matters and give the needed guidance to those who have been appointed to be the leaders in the Parish, it is regrettable to inform you that we are on brink of disaster.

Your Grace:

At a Parish Council meeting held Monday, July 25, all six of the eight Parish Council members of St. George Armenian Church, Houston, Texas, present, voted to purchase a home in the name of the Diocese of the Armenian Church of New York for use as a home for a parish priest.

The six Parish Council members present were James Boyajian, Yohanness Hekimian, G. A. Melik Keramian, Antranig Mavoulian, Stephen Saxenian, and Sooren Yeriazarian. This action was taken as a result of a Parish Assembly meeting on June 16, at which time the issue of purchase of a home was left to the discretion of the Parish Council.

Because our new parish priest, Reverend Terenig Kondralian, will be arriving in Houston with family and household goods around September 10, the Parish Council has contracted (\$1,000 deposit) to purchase a home at 15119 Wellman Lane, Houston, Texas 77060. The latest closing date for the purchase is August 25.

The sale price for the home is \$32,213. The present owners, Henry A. and Brenda Swatman, Jr. have a Veterans Administration 6 percent mortgage with the Mortgage and Trust Incorporated, P.O. Box 2885, Houston, Texas 77001. The mortgage expires April, 1997, and was for \$14,600. As of August 2nd, 1977, the mortgage has been reduced to \$12,135. The monthly payments for interest and principal are approximately \$87.00, and insurance, taxes, etc. raises the monthly payments to \$139.00. Because the interest rate on the mortgage and the small monthly payments are so favorable, the Parish Council has decided to assume this mortgage and pay the balance of the sale price in cash, \$20,178. The home is being purchased through Century 21 Apollo Real Estate, Houston, Texas.

Our financial status at present is: We have a savings and checking account in Western National Bank, Houston, Texas. We have \$2,750 in our checking account and \$10,033 in savings. In addition, we had a donation of 500 shares of First City Bancorporation of Texas, Inc., which we have sold for cash value of \$15,139. Also attached is a copy of our 1978 budget, which was approved by the Parish Assembly meeting June 16. As you know, we own free and clear a two-acre site of property with two buildings, 1111 Bering Dr., Houston, Texas.

In purchasing the home, two of three members from this parish will act as trustees. They are Yohannes Hekimian, James Boyajian, and G. A. Melik Keramian. The trustees guarantee that in the event the St. George Armenian Church cannot meet the monthly payments of the purchased home, they in turn will be responsible to do so.

The Capital Title Insurance Company of Houston will handle the closing of the home and will use the Texas Standard Title Property Owners form. Title for the home will be sent to the Diocese upon purchase.

What we must have for the closing is a letter from the Diocese authorizing that Yohannes Hekimian, 5930 Schumacher Avenue, Houston; James Boyajian, 1011 Suwanee, Houston; and G. A. Melik Keramian, 15122 Wellman Lane, Houston; will act as trustees for the Diocese of the Armenian Church, New York, in the purchase of the property located at 15119 Wellman Lane, Houston, Texas 77060, and that in the event the Parish members of the St. George Armenian Church, 1111 Bering Dr., Houston, Texas, are not able to meet the mortgage, taxes, and insurance payments, that the trustees will then assume those responsibilities.

Legal description of the home is northerly 16 feet of lot 13, southerly 46 feet of lot 15, Block One, Greenridge North Subdivision, Section I.
