

Dear Serpazan Hayr,

As you must be aware by now, the chairman of our Parish Council Mr. Sam Chapootian, at the Parish Council meeting of December 12, 1978, in the presence of the two Diocesan Council representatives Very Rev. Fr. Housig Baghdasian and Mr. George Mekenian, declared that the Parish Council will not continue to pay either the clergy insurance or the clergy retirement sum of \$750 annually, as decided in the Diocesan Assembly of 1977 in Providence, R.I., that parishes would pay. Last year, in 1977, the Parish Council had complied with the diocesan decision in both matters and had fulfilled its obligation.

This year's attitude of the Parish Council, due to lack of revenue from some of the church's affairs, has caused me undue anxiety, since I feel that I shall be needing these benefits more than ever, especially after the serious heart surgery I underwent this year, and a retirement pension will become so useful to me, or to Yeretzgin after my passing. The sad part is here that, after thirty years of service in this Diocese, these benefits can be so arbitrarily withheld without first obtaining the approval of the proper diocesan authority. What if, in the near future, the Parish Council should decide to discontinue the stipend of the pastor?

As one of the diocesan priests, I am appealing to you to find a solution to this matter, since the last payment on my insurance was made a few months ago by the Diocese and my benefits are again in imminent danger of cancellation. Furthermore, the amount of \$750 should be remitted before the year 1978 ends, for the clergy retirement fund.

We have received a letter from Mr. Sam Chapootian which we do not feel is in proper form since it did not indicate the meeting date dnd did not indicate that the content resulted from a meeting of the parish council.

The Diocesan Council feels it imperative that according to the decisions of the Diocesan Assembly, the clergy insurance and IRA be paid forthwith to protect the interest of the pastor. This matter was discussed at length at the Diocesan Council meeting on February 23, 1979.

Be advised that we have received the reports of the election, which election is not confirmed pending compliance and payment by your church of the clergy insurance and IRA.

We direct you to call a special meeting forthwith with the current parish council members to vote on the issue of payment by your church of: (a) the clergy insurance, and (b) I.R.A. You are to have a recorded hand vote on this issue, recording the names of the affirmative and negative votes and the results thereof.

We also direct you to invite your Diocesan Delegates to this special meeting.

The results of the vote indicating by name the affirmative and negative votes of the two issues of payments are to be forwarded to us forthwith indicating any members who are absent.

Upon receipt of this information, we will then submit this matter to the Diocesan Council for appropriate action as the case may be.


Any member of the Parish Council not cooperating with the intent of this letter or in any way interfering with the meeting referred to which may be obstructive to the intent of this letter should be reported to us in your letter.

Your Parish Council members should be on notice that any payments required for the payment of clergy insurance or IRA was the decision of the Diocesan Assembly and not to be negated or interfered in any manner whatsoever. Any action by any member of your council with the intent to defeat the decision of the Diocesan Assembly will not be tolerated.

Dear Mrs. Haroutunian:

Thank you for your letter of September 29, 1992 addressed to His Eminence Archbishop Khajag Barsamian. I appreciate your concern about the situation at Holy Cross Church. I would like to draw your attention to the following points.

- 1. Father Vahan Hovhanessian was not a member of the Diocesan clergy.
- 2. As a student in New York by special permission of the Primate and with consultation of Holy Cross parish council he was appointed as a visiting pastor to that parish.
- 3. As he was appointed by the Primate with the same procedure he was removed from his responsibilities at Holy Cross. The parish council obviously was consulted about it. At the request of the parish council once in a month Father Vahan will celebrate Divine Liturgy at Holy Cross as well as continue his Bible Study there.

I fully accept your concern about your church, but consider the fact that St. Vartan Cathedral did not have a permanent priest for the past year. We hope that Father Vahan as a young energetic and educated clergy can be of more help to the Armenian Church by using his energy at the heart of our Diocese at st. Vartan Cathedral. This will also help him and enlarge his knowledge and experience on the national and ecumenical spheres.

It has come to the attention of N.Y. Holy Cross Armenian Church parishioners that a letter was not directed to the Parish Council relating to the change of duties for our parish priest Fr. Vahan Hovhanessian to work at the Diocese instead of remaining at Holy Cross.

Does not our parish belong and pay dues to the Eastern Diocese, and should not the Parish Council be formally informed of a change and be made aware of changes that are being planned, before they are undertaken.

Many parishioners feel disturbed by the above events and are distressed the Fr. Vahan is leaving our parish to be replaced by a priest that does not speak English.
