





Our sincere congratulations to you for the excellent and highly objective editorial, "Stain Armenians Deserve Commemoration," in the Milwaukee Journal of August 3.

The points made in the editorial are logical and valid. Rep. Jim Moody (D-Wis.) is indeed wrong in objecting to the establishment by the Congress of a "National Day of Remembrance for the Victims of the Armenian Genocide." Of particular import was the statement about the present Turkish government's "touchiness" on the issue. The Armenians have never accused the present Turkish government for the crimes of the Genocide which was perpetrated by the Ottomans in 1915-1923. What we do not understand, nor can any principled person understand, is why the Turkish government remains so intransigent in the face of historical reality. Not only has the Turk consistently refused to acknowledge that the Genocide of the Armenians took place; they are spending vast sums to re-write the Armenians out of Turkish history altogether.

The Congressional resolution should be enacted, not only to recognize the first mass murder of an entire people in the 20th century, but also to remind the world that such a thing must never happen again. Such recognition would also give encouragement to Turks to rethink their position and join the community of civilized nations in acknowledging the guilt of their Ottoman predecessors.

Slain Armenians deserve commemoration

Many Wisconsin residents of Armenian extraction are angry at Rep. Jim Moody (D-Wis.) because he opposes a congressional resolution proclaiming a "National Day of Remembrance for the Victims of the Armenian Genocide." Moody's objections are principled, but his opposition to the proposal is nevertheless mistaken. The resolution ought to be approved.

Involved is one of the bloodiest chapters in history: the massacre, in the early part of this century, of Armenians in Turkey. The proposed resolution, which was defeated a year ago on a procedural vote, called on Americans to remember the 1.5 million or more "victims of the genocide perpetrated by the governments of the Ottoman Empire from 1915 to 1923 prior to the establishment of the Republic of Turkey."

Moody acknowledges and laments that thousands of Armenians perished. Indeed, he has said, "Almost no one has suffered more than the Armenians." His chief argument against the resolution is that "there remains considerable controversy among historians" about the exact circumstances of those deaths. He also asserts that Turks would regard passage of the resolution as a "gratuitous insult."

It is difficult to understand the scholars' uncertainty. Reports of the massacre of Armenians at the hands of the Turks are contained in a mountain of newspaper clippings as well as in other sources.

Henry Morgenthau, the US ambassador to Turkey from 1913 until 1916, wrote that the killings "were the working out of a well-plotted plan of wholesale extermination in which regular Turkish officials and troops took part as if in a campaign against an enemy in the field." The World Book Encyclopedia describes Turkey's "campaign to wipe out the Armenians" and notes that "by 1918, about 1,800,000 Armenians had been murdered."

Researchers may be right in saying the picture is not completely clear, but some parts of it — the parts about which Armenians grieve — are.

Equally difficult to understand is Turkey's touchiness. The current government there is not responsible for atrocities perpetrated by its Ottoman predecessors any more than the present government of Germany is responsible for the crimes of the Third Reich. Indeed, the congressional resolution carefully avoids blaming the present government in Turkey.

In 1918, Morgenthau complained that Turkish officials "resorted to the most shameful prevarications" in discussing the massacre of the Armenians. There is no good reason for present-day Turkish officials to evade the issue. Nor is there a good reason for Moody and his colleagues to delay approving this resolution.
