This action having been brought on for trial on the 13th day of January, 1975, at the regular January Term 1975 of this court and having been heard before the Honorable Mark J. Farnum, Judge of this court, and the court having made and filed its findings of fact and conclusions of law:

NOW, THEREFORE, on motion of Frank X. Kinast, attorney for the plaintiff,

1. IT IS ORDERED, ADJUDGED AND DECREED That the bonds of matrimony existing between the plaintiff, Linda K. Taber, and the defendant, Philip L. Taber, by reason of the marriage heretofore entered into by them on December 26, 1971, at Beloit, Wisconsin, are hereby dissolved.

2. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That as a full, final and complete division of the property of the parties, and in lieu of all alimony, past, present and future, the plaintiff shall be awarded the following:

- a) Homestead at 108 Yost Drive, Beloit, Wisconsin subject to mortgage and remodeling costs, and plaintiff shall save defendant harmless therefrom.

- b) Furniture and furnishings located at 108 Yost Drive, Beloit, Wisconsin.
- c) BIW Credit Union account.
- d) Personal effects and personalty in possession of plaintiff.

3. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That as a full, final and complete division of the property of the parties, and in lieu of all alimony, past, present and future, the defendant shall be awarded the following:

- a) 1973 Monte Carlo automobile.
- b) Boat, motor and trailer.
- c) Personal effects and personalty in possession of defendant.

4. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That each of the parties hereto be, and they are, hereby ordered to promptly execute any document or other writing and to do any other thing necessary to carry out and make effective the division of property herein decreed.

5. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That the plaintiff be restored to her former name, to-wit: Linda K. Benedetti.

6. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That the plaintiff may within the six month period, between the date of the granting of the divorce judgment and the date when same becomes final, sell or mortgage the real estate awarded to her without the necessity of application to the court for permission therefore or approval thereof, and may retain the proceeds.

7. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That disobedience of this judgment in respect to a court order for payment of property division and any other payment required of the plaintiff or defendant is punishable under Section 295.03 by commitment to the county jail or house of correction until such judgment is complied with and the costs and expenses of the proceedings are paid or until the party committed is otherwise discharged

according to law.

8. IT IS FURTHER ORDERED, ADJUDGED AND DECREED That this judgment for divorce shall not be effective so far as it affects the marital status of the parties until the expiration of six months from the date of granting such judgment, except that it shall immediately bar the parties from cohabitation together and except that it may be reviewed on appeal during said period. But in case either party dies within said period such judgment, unless vacated or reversed, shall be deemed to have entirely severed the marriage relation immediately before such death.
