Your Grace:

Our attorney Mr. Michael Kachigian has informed the Parish Council that the purchasers of our old Church have requested certain papers from him which only you and the Diocesan Council can supply.

The papers requested being a certified copy of the Diocese By-Laws and a Resolution adapted by the Diocesan Council of the Church to the Calvary United Pentecostal Church, a religious corporation of Illinois and that these should be certified by a custodian of records and have a seal affixed to them.

The Resolution should contain the following information:

- (1) Names of all persons elected to the Council.
- (2) Notice of said election.
- (3) Total number of members entitled to vote.
- (4) Notice of meeting to consider the question of conveying was properly given to all members.
- (5) The number of members present at the meeting.
- (6) The number of ayes and nays cast for the sale.
