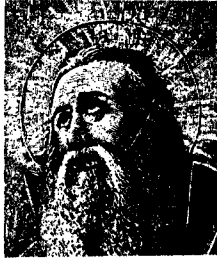
Dear Mr. Kazarian:

Your Grace,

I am happy to hear of your consent to visit our Parish on October 3rd, 1965, for our First Anniversary Celebration. We hope your visit will be a memorable one and that our efforts adequate for the task confronting us. Should there be any way that we can be of any further help, please inform us.

As you may have noticed, there are certain papers enclosed which require your signature and also the secretary's, along with the Seal of the Diocese. This document has been made out in the name of the Diocese because along with it we have proceeded to transfer the title and deed of our new church over to the Diocese.

As you may recall, our original mortgage was for \$85,000 and required us to make payments of approximately \$990.00 a month. Since our consecration of eleven months ago, I am happy to inform you that we have reduced this figure to around \$48,000 and a payment of \$565.00 a month. This was brought about by the proceeds from the sale of our old church and also from monies collected. Due to the change in titles of the church and also because of our choice of lower monthly payments, the following papers require your signature.

I also would like to inform you that we also have approximately \$10,000 on hand to meet our monthly payments and if our October 3rd, affair is successful, to further lower our mortgage.

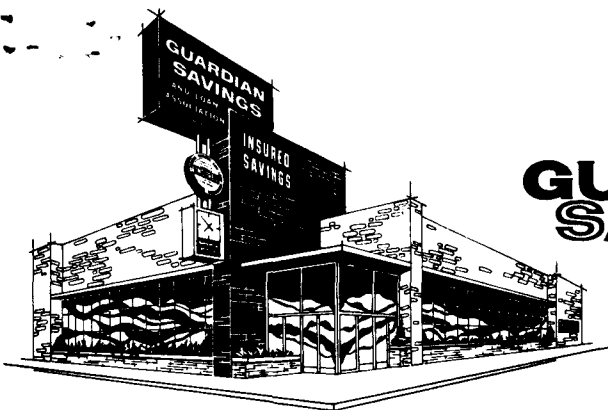
Looking forward to your visit and also a speedy return of the papers, I remain,
