I am in receipt of a letter dated August 20, 1975, without a signature but signed "St. Gregory Armenian Church Parish Council."

Relating to two particular statements of the letter, hopefully they will be resolved with this communication. Regarding item one, your parish being charged for Clergy Insurance, this was an oversight of the Bookkeeping Department and has been corrected and reflected in your last quarterly statement. Regarding item two, your annual payment from the Bylos Fund. The letter stated that your parish had not been paid in the last several years. For the information of your Parish Council, the following information is hereby submitted dating back to 1971 to the present:
