RE: New study commission on South Africa and IRD connections

I write to alert you to the following matter: On Thursday, February 27, 1986, I received a call from Ms. Shelly Green concerning a study she will be working on called "South Africa Beyond Apartheid". It was my first contact with her. The South Africa study will be conducted during the next one and a half years and will be focused on the future of the country and "how we get there." Ms. Green explained that to carry out the study, interviews would be conducted with representatives of U.S. and S.A. groups including labor unions, corporations, churches, anti-apartheid groups and state and local officials. Ms. Green will be interviewing church and labor officials with David Hauck, Director of the South Africa Review Service of the Washington, D.C. based Investor Responsibility Research Center (IRRC).

The kinds of questions which will be asked include the perceptions representatives of various groups have on the future of South Africa, and, based on that, how they expect their activities to impact South Africa. Ms. Green mentioned that she and the other writers would be answering to a board of directors. I pressed her on this point, and she proceeded to read down a list of American and South Africans that were on this committee (see attached list). Among the names she listed were Peter Berger, who, according to Ms. Green, was fairly new to the subject of South Africa, but was on the panel because he was an "eminent sociologist"; and Richard John Neuhaus, who according to Ms. Green, brings to the panel a knowledge of U.S. and South African church groups and recently published a book on the subject. Mr. Neuhaus will be responsible for looking at the activities of church groups in the U.S. and South Africa.

As you will recall, Peter Berger and Richard John Neuhaus were founding members of the Institute for Religion and Democracy (IRD) and have been key players in that organization's attacks on the policies and mission activities of the mainstream Protestant churches. Neuhaus was one of two IRD spokespersons who attacked the churches in CBS's now-famous "60 Minutes" program which aired three years, ago.

While it is not clear exactly what the role of this commission is and what are its official and unofficial ties to the corporate community and the U.S. and South African governments, we in the church community should be extremely cautious. On at least three occasions, U.S. church representatives have been asked about their positions on an "end to apartheid" that would not allow for a "one-person-one vote" political settlement. These occurred during meetings with Chevron Chair and CEO George M. Keller and Chemical Bank President Bob Callendar and in questions by Representative McCollum of Florida following Congressional testimony. These questions by top level officials have been repeated by many other lower level corporate officials. In sharing these encounters among ourselves, some ICCR church representatives believe there is an organized behind-the-scenes effort to formulate a political settlement which is aimed to win broad-based U.S. support, but which will not address the political rights and aspirations of South African blacks.

Furthermore, we perceive that some major U.S. corporations involved in South Africa are giving support to neo-conservative and right-wing "think-tank" type groups. A review of a recent Chase Manhattan company report listing corporate contributions indicates the bank has given substantial sums of money to both the Heritage Foundation and Ernest Lefever's Ethics and Public Policy Center.

Therefore, the "South Africa Beyond Aparthied" study commission has both the ability to play a role in formulating political alternatives in South Africa which do not take seriously the political aspirations of the black majority or the perspectives of our South African church counterparts, and likewise has the ability to serve as a springboard for attacks on U.S. church groups for their South Africa—related activities. I, therefore, urge you to excercise extreme caution.

It is possible that either Ms. Green or Mr. Hauck will be in touch with you soon to interview you concerning your church's/organization's activities on South Africa. If this occurs, please contact either Tim Smith or me. Ms. Green has asked to meet with Tim and me, and we have agreed to a meeting to be further briefed on the study and its origins, funding and goals. We will keep you informed of any updates on this situation.
