This is in regard to your handling of the complaint made against my work as Editor of PAROS by an organization outside the Church (one which is not subject to Diocesan by-laws or governed by the Parish Council, but has its own purposes, by-laws, executive body and treasury), in this case the AGBU. Your procedure was improper, and the letter to me drafted over the signature of Helen Atkian, a copy of which is attached, was offensive in tone.

The coincidence in timing of the AGBU's complaint about a policy which I established eight months ago, and the rush of a "lame duck" Parish Council to push through a motion to accommodate the outside organization, is certainly subject to question.

Since you did not give me my rightful privilege as target of the complaint to receive a copy of the AGBU letter, take part in your discussion of it and present the reasons for my position, I am asking that a copy of that letter be sent to me immediately.

I will, of course, ask for a review of this situation when the newly elected governing body of the Church comes into office, since in my opinion your motion is poorly conceived, badly written and certainly not in the primary interests of the Church.

In order to accomplish that goal, our Church and its local leaders must be sensitive and responsive to the needs of all of our people who incidentally also happen to be God's children. Let us both be remembered as people with wisdom.

Enclosed is a copy of a motion that was passed by the St. Gregory of Narek Armenian Apostolic Church Parish Council at its meeting of March 28, 1988.

At the time that this motion was discussed and later passed, reference was made to page 27, paragraph "i" of the By Laws of the Diocese of the Armenian Church, (copy attached), along with the fact that our Church publication has traditionally published announcements from all our community organizations.

The Parish Council felt compelled to re-emphasize this policy by Resolution because three members of our church, two of whom are relatively new in the church community, have recently in rather vocal and sometimes insulting and disruptive ways, demanded that the occasional announcements that the local Tekeyan and AGBU chapters submit should be banned and that the PAROS should and must publish articles from Church related organizations only.

Under normal circumstances this kind of thing could be handled and laid to rest on the local level in the manner that I have just described; but unfortunately, it appears that this matter will not rest until a much higher authority lends his support to this legally passed motion in a very crystal clear manner.
