The Annual Parish Assembly of St. Gregory of Narek Armenian Church of Cleveland was held at our Cultural Hall on Sunday, February 23, 1986 at 1:30 p.m., with myself presiding as President.

Mr. Sam Mirakian, opened and directed the meeting while the officers of the Assembly were being elected by closed ballot. 54 dues paying members out of 98 total registered church members were present. Mr. Richard Aurslianian was elected as chairman of the day and Mrs. Florence Goekjian for secretary. The Annual Parish Assembly was conducted accurately according to the By-Laws of the Diocese of The Armenian Church of America.

The adoption of the agenda was set and the Assembly moved along smoothly. The pastor, parish council, and subsidiary church organizations presented their annual reports and were approved. Questions were asked and appropriate answers were given. The financial report of the Parish Council was also presented and was approved. The 1986 budget of \$106,838.00 (gross) was approved unanimously.

With the assistance of the Nominating Committee charman, Mr. George Sakian, we elected by closed ballots the following members to the office of Parish Council for a two year term:


