RULES AND REGULATIONS GOVERNING CHURCH MEMBERS IN GOOD STANDING

RULES AND REGULATIONS CONCERNING CHURCH MEMBERSHIP

"All persons who have been baptized and confirmed in the Armenian Church, who accept its doctrine, canons and rites, and who fulfill their obligations to the church and community, shall be members in good standing of the Parish Church and shall constitute the Parish Assembly".

"Every Member of the Parish, 21 years of age or over, shall pay the church an annual due".

"Members in good standing of a Parish Church, who are twenty-one years of age or over, may participate in the assemblies of the same parish and may vote, provided that at least six months have elapsed since the date of their registration as members of the Parish and their dues have been paid. They may be eligible for office one year after becoming members".

"Members who fail to pay their dues for one or more years, automatically forfeit their right to vote at Parish Assemblies, or to hold elective office within the Parish. Such members may reinstate these rights by payment of their dues in arrears for at least the previous two years".

Articles 5, 6, 7 and 8 respectively BY-LAWS OF THE ARMENIAN CHURCH OF AMERICA

RULES AND REGULATIONS GOVERNING PARISH ASSEMBLY

"The agenda of the Parish Assembly shall be prepared by the Parish Priest and the Parish Council. Other matters of new business may be added by majority vote of the Parish Assembly".

"At Parish Assemblies the presence of a minimum of one-third of the eligible voting membership or fifty members shall constitute a quorum. Decisions shall be rendered by majority vote of members present and voting".

"In a Parish Assembly each member shall be entitled to one vote which is not transferable and must be cast in person."

MINUTES OF ANNUAL PARISH ASSEMBLY ST. GREGORY OF NAREK ARMENIAN CHURCH CLEVELAND, OHIO

February 23, 1986

The Annual Assembly of St. Gregory of Narek Armenian Church was called to order at 1:30 p.m. in the Cultural Hall. Father Terenig Kondralian gave the invocation and presided over the meeting.

Parish Council Chairman, Sam Mirakian, welcomed all present and thanked Jean Sakian and her committee for preparing the luncheon.

A roll call by Parish Council Treasurer, Naz Yessayan, established that 54 members in good standing out of an eligible membership of 98 were present and constituted a quorum.

The chairman then turned the meeting over to Robert Bagdasarian and George Sakian of the Nominating Committee who passed out printed ballots for election of the Assembly officers. Elected by closed ballot were:

John Bennaian questioned the status of Honorary Member, Rose Bedrosian. When informed that she held honorary membership, but without voting rights, he offered to pay her dues so that she could vote. His offer was accepted.

The agenda was accepted after 7 items of Old Business and 4 of New Business, for discussion at the assigned times, were added from the floor.

Jack Hacherian moved and Alice Hacherian seconded the acceptance of the 1985 minutes as written.

The next item on the agenda was the election of members to replace 4 outgoing Parish Council members: David Andonian, Dr. Abraham Arslanian, Florence Karoghlanian, and James Nazarian. Also to be elected were 3 members of the Nominating Committee and 3 of the Auditing Committee. Results of the elections by closed ballot were:

The Pastor's Annual Report was approved as written as were the Parish Council Report and Auditing Committee Reports. David Andonian moved and Karyl Aghajanian seconded that these reports be accepted. Motion passed. The Parish Council Financial Report was accepted after some discussion on the accounting system used and on final balances. Jack Hacherian suggested that Parish accountants create a standard, permanent format for a financial program to be used by the Treasurer. Grace Arslanian moved to accept the report and Michelle Schwertner seconded. Motion passed.

Under the discussion of the Projected Budget for 1986, Vergin Arslanian made a motion that as many as possible the Annual Reports be distributed at church in the future and only those not given out be mailed. Michelle Schwertner seconded. Carried. Thelma Bagdasarian asked why there was no projection in the 1986 budget for Paros. The reply was that a rise in postage rates is expected, and that the mailing will increase from 356 to about 425. Therefor it is difficult to accurately perdict costs.

Acceptance of the Diocesan Pelegate's report was moved by David Andonian, seconded by Lucille Andonian.

During the reports of Parish Auxiliary organizations, Martha Hacherian suggested that since the Ladies' Auxiliary is no longer functioning, the Women's Guild might plan a warm weather meeting to assist in dissolution of the group. In the Women's Guild report it was pointed out that there was no mention that Sandra Aurslanian was vice-chairman or that Anahid Aghajanian and Louise Ohanian had arranged the Cultural Day program. In the ACYOA report, Cheryl Arslanian brought attention to the omission of names of the organization's officers. Jean Sakian moved and Sandra Aurslanian seconded that reports of all church organizations be accepted. Carried.

Discussion of Old Business began with the motion by Dr. Krikor Ghazarian that all new non-emergency expenditures to improve the Parish Office be put on hold until a study of plans and estimates of cost can be presented to and approved by the Mid-Year Assembly. Seconded by Michelle Schwertner, the motion passed.

David Andonian moved that the names of all members in good standing be listed in the Annual REport without dollar amounts after their names. Ara Bagdasarian seconded. Passed.

Martha Hacherian asked about the last Assembly's projected committees, namely: Stewardship, Membership and Ways and Means. David Andonian said he would be sending out notices and explaining Stewardship in the PAROS. Ara Bagdasarian will be conferring with Father Terenig about Membership and Sam Mirakian has Ways and Means as a first priority on the 1986 Parish Council agenda.

Jack Hacherian suggested that previous Parish Council chairmen comprise of a Standing Advisory Committee to be available for reference by current Parish Councils. David Andonian moved that an official meeting between the Parish Council and Advisors be held during the 1986 fiscal year to discuss parish matters. Seconded by Florence Karoghlanian. Passed.

Thelma Bagdasarian inquired as to progress on the sidewalk to the outside choir door. Naz Yessayan reported that all walks are included in the overall paving plan.

Thelma Bagdasarian asked that all anticipated Old Business be itemized in the printed agenda.

Alice Bagdasarian inquired about Bingo. Robert Bagdasarian said that the Assembly had authorized continued action on the project and Jack Hacherian plans to report on progress at the Mid-Year Assembly. David Andonian suggested that there be a Standing Committee on the project and a renewal of the license.

The first item on the list of proposed projects recommended by the Parish Council was the parking lot repaving and extension. With \$36,000 to \$38,000 as first projections of cost, the Parish Council is waiting for more bids to come in.

As to remodeling and additions to the church -- Der Hayr said it is not needed at present.

Parish Council plans to get estimates and suggestions for the picnic pavilion and report to the Mid-Year Assembly. It was suggested and approved by the Assembly that rather than consider a door canopy at this time, the present doors should be properly refinished and copper kickplates be installed where needed.

Regarding altar wear cabinets in the vestry, Father Terenig said they were not needed.

Alan Borazanian moved that the Assembly give the Parish Council authority to proceed with the work on the parking lot. Grace Arslanian seconded the motion. Passed.

Ann Karayan suggested that when the paving of the lot was being considered that adequate lighting all around the area be incorporated in the planning.

During the discussion of New Business, Thelma Bagdasarian asked that the minutes of Mid-Year and special meetings be incorporated with the Annual Parish Assembly reports.

David Andonian moved that a Mr. and Mrs. Club be formed as a service group for the church rather than the Men's Club which had been considered. James Nazarian seconded. The motion passed.

Janis Nazarian and Yeretzgin Christine asked that new keys be made for the church school classrooms because they were being entered and left in disorderly condition. Naz Yessayan said that the Parish Council plans to change all the locks in the Cultural Hall.

Janis Nazarian and Thelma Bagdasarian suggested that the agenda should be flexible enough to include new ideas raised in the business of the day.

George Sakian announced the results of the elections to Parish Council, Nominating and Auditing Committees as previously recorded in these minutes.

After a benediction by Father Terenig, the Assembly was adjourned by Chairman Richard Aurslanian at 5:45 p.m.

PASTOR'S ANNUAL REPORT

1986

It was a very good year.

That's the way I would describe the year 1986 for the parish of St. Gregory of Narek Armenian Church. Most of the goals and objectives which we set earlier this year were accomplished. This was due to the persistent hard work and devotion of many individuals, committees and organizations in our church.

Community accomplishments and achievements are hardly the result of coincidence or of single individuals' drive and genious. The truth of the matter is that it takes a collective, concerted effort and determination to bring a plan or a goal to its completion. This was the case in our church last year. For a compact church like ours the accomplishments were exemplary.

Excessive self admiration on past accomplishments is a temting pitfall; we should be alert and extremely careful not to fall into it. Many church communities have fallen into such situations and have become stiff, lazy and eventually paralyzed. We must set goals and objectives and pursue them no matter how much we have accomplished in the past. We must never as a church stop working for today and for our future. There is no such thing as "we have done enough" or "let's take a break". The church work goes on and on; it is never done. It was there before we were born, and it will be there after we have passed on. We must strive for continuity and see that it's kept alive and healthy so that those who come after us may also share the benefits of working for Christ. Yes indeed, it is a joy and pleasure to work for our church; after all, through our church we are given the unique privilege of working for the glory of Christ and the kingdom of God.

The size of our church should motivate us to work harder. We simply can't afford to stop and be content. We can't and we shouldn't stop making realistic goals and objectives, because continuous work is the bloodline of our church. Standing still with no plans and objectives is detrimental to our livelihood and existence.

I truly believe that we have begun turning the wheels of this church forward. We should keep this pace, perhaps occasionally, switching into lower or a higher gear; that is fine and even healthy as long as we're moving forward. What we have to watch is not to stop this working machine, the body of our church.

As in the past, also in 1986, every Sunday our church continuously celebrated the Divine Liturgy (Soorp Badarak). Last year we made a promise to the congregation to start church services on time. We kept our promise and as a result services conclude at 12:00 noon (this includes the sermon of the day). If we have gone overtime it was because of hokehankisd service or a particular feast day which required a special order. During 1986 I have celebrated Divine

Liturgy and delivered sermons on 45 occasions. Two Sundays in July, due to my annual vacation we did not have any church services; although the church was kept open for those parishioners who wished to come for private prayers. On six Sundays, instead of Divine Liturgy (Soorp Badarak) we had Mid-day Services (Jashoo Gark), led by Archdeacon Dr. Krikor krikorian, whose participation has added a great value to the overall quality of our church services.

On several occasions we did services which were out of the ordinary. On Sunday, January 5th, 1986 at 7:30 PM we had Armenian Christmas Eve Divine Liturgy and the next morning Monday, January 6, 1986 we celebrated the Armenian Christmas Badarak and in each instance we had over 25 parishioners in attendance. On Thursday, March 27, 1986 on the occasion of Maundy Thursday, twelve Sunday School boys and ten girls, along with their parents, grandparents, relatives and friends were invited to a supper to commemorate the Last Supper that Christ had with his Apostles. Later that same evening we had the ceremony of washing of the feet. It was good to see a full church. On Easter Eve we had Divine Liturgy followed by a reception in the church office. On two Sundays, June 15 and August 17, we had Divine Liturgy outdoors on the church lawn. Those who attended enjoyed it.

When I speak of church services, it is impossible not to mention our deacons, altar servers and choir who, Sunday after Sunday, rain or shine, freeze or breeze attended church and gave of their voices and talent, leading the congregation in the worship and service of our Lord. For serving on the altar I would like to thank deacon Dr. Krikor Krikorian, subdeacons Dr. Krikor Ghazarian and Haig Arpajian, Simon Ghazarian, John Karayan and Acolytes Ara Arslanian, John McDonough, Boghosig Kondralian and Harout Tabrizian. For singing in the choir I would like to thank choir director Thelma Bagdasarian, our organist Anita Arpajian and members of the choir, Jeannette Aurslanian, Marie Bosnoian, Mary Arslanian, Sue Mirakian and Leslie Bagdasarian. In regard to church services and its related matters one most important component, the congregation's participation, unfortunately remains to be my unfulfilled dream and earnest desire.

Part of our Sunday church services is the teaching of Christian education as taught through our Sunday School. We were fortunate to have a dedicated staff, who persistently against all odds kept the Sunday School education alive. I would like to thank Janis Nazarian our former superintendent who was in charge for the first half of 1986 and Nancy Bagdasarian, the present assistant superintendent, the teaching staff, Florence Goekjian, Ann Karayan, Ara Bagdasarian, Sonia Elloian, Yeretzgin Christine Kondralian and Philip Karayan. The Sunday School of our church is fortunate to have a selected group of parents who support and assist the Sunday School staff. They reach out to help Sunday School raise funds for books and other school related needs. or the Sunday School parental support group I would like to thank Karyl Aghajanian, Louise Ohanian, Sandra Aurslanian, Armine McDonough and Alice Yessayan.

As I begin to report about the church organizations, the Women's Guild does not need any introduction. The long history of their benevolence to our church is recognized and accepted by everyone who

visits the church. I honestly believe that Women's Guild has a mission to support the church in every phase of her life. I would like to commend the chairladies of the executive committee, Aida Janian and Sandra Aurslanian, Secretaries; Alice Hacherian and Elizabeth Latukka, treasurer; Grace Arslanian, advisors; Martha Hacherian and Florence Goekjian.

The ACYOA had a busy year. I have come to enjoy working with the youth of our church. They are really a bunch of clean-cut kids. During March of 1986 we had a lenten weekend retreat in Punderson State Park. A year has passed and most of the participants still reminisce about those moments of spiritual renewal. It was a great experience for all who had the opportunity to participate. On Palm Sunday we marked the 40th Anniversary of ACYOA with a banquet. was good to see so many of alumna. In June 1986 the ACYOA in conjunction with Sunday School had a Father's Day picnic. The proceeds from this was donated to the Sunday School to help them purchase books for the fall semester. To top this, our ACYOA was the best behaved chapter and team at the Annual ACYOA sports weekend held in Philadelphia, Pennsylvania. For the ACYOA Srs. I would like to complement the chairman; Nancy Bagdasarian, secretary; Cheryl Arslanian Gideon, treasurer; Jay Bagdasarian, Advisors: Leslie and Ara Bagdasarian. For the ACYOA Jrs. I would like to commend the chairman Vicky Mirakian and Erica Ohanian, secretary; Dina Aurslanian, treasurer; Sam Mirakian, Jr.

In accordance with a decision made at the 1985 Annual Parish Assembly, a new organization, the Mr. & Mrs. Club was established within the life of our church. A set of By-laws was drawn and approved by the Parish Council. The objectives of this organization is:

- 1) To bring married couples of the Armenian Community together for the purpose of fostering a spirit of Christian fellowship
- 2) To stimulate interest in cultural development and goodwill among its members
- 3) To encourage active participation by its members in spiritual and social affairs of the Armenian Church community.

Since last July the newly appointed interim executive committee is doing a marvelous job. In spite of being a new organization, it is very active and promising. I would like to compliment the Chairman; Russell Arslanian, Vice Chairman; Sarkis Hamamjian, Secretary; Obie Bagdasarian, Corresponding Secretary; Mrs. Jeanne Arslanian, treasurer; Mr. David Andonian and advisors; Jack Hatchadorian and Alex Bagdasarian.

Over and above to different organizations in our church, we also have standing committees which under the direct supervision of the pastor and Parish Council, are appointed to be in charge of different programs.

The Bible Study Group which was revitalized in the fall of 1985 continued its bi-weekly meetings, regularly averaging 12 individuals

for each session. The Bible Study program gives an opportunity to all those who wish to further their knowledge and education in learning more about the word of God in a collective discussion forum. I would like to thank Florence Goekjian, Mae Hatchadorian and Lucy Nigosian for their assistance in calling and informing the interested individuals prior to each study session. As a church and as a spiritual, religious institution we should encourage programs like this.

Due to the noticable decline in our church membership, a committee was appointed to remedy the situation and eventually increase the number of our membership. The committee members were Ara Bagdasarian, Jeanne Arslanian, Richard Aurslanian, Ann Karayan and Nancy Bagdasarian. Due to their well planned and organized work, they increased the church membership by 20%. They must be commended for a job well done.

Another new committee was formed, namely Trustees of the Memorial Fund. After long deliberation by the Pastor and the Parish Council, By-laws were formulated to enable selected committee members to act as trustees of all contributions made to the church in memory or in tribute of a loved one. The committee along with the pastor will be the guardian of these funds, keeping detailed data on each fund and the donor. They will also be in charge of selecting and preparing a list of items needed in the church. The three members who were appointed to this committee are Kevork Arslanian, Florence Goekjian and George Sakian.

Major part of our inter-parish public relations is done through our monthly newsletter the "Paros". For over the 30 years the "Paros" has been published continuously month after month. For so many Armenians living in the state of Ohio at large and out of state, "Paros" is the only means of comunication with the church. The credit for the "Paros" success is due to the past and present editorial staff who gave it their best attention and tender loving care. I would like to thank the former editor, Thelma Bagdasarian and typist, Sandra Aurslanian. Our present editorial staff, Florence Goekjian, Helen Chekemian and the typists, Liz Latukka and Lisa Sakian, and the individuals who helped us to give the "Paros" a new look, Leslie Bagdasarian, a talented professional in medical graphics, need to be commended and acknowledged for doing an excellent job.

The church office and its related day to day operations are mainly administered by me. All means of correspondence and communications are conducted under my supervision. All church related matters are conducted in a professional atmosphere and with a courteous attitude. I have responded to all inquiries promptly Our filing system is kept up-to-date at all times. Clarity and cross reference are pivotal in our management system.

Furthermore, as the ex-officio president of all church-related organizations and committees, I have participated in all their executive and membership meetings and have offered my guidance and counsel. As an ordained priest and your pastor, I have performed

all the priestly duties prescribed in the Bible. I have administered the sacraments to our parishioners, remaining always loyal to the canons and the rites of the Armenian Apostolic Orthodox Church.

I present the following details for the record of 1986. We had the following sacraments: 14 funerals, 3 weddings and 3 baptisms. During the course of the year I attended to 232 meetings, visited and blassed homes of parishioners on 67 occasions, counciling sessions on 33 occasions, visited hospital and administered Holy Communion on 17 occasions, and on 58 occasions I had teaching sessions and rehearsals.

As I approach the conclusion of my Annual Report I would like to acknowledge the members of the Parish Council, Sam Mirakian, Helen Atkian, Krikor Ghazarian, Naz Yessayan, Armen Arslanian, Janet Yoel, and Harry Kananian for their cooperation and support in guiding and administering the needs of this church. As we end the year 1986 and begin the year 1987, let us pray and wish that the Holy Spirit of Christ may guide us to do the will of God, for the benefit of His church and the Armenian people.

DIOCESAN DELEGATE'S REPORT

The 84th Annual National Diocesan Assembly of the Armenian Church in America was held in Racine, Wisconsin. It was hosted by St. Mesrop Armenian Apostolic Church, from May 1-4, 1986.

Archbishop Torkom Manoogian was elected to his 6th term as spiritual leader of the Eastern Diocese.

The Assembly directed the Unity Committee and Diocesan Council to continue efforts to eliminate the split in the church.

The construction of a High Rise building to be built adjacent to St. Vartan Cathedral in order to assure a steady and substantial revenue for Diocesan operations was again discussed. After some debate, the High Rise Committee and trustees were asked to explore further the issue and come to a decision.

The annual Diocesan budget was presented at \$1,000,000.

A surprising proposal presented by the Diocesan Council asked the Assembly to authorize the Primate of the Diocese to request His Moliness the Catholicos to ordain qualified women to the Diaconate. This would reinstate a centuries-old tradition which since apostolic times permits the first Holy Order to women. The rationale for the request was that since men and women are equal in the eyes of God, both are called to serve Him. Also, ordination of women Deacons is a practice and tradition which has fallen into disuse, but there is no known Church Canon Law which prohibits women from such service. There are, now, women trained in theology and faithfully serving the Church in various roles who would be immediately qualified. The Assembly approved the proposal by a 96-22 vote.

At the Saturday Banquet, the "Friend of the Armenians" awards were presented to Senator William Proxmire and to Congressman Les Aspin.

A celebratican of the Divine Liturgy and a brunch, on Sunday concluded the Assembly.

MEMBERSHIP DRIVE COMMITTEE REPORT

In accordance with a decision made at the 1985 Annual Parish Assembly held on Sunday, February 23, 1986, the formation of a Membership Drive Committee was approved. Through organized programs the Committee would invite and register all eligible and qualified individuals in the community (over 18 years of age) to become dues paying members of our church.

Early in April 1986 the Membership Drive Committee was formed under the direct supervision of our pastor, Fr. Terenig Kondralian. The Committee Co-Chairmen were Ara Bagdasarian and Jeanne Arslanian. Other members of the Committee were Richard Arslanian, Ann Karayan and Nancy Bagdasarian.

From April to October of 1986, the Committee held 10 meetings. Definite plans were made as to how to approach this membership drive and complete it successfully.

The following are the steps taken by the Committee:

- I. It was decided that the period from September 14th through the 30th be publized in our parish as "Membership Drive Campaign Weeks." These were the weeks when Membership Drive would reach a climax where every non-dues paying individual in the community would receive a telephone call inviting them to become a dues paying member of our church.
- II. In the months preceeding the fore mentioned two week period each Committee member was given the responsibility of writing letters and articles which were published in the "Paros."
- III. A factual essay was written in the form of a Bulletin by Fr. Terenig Kondralian underlining the present status of membership in the Armenian Church throughout the world and highlighting the importance of becoming a member of the Armenian Church.
- IV. Early in September a membership application and a cover letter of invitation were mailed to all community members.
- V. Numerous telephone calls were made and follow up letters sent to all interested individuals.

Since the Membership Committee undertook this task 20 new members have joined our church. That is a 20% increase.

The Membership Committee extends its sincere appreciation to the Parish Assembly for entrusting this responsibility to them. Through perserverance we accomplished a measure of success. It was hard work to get new members but it is even harder to keep them. That responsibility belongs to each and every member of our church.

Ten issues of <u>Paros</u> were published in 1986. During this year the cover pages were redesigned by Father Terenig with the help of Leslie Bagdasarian, graphic arts coordinator. The new church address, 678 Richmond Road, was incorporated into the format.

The By-laws of Paros state that the newsletter shall be an integral part of the administrative mechanism of St. Gregory of Narek Church and shall be its official voice. It will serve as a vital source of information, to teach and to keep the Armenian community informed about activities, functions and decisions of all church organizations and standing committees.

It shall have articles to teach Christian truths and values based on Holy Scripture, Traditions of the Church Fathers and the Doctrine of the Armenian Church. At present, the publication is carried out by Father Terenig, Editor-in-Chief, who writes articles on religious observances and teachings of the Church, does all the final compilation of the paper, and supervises the printing and mailing.
