called the meeting to order. Decon Raymond gave the invocation. Dr. George Rejebian did the roll call, and declared that there was a quorrum.

A membership of sixty-one paid members, who have paid their
dues for 1973, only thirty one members were present, of which two did not have voting rights, because they have been members less than six months.

3. Election of Assembly Chairmen & Secretary Pro-Tem

Dr. Garabed Fattal was duly proposed and seconded to be Chairmen of the assembly and was unanimously elected.

Mrs. Alice T. Bogdasarian was duly propsed and seconded as Secretary Pro-Tem, and unanimously elected.

Dr. Nubar Astarjian, secretary of the Parish Council read the minutes of the 1972 annual Parish Assembly meeting. Harry J. Mahakian moved that the minuets be accepted as read. It was seconded by John Kasabian, and carried unanimously.

Minutes from the Special Parish Assembly of 1972 were read, John Bogdasarian moved that the minutes be accepted as read, and Alice Ketchoyan seconded, the minutes, and it was unanimously carried.

Mrs. Carol Bogdasarian moved and Mr. Harry Mahakian seconded that the Parish Council form an Ad Hoc committee to study this situation and find the remidies, and report back to the Parish Council.

4. Youth Group

Dr. George Rejebian read the Youth Group report on behalf of Mrs. Marion Rejebian, the clubs directoress who was not present due to illness. The assembly hailed the work being done by this group.

5. Women's Guild

Mrs. Alice Bogdasarian read the Women's Guild Report on behalf of Mrs. Anoush Dekmejian, the Guild's Chairlady for 1972, who was not present due to illness. Favorable comments were said by various members of the assembly.

Diocesean Delegate's Report=

Mr. Ara Misakian, our Diocesan assembly delegate was asked to give his report. However, he did not have a written report, but mentioned the following points.

- A. Decon Raymond particapated in the Assembly proceedings without a vote.
- B. Hagop Injajigian was the representative from the Youth Group.
- C. Some proposals passed or were voted down by one vote. Thus, it is important to have a delegate from the parish attend these meetings.
- D. The A.Y.C.O.A. was disolved, and local youth roups will be encouraged in parishes.
- E. The Dioces has a large deficet in its budget, and to close this gap ways were suggested which are already being implemented.
- F. The first vote was cast and passed for Parish Council chairmen to have a vote at the Diocesan Assemblies.

This year, the same question will be voted upon again, according to the by-laws.

There was a lengthly discussion about the Diocesan Assembly Delegate giving a verbal report, rather than a written report. Most of the assembly members were in favor of having a written report.

Dr. Astarjian moved, Dr. Bogdasarian seconded that the Diocesan Assembly delegate should present a written report to the Parish Council soon after his return from the meetings, and, also to the Annual Parish Assembly, when it convenes, about the pertinant points, and especially matters of general nature, and those who have a bearing on our parish. The motion was carried unanimously.

7. Parish Pastor

Decon Raymond read his report as pastor of the Parish. The members of the assembly unanimously applauded him for his work in the parish.

8. Parish Council Report

Chairmen, Dr. Robert Bogdasarian of the Parish Council read his report. The report is on file. However, he stressed the importance of the pledge system, and encouraged prompt participation by all church members. He also stressed the fact that every parishoner should participate in the work of the church. He thanked all the members of the Parish Council for their work on the council. He also thanked those members of the church who have been of help during the year.

He pointed out that this brings to an end his tenur of eight years in the Parish Council, and wished success to the remaining members. The members of the Parish Assembly hailed him for his dedication, devotion, and the effort he put forth in his work for the church.

9. ,Secretarys Report

Dr. Nubar Astarjian read his lengthly, and interesting report, with a break down of each committees, activites, affairs, religious functions, financial report, etc. Many hours of work went into Dr. Astarjian's complete and accurate minutes, which he so abley did. He stressed the importance each one of us has as member of the church, and all should take on the responsiblities, when asked to do so.

Decon Raymond presented an ammendement to Article 50 of the by-laws. He proposed that article 50 read as follows: The Diocesan Assembly is a permanent body and shall consist of elected lay delegates, decons, who have been appointed by the primate, as Decon in charge of a parish or parishes, and all the priests, and higher ranking clergymen under the jurisdiction of the Dioceses.

This proposal was unanimously accepted and will be sent to the Dioceses for presentation at the Diocesan annual assembly, as an ammendment to the by-laws.
