RULES AND REGULATIONS CONCERNING CHURCH MEMBERSHIP

- "5. All persons who have been baptized and confirmed in the Armenian Church, who accept its doctrine, canons and rites, and who fulfill their obligations to the church and community, shall be members in good standing of the Parish Church and shall constitute the Parish Assembly.
 - 6. Every member of the Parish, 18 years of age or over, shall pay to his (or her) church an annual due, the amount of which shall be determined by the Diocesan Assembly. Such amount may be increased, but not decreased by the Parish Assembly.
 - 7. Members in good standing of a Parish Church, who are 18 years of age or over, may participate in the assemblies of the same parish and may vote, provided that at least six months have elapsed since the date of their registration as members of the parish and their dues have been paid. They may be eligible for office one year after becoming members, provided they have attained the age of 21.
 - 8. Members who fail to pay their dues for one or more years, automatically forfeit their right to vote at Parish Assemblies or to hold elective office within the parish. Such members may reinstate these rights by payment of their dues in arrears for at least the previous two years.
 - 9. No one may be a voting member in more than one parish at the same time."

RULES AND REGULATIONS GOVERNING PARISH ASSEMBLY

- "16. The Agenda of the Parish Assembly shall be prepared by the Parish Priest and the Parish Council. Other matters of new business may be added by majority vote of the Parish Assembly.
 - 17. At Parish Assemblies the presence of a minimum of one-third of the eligible voting membership or fifty members shall constitute a quorum, and decisions shall be rendered by majority vote of members present and voting.
 - 22. In a Parish Assembly each member shall be entitled to one vote which is not transferable and must be cast in person. In case of a tie vote the presiding officer shall cast the deciding vote or he shall authorize a second balloting upon the same question.
 - 43. The Parish Priest shall preside over the meeting of the Parish Council and the Parish Assembly."

PASTOR'S REPORT

Dear Parishioners:

With the grace and mercy of God, we, the members of St. John's Armenian Church Community, have spent another year under the shadow of our Holy Mother Church. With a clear conscience, I declare that I did my human utmost in providing pastoral care and guidance to this Church and her members, without sparing the graces which the Lord God has bestowed upon me. I am grateful to God for the opportunity to serve St. John's Armenian Church for another year.

WORSHIP SERVICES

Divine Liturgy was celebrated, and Armenian and English sermons were delivered every Sunday. Services were also offered during the week in accordance with the requirements of our Church traditions.

Under the auspices of St. John's Armenian Church, Divine Liturgy was celebrated in Ann Arbor, Michigan on one occasion in 1983.

We also assisted our Sister Parishes throughout the year whenever the need arose. We will continue to provide the services of a clergyman to our Sister Parishes in their times of need.

PASTORAL STAFF

In 1983, our Church operated with an adequate pastoral staff. The Rev. Fr. Haik Donikian, Assistant Pastor, and the Very Rev. Fr. Papken Anoushian, Student Priest In Residence assisted me in attending to the needs of our Church and Community.

SACRAMENTS AND RITES

During 1983, the following Sacraments and Rites were officiated: Baptism and Confirmation of infants and adults, 72; Engagement Services, 8; Holy Matrimony, 36; and Funeral Services, 76.

ACKNOWLEDGEMENTS OF SERVICES

The following clergymen celebrated the Divine Liturgy and preached, or were present at our Church Services in connection with their visits to Detroit in 1983: His Eminence, Archbishop Torkom Manoogian, Primate of our Diocese; the Most Rev. Archbishop Sion Manoogian, Chairman of the Supreme Spiritual Council of Holy Etchmiadsin; Very Rev. Fr. Arshen Aivazian, Dean of St. Nersess Armenian Seminary; Very Rev. Fr. Haigazoun Melkonian, Pastor of St. Gregory the Illuminator Armenian Church of Haverhill, Mass.; Rev. Fr. Diran Papazian, Pastor of St. Gregory of Narek Armenian Church, Cleveland, Ohio; Rev. Fr. Garabed Kochakian, Pastor of St. Mesrob Armenian Church, Racine, Wisconsin. On behalf of our Church, I extend my appreciation to our Church hierarchs and her servants for the opportunity of praying and exalting the Lord together at St. John's.

In connection with the worship service of our Church, it is my duty and privilege to thank each and every member of our Komitas Choir and the Deacons of our Church for their dedication and service to our Church and her worshipping congregation. Again, it is my pleasure to acknowledge, specifically, Deacon Ara Haig, Choirmaster, who worked diligently during the past year to make our services dignified and inspiring. During the officiation of the Sacraments and Rites of our Church, Deacons Ara Haig, Daniel Shahan, John Semizian, Michael Ohanesian, Mihran Hoplamazian, Richard Norsigian, and Hagop Asadurian have assisted us as often as possible and we thank them for their concern for the dignity of our Sacramental Services.

PASTORAL VISITATIONS

Hospital visitations, nursing home visitations to the sick and elderly, home visitations for consolation, home blessings, visitations with families of the Parish in connection with the Sacraments and for various other reasons have been attended to by myself, Fr. Haik Donikian and Fr. Papken Anoushian conscientiously and to the utmost of our ability. I would like to remind our parishioners to inform the Church Office directly when the services of a clergyman are needed.

RELIGIOUS EDUCATION PROGRAMS

Under the sponsorship of St. John's Armenian Church and the Church School, the Adult Religious Education Program continued in 1983.

Adult Religious Education courses, featuring Armenian Church History as the subject were continued under my instruction.

Bible Study Classes were conducted during the year in Armenian and in English by Fr. Haik Donikian.

We urge our parishioners to avail themselves of these opportunities to learn more about our Church and her teachings.

ADMINISTRATIVE DUTIES

My administrative responsibilities during the past year have included office work and management, Parish Council and Church Auxiliary Organizations' general body and committee meetings, attendance and participation in organizational functions, promotion of educational and cultural programs, coordination of Church organizations, fund-raising and involvement in the various aspects of our Building Expansion Program.

PUBLICATIONS AND PUBLIC RELATIONS

During the past year, I have continued to follow closely and offer my time and advice to the Editor of our Church Monthly Publication. I take this opportunity to thank the Editor of the Torch Bearer, Mrs. Gloria Mikaelian, for the commendable services she renders to our Church in connection with this publication. Public Relations during 1983 were generally confined to presence at, and offering invocations and presenting lectures to various Armenian organizations, conducting Church and Museum tours for religious, educational, and youth groups for the purpose of introducing the Armenian Church, history, and cultural heritage.

ACKNOWLEDGEMENT OF COMMITTEES

I would at this time like to extend my appreciation to the following Committees and their Chairmen: Super Raffle '83 Chairman, Charles Stamboulian; Special Fund Raising Committee Chairmen, Dr. Edward and Anna Sarkisian; Oriental Rug Sale Chairman, Arthur Apkarian; Bazaar '83 Co-Chairmen Richard Apkarian and Sooren Gozmanian; and Bingo Committee Chairman Vahe Papelian.

We have come to rely upon all of the above annual fund-raising projects along with the newly added Oriental Rug Sale to improve the financial position of our Church. It is a concern of mine and of the Parish Council as it should be the concern of each and every parishioner that without the efforts of these committees the resources of our Church would have fallen short of her growing needs.

Once a year, I write to our parishioners asking if they can find it within their means and their hearts to raise their yearly pledges, because obviously the minimum pledge that is set by the Parish Assembly is not enough to operate our Church. We are all proud of our Church, and we all expect our Church to be there when we need it. The Church is our home; it is our community home, and that is the way we should look upon it.

As our expenses grow in our homes, so do our expenses grow at our Church. Unless one thinks in this manner, he will cling to his minimum pledge. For the past few years we have not raised our minimum pledge because of the economic situation prevailing in this country and in this state in particular.

Perhaps it is time that we raise our minimum pledge. However, whatever amount the Parish Assembly might be willing to raise the minimum pledge to, may not be sufficient to meet our needs. Above and beyond that, I am appealing to those of you who can afford it to reconsider your pledges in accordance with the inflation that has affected your own homes, since the Church is our extended home.

The fund-raisings that take place might then become less important for budgetary reasons. Of course, we must continue to have them for their social and financial benefits, but since we would not be dependent on the fund-raising events, we might make the decision to save the income for posterity, thus, easing our own financial responsibility and that of our children to our Church in the future.

SPECIAL FEATURES OF 1983

On January 26, 1983, St. John's became the first Armenian Church to ever be visited by an American President. In this historic visit, President Jimmy Carter and his wife Rosalyn were the guests of St. John's and toured the Church Complex. President Carter displayed strong interest in our Sanctuary and in St. John's Museum, and was visibly impressed by St. John's collection of Armenian Artifacts, some of which date back to the 7th Century B.C. Throughout his visit, the President indirectly conveyed that he possesses a knowledge of Armenian history.

St. John's Armenian Church celebrated the 25th Anniversary of the ordination into the Sacred Priesthood of Rev. Fr. Haik Donikian, Assistant Pastor, on Sunday, January 30, 1983. His Eminence, Archbishop Torkom Manoogian, Primate of the Eastern Diocese of the Armenian Church was present to preside over the day's festivities. Following the Church Services 380 parishioners and friends attended an elegant Banquet in honor of Fr. Haik Donikian at the Church Cultural Hall on that Sunday. In an effort to bring Armenia's cultural heritage to the attention of both the general public and scholars, the Center for Russian and Eastern European Studies at the University of Michigan, Ann Arbor presented a Festival of Arts and Humanities, "Concepts of Culture, The Armenian Odyssey" from February – April, 1983. The major portion of the magnificent exhibition of Armenian Artifacts and Manuscripts were on loan to the University from St. John's Armenian Church. Developed to illustrate the Armenian artistic tradition preserved in the United States, "An Armenian Treasury in Michigan" was one segment of the Armenian Odyssey. An outstanding exhibition of Armenian Rugs, and carefully assembled programs of performance events, films, and lectures were also devised to acquaint the public with our Armenian Culture. The Armenian Odyssey was the first attempt of a major University in the United States to present a festival of this magnitude devoted to the Armenians.

During 1983, construction of our new kitchen was completed. Enlarged and equipped with the finest equipment available, the kitchen was designed to attain high levels of efficiency to meet the current and future needs of St. John's. Parishioners were given their first opportunity to tour the facilities during a grand opening following Church Services on Palm Sunday.

In 1983, St. John's parishioners were called upon through a national appeal to come to the financial aid of St. Nersess Armenian Seminary. Adhering to this urgent appeal for funds to train young men for the priesthood in this country, our community came forth with an overwhelming response, and together contributed a sizeable amount. Also for the second consecutive year, St. John's fulfilled her pledge in the amount of \$10,000.00 to St. Nersess Seminary.

St. John's was honored with an "Orchid Award" for Historical Preservation and Environmental Planning in the Second Annual Orchids and Onions Competition for Design. Our Church was selected by a jury of design experts from out of over 300 nominations from the general public. The awards panel praised St. John's design because it has "kept the flavor of the Armenian people and culture, not only when it was built, but as an ongoing project." This in itself is a tribute to our parishioners for their foresight and their continued dedication to excellence.

CHALLENGES FACING US IN THE NEW YEAR

The foremost challenge facing us today is the development of our Senior Citizens' Complex. It is the duty and responsibility of our Parish and our Community to ease the loneliness of our elders and to provide them with comfort and security. I am confident that in 1984 we shall begin our Senior Citizens' Complex. We will not spare any effort or funds until this project materializes.

We feel that through the Church School, the Activities Programs, and the Recreation Center we have provided for some of the needs of our Church Community's youth. However, in this regard there are still some things that we should be able to provide. Specifically, I feel that a camp should be opened. I believe that properly structured it can provide an environment where our religious and cultural values and identity will best be communicated to our youth.

Coming to Church regularly or occasionally, making a pledge commitment to our Church, and other donations to the Church every so often, somehow do not seem to be enough for the generation among our parishioners who are expected to make provisions for all of the above. The question that I have on my mind is, "How truly are we committed to our faith and to our identity?" Our willingness to participate and to contribute actually is the barometer of our commitment to our faith and identity. It is we, who make whatever we are doing in our lives to be meaningful. Talking about raising pledges, talking about making sacrifices now, both for our own benefit and that of our children's future will become unnecessary if we ourselves provide the positive answer to the above question. What is expected of me as an Armenian Christian to make my life meaningful for my community and from my Creator's viewpoint? Obviously the provisions that we have to make for our youth, for our elders, as well as for ourselves are beyond the scope of our annual pledges or occasional gifts to the Church. We must begin to seriously consider wills, bequests and endowments, both our own as well as others who are close to us who are in a position to make such provisions.

APPRECIATION AND CONCLUSION

I take this opportunity to express my heartfelt gratitude and appreciation to Rev. Fr. Haik Donikian, Very Rev. Fr. Papken Anoushian, to the members of the Parish Council, and especially the Chairman of the Parish Council, Mr. Arthur S. Mardigian, the Armenian Apostolic Society, Church Auxiliary Organizations and their Executive Bodies, Church Standing Committees, as well as to individual parishioners for their cooperation, services and sacrifices which enabled our Church to conclude another fruitful year. The accomplishments and the success of our Church are their pride and fulfillment.

I pray that God will bless each and every one of us abundantly. May the Lord God also give us guidance and perseverance to continue our good works.

PARISH COUNCIL CHAIRMAN'S MESSAGE

We have completed another year of excitement and accomplishment at St. John's.

The buildings of our Church Complex have started to show their age and repair and maintenance problems had to be dealt with. A review of the actual expenditures for the year 1983 will indicate to you that much time and funds had to be spent in this area. We have been able to take care of certain aspects of this problem but there are many items that must be taken care of in the coming years.

A concern for us is the diminishing rates of pledge income versus expenses. In the coming year we will present to you a plan to bring these figures into proper proportions again.

In order to meet expenses in the past the Parish Councils have initiated new fundraising projects which have become permanent features in balancing the income of our Church against expenses.

In 1983 we followed the trend by introducing a Rug Sale in order to meet our budget as well as unforeseen additional expenses for the year. As you can see, as of 1984, the Rug Sale has been reflected in our budget as a line item of income.

In order to maintain the solvency of our Church finances in the future, we ought to think in terms of permanent endowments for the benefit of our Church. The Parish Council will be taking a small but firm step in that direction. Additional new steps will follow. The success of these programs will depend on its enthusiastic reception by you the parishioners of St. John's.

We hope that together we will be able to confront and to conquer the above challenges for the good of our Church and our people.

PARISH COUNCIL MEETINGS

The Parish Council held 26 regular meetings and 5 special meetings. The special meetings were held for the election of the Parish Council Executive body, building policies and also with the Diocesan Delegates.

The Council also held meetings with various other committees concerning Church projects and activities.

SPECIAL PARISH ASSEMBLIES

The Parish Council called for a Special Parish Assembly on Sunday, March 6, 1983. Our HUD applications for housing for the elderly and handicapped that were submitted for 1980, 1981 and 1982 were reviewed and discussed. The membership present approved a \$7,000.00 increase for legal expenses for Seniors Housing in our 1983 Budget. This line item was increased from \$3,000 to \$10,000 for 1983. This was approved at the request of the Parish Council so that our 1983 HUD application would be prepared by a major legal firm. There were 153 members present at this meeting.

The Parish Council called for a Pre-Diocesan Assembly on Tuesday, April 26, 1983. The issues of the 1983 Diocesan Assembly were reviewed and discussed. There were 43 members present, therefore this was an informative meeting only.

On Tuesday, May 24, 1983, a Post-Diocesan Assembly was called by the Parish Council at which time the Diocesan Delegates reported on the decisions of the 81st Diocesan Assembly. This Post-Diocesan Assembly was called by the Parish Council for the purpose of electing a Church Auditor to fill a vacancy on the Auditing Committee from the nominees presented by the Nominating Committee.

An election was conducted resulting in the election of Mr. Robert Aginian. There were 62 members present at this meeting.

PLEDGE REPORT

The minimum pledge per annum remained at \$78.00 per individual member and \$156.00 per couple in 1983. The year began with 1218 members and ended with a total membership of 1202 in spite of deletions due to deaths or removal from membership for nonpayment of pledges for three consecutive years. Out of the total membership 665 pay the minimum pledge, 315 pay under the minimum, and 222 pay over the minimum.

We would like to remind our parishioners that it is the privilege of only the limited income senior citizens and students to make less than the minimum pledge to the Church. All those who are gainfully employed or can afford to, are expected to abide by the minimum pledge decisions of the Parish Assembly.

St. John's is assessed \$46.00 a year by the Diocese for each pledge member. In addition, the added costs related to membership privileges create an out-of-pocket expense for our Church of \$16.00 a year per member.

We hope that these costs are borne in mind when filling annual pledge cards for the Church.

THE TORCH BEARER, CHAHAGIR

Eleven issues of the Torch Bearer, Chahagir, were published during 1983 including a combined July and August issue.

With the cooperation of the reporters, who assisted us in reporting the news and coming events on a current basis, we were able to maintain the deadline for the monthly publication.

The Pastors and Parish Council extend their gratitude to the Editor, Mrs. Gloria Mikaelian, for her dedicated service enabling us to maintain the quality of our Church publication.

SENIOR CITIZENS' LUNCHEONS

St. John's continued to sponsor Senior Citizens' Day on the second and fourth Tuesdays of every month at the Church Cultural Hall during 1983. Luncheon, programs, and fellowship highlighted the agenda on these days. A special Thanksgiving luncheon and program was presented for the Senior Citizens in November.

The Senior Citizens' Program is subsidized by St. John's, with only a minimal amount charged to those who attend.

Rev. Fr. Haik Donikian is present at the luncheons and usually presents food for thought to the Senior Citizens. Parish Council representative Homer Lafian and former Parish Council Member Leo Zamanigian continue to be present at the luncheons to assist our Senior Citizens in every way possible. St. John's Activities Director, Barbara Sarkisian, coordinates the programs and is present to assist the Senior Citizens.

SENIOR CITIZENS' HOUSING COMPLEX

In 1983, in the name of St. John's Manor Corporation, we again applied to the Federal Government for funding to provide housing for the elderly and the handicapped.

In order to increase our opportunities of receiving funding in 1983, we again submitted a non-refundable deposit of \$500.00 for an option to purchase a parcel of property in the proximity of our Church with the intent that it be acquired for the specific purpose of a Senior Citizens' Complex at the time our application is approved for funding by the Federal Government.

Our application was prepared for processing without any charge by Mr. Peter Sarkesian, Attorney at Law. We incurred processing fees and other expenses totaling \$1,429.00.

In 1983, because of our efforts, we were confident that we would receive funding. Our application was found technically acceptable by the Government; however, for reasons of priority, we were again denied funding.

As of the writing of this report we have not yet arrived at a decision regarding the direction in which we should proceed for funding this project; however, our commitment to the Senior Citizens' Complex remains steadfast and unwavering.

MARTYRS' DAY OBSERVANCE

St. John's Armenian Church commemorated the 68th Anniversary of the Genocide of the Armenian Nation on Sunday, April 24, 1983. The day's observance commenced with a Requiem Divine Liturgy.

Following the Divine Liturgy in the church, requiem prayers were also offered at the site of the Armenian Memorial Monument, Gomidas Vartabed, in Downtown Detroit. A wreath laying ceremony preceded the Hokehankist and the Blessing of the Madagh.

At the conclusion of the Services the Armenians who were present partook of Madagh sandwiches. The balance of the 2000 sandwiches, each one accompanied by a leaflet outlining the massacres of 1915, were distributed to the general public downtown with the assistance of representatives from the ACYOA Seniors and Men's Society Ushers' Corps.

Our sincere appreciation to Mrs. Arakse Hoogasian and her Committee from the Ladies Auxiliary for preparing the lamb and to Mrs. Julie Couyoumjian and her Committee from the Women's Guild for assembling the sandwiches.

ACTIVITIES PROGRAM

This year the Activities Program grew in several directions. The progress dealt with youth, families, adults and senior citizens. Approximately 900 people registered in the Activities Programs in 1983.

One youth program which continues to escalate is our basketball clinic. From barely 20 children age 8-12 years, the program involved 52 children this fall. St. John's participated in the Orthodox Youth Athletic Association with five basketball and two softball teams serving participants from 9 years to adult. During the summer our Men's and Women's Softball Teams took first place in their respective divisions.

Although youth programs have been targeted as a priority, Saturday activities have been slow movers. Day camps run during the summer and Christmas along with floor hockey and basketball clinics were found to be mildly successful. A renewed tradition of an Awards Banquet brought together 240 people to honor our sport teams and volunteers. Family programs including trips to Tiger Baseball, Pistons Basketball, Snow Fun Day and Bowling have brought together families to share recreational pursuits and fellowship.

Adult programs have continued to be the backbone of the program. Armenian cooking, Ultimate Workout, Women's Golf League and Golf Clinic along with Instructional Bridge and Armenian Dance have led the list in favorites.

As usual, Men's Basketball continues to grow and provide an outlet recreationally and socially. Two racquetball tournaments were also highlighted during the year.

Our Senior Citizens enjoyed day trips to various destinations. Our travels included tours of Eleanor Ford Home, Armenian Art Exhibition in Ann Arbor, Sarnia, Detroit Symphony and Rockford-Hushpuppy Factory. Extended trips to Chesaning Showboat in Flint and Florida rounded out the year.

The Activities Advisory Board continues in their efforts to provide quality programs and afford the opportunities for our parishioners to recreate together. The 1983 Board consisted of: Dr. Rose Berberian, Mr. Harry Couyoumjian, Dr. Paul Hovsepian, Mr. Gary Reizian, Ms. Rose Samarian, Mr. Ron Godoshian, Parish Council Liaison Officer, and Ms. Barbara Sarkisian, Activities Director.

20TH ANNIVERSARY OF THE PRIMATE

The occasion of the Twentieth Anniversaries of Ordination as Bishop of the Armenian Church and the Primacy of the Western and Eastern Dioceses of the Armenian Church of America of His Eminence, Archbishop Torkom Manoogian was celebrated by the Diocese of the Armenian Church on April 9, 1983.

St. John's participated in this celebration by presenting a generous contribution to the Archbishop Torkom Manoogian Educational Fund and with the presence of our Parish Council Chairman, Mr. Arthur S. Mardigian at the official celebrations of the Primate's Anniversaries in New York.

25th ANNIVERSARY OF REV. FR. HAIK DONIKIAN

St. John's paid tribute to Rev. Fr. Haik Donikian, Assistant Pastor of St. John's Armenian Church on the occasion of the 25th Anniversary of his ordination to the Sacred Priesthood with a full day of celebration on Sunday, January 30, 1983.

His Eminence, Archbishop Torkom Manoogian, Primate of the Eastern Diocese was present to preside over the day's festivities. Fr. Haik celebrated the Divine Liturgy and delivered the sermon on that day. Following Church Services 380 parishioners and friends attended a Banquet tendered for Fr. Haik.

On this occasion Fr. Haik received a Gontag from His Holiness, Vasken I, Catholicos of All Armenians, bestowing the title of Avak Kahana upon him. Also, the Primate, Archbishop Torkom Manoogian presented Fr. Haik with an Armenian Design Plaque on behalf of the Diocese.

On behalf of the parishioners of St. John's, a twenty-five inch console, color television set was presented to Fr. Haik during the Banquet.

The Pastor and the Parish Council served as the Committee for this special tribute to Fr. Haik Donikian.

25TH ANNIVERSARIES OF REV. FR. DIRAN PAPAZIAN AND REV. FR. MICHAEL BUTTERO

During 1983, the former Pastor of St. John's, Rev. Fr. Diran Papazian and former Assistant Pastor of St. John's, Rev. Fr. Michael Buttero celebrated the 25th Anniversaries of their ordinations into the Sacred Priesthood of the Armenian Church at their respective Parishes of Cleveland, Ohio, and Bayside, New York.

St. John's participated in these celebrations, on behalf of her parishioners, by extending congratulatory letters and appropriate gifts to each of them.

PRESIDENT CARTER VISITS ST. JOHN'S

In an unprecedented historic visit, former President Jimmy Carter was the guest of St. John's Armenian Church on Wednesday, January 26, 1983. Accompanied by his wife Rosalyn, President Carter along with close personal friend, Set Momjian, former United States Representative to the United Nations, and his wife Joan toured the St. John's Complex.

An elegant Champagne Reception in honor of President and Mrs. Carter was hosted by St. John's at which the elected and appointed officials of St. John's Armenian Church were present. President Carter was welcomed during brief addresses by Father Paren Avedikian and Mr. Alex Manoogian. In his address, President Carter expressed his pride in being "the first President of this great country to ever visit the historic Church of a great people."

All three local television channels featured extensive news coverage of President Carter's visit to St. John's.

TEAS

The Most Rev. Archbishop Sion Manoogian, the Chairman of the Supreme Spiritual Council of the Mother See of Holy Etchmiadsin, was the guest of St. John's from March 25-30, 1983. His Grace celebrated the Divine Liturgy and delivered the sermon at St. John's on Palm Sunday, March 27. Following Church Services, a Tea was tendered in his honor by St. John's in the Church Cultural Hall. Members of the Women's Guild served as hostesses for the occasion.

The Very Rev. Fr. Arshen Aivazian, Dean of St. Nersess Armenian Seminary was invited to be the guest of St. John's during the weekend of May 15. Fr. Arshen was the Celebrant and Preacher at St. John's on Sunday, May 15. Following Church Services, a Tea was tendered in his honor. Mrs. Angie Banerian coordinated the Tea with the assistance of members of the Women's Guild.

SOCIAL CONCERN FUND

During 1983, St. John's Social Concern Fund has helped various individuals or families who either have sought assistance from the Church or of whose predicaments the Church was made aware. The total contributions to these recipients for the year 1983 was \$10,750.00.

CULTURAL EVENTS

"Concepts of Culture in America: The Armenian Odyssey" was presented by the University of Michigan, Ann Arbor in an unprecedented Festival of Armenian Arts and Humanities from February 4 – April 9, 1983.

St. John's collection of ancient artifacts and manuscripts provided impetus for the Center for Russian and European Studies at the University of Michigan to initiate and develop "An Armenian Treasury in Michigan" an exhibition part of the larger project, A Festival of Armenian Art and Culture. Since the goal of the organizers was to use works from Michigan collections only, the Exhibition proved that the Michigan Armenian community possesses one of the richest repositories of the Armenian artistic heritage, largely due to St. John's collection.

Sacred and secular objects, Armenian manuscripts, ceramics, metalwork, textiles, and illuminated books and fragments were loaned to the University of Michigan by St. John's for this two month exhibition.

Although the artistic treasures were provided locally, scholars from major universities throughout the United States and Europe participated in the lectures and symposiums. Dramatic readings, concerts, Armenian films, and an Exhibition of Armenian Rugs from the Caucasus, Persia, Turkey and Central Asia also highlighted "The Armenian Odyssey."

SPECIAL FUND-RAISING EVENTS

Super Raffle '83

The Super Raffle '83 Committee was headed by General Chairman, Charles Stamboulian and consisted of a large number of individual parishioners and all of St. John's Organizations. The grand prize offered in the \$100.00 a ticket Super Raffle was a 1983 Cadillac El Dorado. Four cash prizes of \$1,000.00 each were also awarded. The winning tickets were drawn at the Annual Church Picnic on Sunday, July 17, 1983. The net profit realized from the Super Raffle was \$13,158.00.

The Committee realized a profit of \$3,600.00 during 1983.

Oriental Rug Sale

St. John's Armenian Church sponsored a very successful four day Oriental Rug Sale in conjunction with Edward Bashian and Sons, Inc., importers from New York City on October 27-30, 1983.

St. John's Recreation Center Gymnasium was the scene of the gigantic sale which drew an overwhelming response from parishioners as well as from the general public from the Metropolitan Detroit Area.

This fund raising affair was a Parish Council project, having as General Chairman Arthur Apkarian, assisted by members of the Parish Council and dedicated parishioners. We thank Guy Amboian who served as special assistant to the Parish Council as Publicity Director, and also all of the other parishioners who helped in various ways to make this a profitable project. St. John's realized a net profit of \$36,82°.00 from this project.

Bazaar '83

The annual Bazaar provided an exciting atmosphere for the weekend of November 11-13.

In addition to the traditional booths and activities, Bazaar '83 featured a number of activities for the entire family, including a Pie Eating Contest and a Teen Dance on Saturday evening. The color theme reminded one of the recent "Orchid Award" received by St. John's; thus, offering a delightful variation to the decor of past bazaars.

The tremendous success of Bazaar '83 was the result of months of preparation by St. John's Church Organizations and through the dedication of hundreds of parishioners. St. John's realized a net profit of \$53,999.00 from Bazaar'83.

The Pastors and Parish Council extend their appreciation to the General Co-Chairmen Richard Apkarian and Sooren Gozmanian and to their entire Committee for their tireless efforts.

Bingo Committee

The untiring efforts of the Bingo Committee, under the chairmanship of Vahe Papelian, has transferred \$52,984 to St. John's Armenian Church during the year 1983.

The 24th Annual Picnic was held on Sunday, July 17 on the Church grounds immediately following Church Services. Pleasant weather combined with good food and

entertainment provided an enjoyable day of fellowship for the over 600 persons who attended.

Picnic Chairman, Gary Reizian worked closely with the various Church Organizations and parishioners to make this annual event successful.

The Women's Guild Bakery Booth under the chairmanship of Victoria Reizian prepared an outstanding assortment of Armenian and American delicacies, all of which were completely sold out. The Ladies Auxiliary, Women's Guild, Men's Society, A.C.Y.O.A. Seniors, A.C.Y.O. Juniors Project Youth and Mr. and Mrs. Society all contributed their efforts in various capacities at the Picnic.

The Pastors and Parish Council extend their thanks to the Chairman and to all who participated and helped to promote the success of the picnic.

New Year's Eve Affair

The annual New Year's Eve Affair under the chairmanship of Mr. and Mrs. Michael and Delores Blakian was enjoyed by 353 parishioners and friends.

Guests enjoyed a continuous buffet and danced to Armenian music by the Hachig Kazarian Ensemble and American music provided by a Disc Jockey.

The gala event was concluded with a superb breakfast in the early hours of New Year's Day.

ST. JOHN'S RECEIVES "ORCHID AWARD"

St. John's Armenian Church was honored with an "Orchid Award" for Historical Preservation and Environmental Planning in the Second Annual Orchids and Onions Awards Competition for Design co-sponsored by the Michigan Chapter of the American Society of Interior Designers (ASID), the Designers' Lighting Forum and the Michigan Council for the Arts.

Very Rev. Fr. Paren Avedikian accepted the award on behalf of St. John's at a champagne brunch at the downtown Savoyard Club on Saturday, September 24, 1983.

NEIGHBORHOOD DEVELOPMENT

During 1983, there were no requests by parishioners for financial assistance to purchase homes in the Magnolia Subdivision. As of the year ending 1983, we have 7 parishioners out of 8 that have outstanding balances totalling \$33,000.00. The amount paid back during the past year by these parishioners totalled \$25,000.00. A total of 4 parishioners have repaid the full amount of the financial assistance that they received.

We own a home on Winora Avenue, immediately adjacent to the Church Complex. As approved by the Parish Assembly, the Parish Council is committed to purchase all homes on Winora Avenue that are for sale and, in turn, will attempt to resell or to rent these homes to our parishioners in order to preserve our complex. Presently, the house we own is being rented to a parishioner who is contemplating purchase of the house.

ARMENIAN HERITAGE COLLECTION

The Armenian Heritage Collection is an on-going project, co-sponsored by St. John's Armenian Church and the A.G.B.U. Metro Chapter and is recognized nationally as an important contribution to the preservation of the Armenian culture.

In 1983 the Collection was taken to California for the fourth time and was featured in two performances. One in Los Angeles, St. Gregory Armenian Church in Pasadena, and one in Visalia, at St. Marys Armenian Church in Yettem. Also St. Gregory of Narek Church of Cleveland sponsored the first showing of the collection in Ohio.

We are pleased to inform you that six new costumes have been added to our Collection. The script for these costumes has been written, the entire program has been reviewed and the complete tape has been recorded.

We are indebted to Berge Fazlian of Montreal for the choreography, to Charlene Apigian who has given generously of her time and talent, to Ara Berberian who rerecorded the entire program, and to the HARC recording facilities housed in St. John's for the use of their equipment and Armenian music library. All of the above services were graciously donated.

A sophisticated slide projector was purchased by the Committee. It is housed in a travelling case and will enhance the quality of the presentation and simplify the work of the Committee.

It is important to note that the Armenian Heritage Collection Committee is financially self-sufficient and has funded all the above expenses incurred from its treasury.

The Committee consists of Varsenick Apkarian, Margaret Derderian, Rosemary Hoplamazian, Anoush Papelian, Sona Yavruian having Fr. Paren as a regular member of the Committee.

ARMENIAN ARTIFACTS

Guided tours of St. John's Museum were provided in 1983 to Church auxiliary organizations, community organizations, student groups, visiting groups, and visiting Armenian and non-Armenian dignitaries.

Featured articles of interest and ancient relics from the Armenian past continue to arouse curiosity and create a sense of pride in our heritage.

During the year, eighteen artifacts have enriched the Museum which houses the largest collection of Armenian artifacts in this country.

The following is the list of the new acquisitions for the year 1983: One Scroll Armenian Manuscript, two Cilician Armenian coins, two Armenian rugs, and thirteen paintings.

CHURCH-OWNED PROPERTIES

We sold the property that we owned in Sterling Heights for \$15,500.00 in October, 1983 with \$5,500.00 down and the balance to be paid on a three-year land contract. Our special thanks to Mr. Karl Couyoumjian for donating his services in the sale of this property.

We are the one-fifth owner of a parcel of land in Romulus that was donated in 1982.

BUILDING REPORT 1983

During 1983, the Church Cultural Building continued to be used by the Church, Church Organizations, non-Church Organizations of the community, and for rental purposes by individual Church members and non-Church members. The Recreation Center was used by the Church, Church Organizations, non-Church Organizations of the community and by individual Church members for rental purposes.

We have received repeat and referral rentors throughout 1983 and have increased our Hall Operating Income by 4.9 percent over 1982. The major improvements for the year 1983 include: Installation of insulated glass on the windows of the north side of the Cultural Hall; installation of fire, police, and EMS panic systems at the Cultural Center and the Recreation Center; installation of a fire-detection system at the Cultural Center; repair all the chairs of the Cultural Center; repair the doors of the Cultural Center and the Recreation Center; repair and refinishing of all the wooden doors of the Sanctuary; repair the ceiling of the Chapel; repair parking lot lights; repair Church air-conditioning unit; repair Cultural Center and Church furnaces; place new concrete blocks over water drains in the parking lot; build concrete ramps for the handicapped at the Cultural Center and the Church; purchase and improve security systems for Church, Cultural Center, and install security system at the Recreation Center; commission the study of the problems of the Church roof and obtain recommendations; complete private ownership of Cultural Center and Recreation Center telephone systems; replace the oven of the Recreation Center with a convection oven; and purchase additional dishes and glasses for the Cultural Center.

The accompanying tables indicate that out of 157 Fridays, Saturdays and Sundays the Hall was not in use 52 days, 33.3% during 1983. The Church Organizations used the Hall 12.4% of the total weekend days used while paying aside from their assessments only 4.6% of the incomes; the Armenian Organizations used the Hall 10.5% of the total weekend days used while paying only 5.1% of the incomes; the parishioners used the Hall 21.9% of the total weekend days used while paying 21.0% of the total income; the outsiders used the Hall 55.2% of the total weekend days used and paid 69.3% of the total income.

DIOCESAN DELEGATES' REPORT

The 81st Annual Assembly of the Diocese of the Armenian Church of America was held during May 5, 6 and 7, 1983 at the Sts. Joachim and Anne Armenian Church, Palos Heights, Illinois, with a total of 120 registered clergy and lay delegates present.

The Very Rev. Fr. Papken Anoushian also attended from St. John's as an observer to become familiar with Diocesan Assembly procedures.

The Diocesan Assembly was presided over by His Eminence, Archbishop Torkom Manoogian, Primate of the Diocese of the Armenian Church of America.

SIGNIFICANT ASSEMBLY MATTERS

- 1. Judge John K. Najarian (Sts. Sahag and Mesrob, Providence) was elected Chairman of the Assembly.
- 2. Mr. Alex Manoogian (St. John's, Southfield) was elected to a 10-year term on the Diocesan Board of Trustees.
- Very Rev. Fr. Vazken Keshishian (Sts. Sahag and Mesrob, Providence), Rev. Fr. Mampre Kouzouian (Holy Trinity, Cambridge), Judge Vincent Gurahian (St. James, Westchester) and Mrs. Anne Kasparian (St. Gregory, Haverhill) were elected to 4-year terms on the Diocesan Council.
- 4. Archbishop Torkom Manoogian's address to the Assembly included the following: His Eminence referred to several "divisions" that need to be resolved – political divisions, the "division of the generations," and the "potential separation that may be effected by the large wave of new immigrants."

In facing these concerns, the Primate said "It is incumbent on all of us to confront this new situation, not with the myopia of personal prejudice, but with the interests of the Church and the community paramount in our considerations." His Eminence called for more education and training, a "renewed understanding of our Church and the practice of our faith, and an appreciation of our cultural and national attributes."

In conclusion, the Primate said "Our community cannot be what each of us wants of it, but what all of us most require. We are one Church and one people. Let us learn to live that way, for the glory of God and the advancement of our people."

- 5. Approved for the second time a change to Article 62 of the Bylaws increasing the Diocesan Council from 9 members to 11 members. The clergy number will remain at 4 and the lay members will be increased from 5 to 7.
- 6. Approved for the first time a change to Article 59 of the Bylaws concerning the elimination of the Budget Committee.
- 7. Approved for the first time a change to Article 65 of the Bylaws concerning the presentation of the Budget by the Diocesan Council.
- 8. Approved a proposal asking the St. Nersess Armenian Seminary to review their Bylaws with the purpose of having the North American Dioceses structurally involved in the Seminary Organization.
- 9. Approved a proposal to establish Clergy Training Programs.
- 10. Approved a proposal to establish a fund for the theological education of students preparing to serve as clergy in the Diocese.
- 11. Approved a proposal to review the present health insurance programs for the clergy.
- 12. Approved a proposal for the feasibility study on the possible constitution of a Hye-Rise project where the Diocese Building is today in New York City. The proposed project would not alter St. Vartan's Cathedral or the adjoining plaza in any way, and may provide the Diocese with a substantial annual income.
- 13. The Assembly heard the report of the Diocesan Unity Committee and voted to extend by one year the period of time allotted for a successful resolution of this problem.
- 14. Approved a balanced budget of \$1,453,500.00 for 1983.
- 15. Accepted the reports of the Clergy Conference that was held on May 3, 4 and 5, 1983 in conjunction with the Diocesan Assembly.
- 16. Accepted the invitation of the St. Leon Armenian Church of Fair Lawn, New Jersey to host the 82nd Annual Diocesan Assembly to be held May 3-5, 1984.
- 17. The Assembly Banquet held on May 7, 1983 honored Archbishop Torkom Manoogian for his 20th Anniversary as Primate of the Diocese of the Armenian Church of America and the Western Diocese of the Armenian Church of America.
