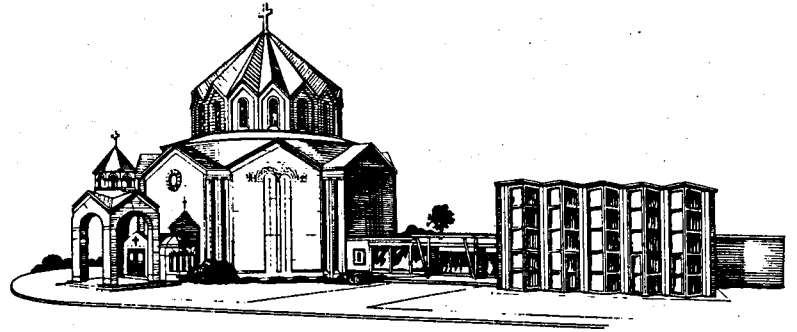

Your Grace:

St. John's Armenian Church of Greater Detroit Annual Parish report has been completed and mailed to you under separate cover.

In accordance with our recent discussion regarding the number of dues paying members reported in our Parish report, the following clarification and explanation is presented to avoid any possible misunderstanding.

- \* The number of dues paying members in good standing in 1992 is 908.
- \* We have previously been erroneously reporting as members those who have not paid their dues for two or more years and therefore are not current members (By-Laws, Article 8).
- \* We had been reporting persons who do not pay full membership dues and therefore were not in good standing in accordance to the By-Laws Articles 5 & 6.
- \* The membership reported in past years have been in error and we have corrected the reporting system and have explained the correction at our Parish Assembly. It seems that some of our parishioners have misunderstood our explanation and have written to you thinking that something improper has been done.

We assure you that this is not the case and that our current reporting system merely corrects a previous error and nothing more.

We trust this explanation will clarify the situation and put to rest any questions. If you require any further information in this regard I would be pleased to respond to your needs.
