THIS CAUSE having come on to be heard upon the Amended
Petition for Dissolution of Marriage filed by the Wife, and in
appearing that an Order of Referral to Special Master was entered
and the testimony of the Wife and her witness were taken, and the
Court having reviewed the transcript of said testimony, the
Findings and Recommendations of Special Master and having
considered the evidence, finds:

1. That the Court has jurisdiction over the parties and the subject matter.
2. That the marriage of the parties is irretrievably broken.
3. That the parties have freely and voluntarily entered into a Property Settlement Agreement dated March 10, 1992, providing for the disposition of all matters of the parties.

THEREFORE, it is ORDERED AND ADJUDGED:

- A. That the Findings and Recommendations of Special Master are approved and are incorporated herein by reference.

B. That the marriage between the parties is irretrievably broken and the bonds of marriage are hereby dissolved.

C. That the Property Settlement Agreement executed by and between the parties on March 10, 1992, is hereby ratified and confirmed and the parties are ordered to abide by the terms thereof and is incorporated by reference into this Final Judgment.


D. That the maiden name of the Wife is hereby restored, and she shall hereafter be known as Nancy Ann Mondello.

E. That this Court retains jurisdiction of this cause to enforce or modify the terms of the Property Settlement Agreement and this Final Judgment of Dissolution of Marriage as may, from time to time, become necessary.
