At a membership meeting of our Parish duly held on March 6, 1955, there were present more than two-thirds of the members of our Parish. At said meeting a resolution was unanimously adopted to sell the building now owned by the Church at 2403 West Main Street, Richmond Virginia, to Dix Popanick for the sum of \$17,000 and the Diocese of the Armenian Church of America was requested to execute a deed conveying said property to said Dix Popanick.

It was also unanimously resolved to purchase vacant lot land located at

In accordance with the foregoing resolutions of the Parish Assembly, we request that the necessary deeds be signed and authorization be given to us to purchase the vacant land mentioned.
