He gave his special thanks to the Parish Council for all their help toward him and his family. He appreciated their dedication, and is working with them for the further development of our Church. Women's Guild has been very active. They had a bake sale which was very profitable.

He said that everyone in the parish has a talent that should be shared with others. He urged our parishioners to extend their hands to help wherever they could in our Church.
