ANNUAL PARISH ASSEMBLY Sunday, February 17, 1991

### **Auditing Committee Report**

The report was presented by Nancy Cherkinian. Special gratitude was extended to Sam Kaprelian for his work and support. The Audit Committee requested that particular mention be made that all items purchased by St. Mesrob Committees become assets of the Church (i.e., no committee may "own" an asset; it is "owned" by St. Mesrob Church).

Jack Kazarian moved to accept the report of the Audit Committee. Mike Garoukian seconded.

There was no old business.

### Proposals to 89th Annual Diocesan Assembly

There were no proposals for the Diocesan Assembly to be held May 9-12, 1991, in Tenafly, New Jersey.

### Proposals to the St. Mesrob Annual Assembly

Five proposals to the parish assembly were presented by the Parish Council to the membership present for their consideration. As spokesperson for the Parish Council, George Stevoff:

- Moved to increase service fee for weddings from \$25 to \$35 for Organist, Deacons and Soloist.
   Seconded by Mel Hagopian.
   Motion passed.
- Moved to change opening balance for the new year of the Parish Council Treasury from \$5,000 to \$7,500, effective January 1, 1992.
   Seconded by Mel Hagopian.
   Motion passed.
- 3. Moved to increase dues for regular members from \$100 to \$105; seniors from \$50 to \$52.50, and students from \$25 to \$26.50, effective January 1, 1992.

  (Rationale for this that if dues are increased slightly every year, parishioners won't feel the sting of a larger increase every few years.)

  Seconded by Arthur Musurlian.

  Motion passed.
- Moved that the age category of senior members be changed from 70 to 80, effective January 1, 1992. (Presented through the Parish Council by Sam Akgulian.)
   Seconded by Catherine Mikaelian.
   Motion passed.

5. Moved that Sunday School fiscal year begin August 1 and end July 31.

(Rationale presented by Lauren Chalekian: due to the Sunday School's operating on a school year [nine months], the revised fiscal year makes "logistics" of operations easier and more efficient.)

Seconded by Mel Hagopian.

Motion passed.

6. Moved by Nancy Cherkinian that the Senior ACYOA checking account be closed and funds be put into the General Fund. Upon reactivation of a Senior ACYOA at some time in the future, the Parish Council would provide appropriate funds. Seconded by Mel Hagopian.

Motion passed.

At 4:10 p.m., the St. Mesrob Annual Parish Assembly was surprised with an honored visit from the Bishop of the North American Diocese, His Grace The Primate, Khajag Barsamian. Surpazan allowed us to continue our meeting, afterwhich he shared with us some thoughts and objectives of his office and the work of the Diocese.

Primary areas of work will be aimed at: strengthening the seminary; developing youth programs; restructuring (reorganization) of the diocese (personnel); and financial improvements, especially at the Diocesan level, with fund raisers for anticipating long-range programs (for the support of the church).

In a brief update on Armenia, Surpazan Hayr told us that there was 100 percent religious freedom in Armenia today; the church is becoming stronger, and attempts are being made to create a "parish life." Concerning the earthquake, work is going faster than before, i.e., improvements are being made more rapidly. (Already in the Diocesan Village in Stepanavan there are two units of condominiums which have been completed with other units slated for construction this year.)

Surpazan kindly offered to answer any questions of the parishioners.

In response to a question by George Stevoff concerning "Unity," Surpazan advised us that we have received no response to our formal letters requesting moves toward unity from the Prelacy Unity Committee. He believes at this time there is no reason to be separated, but contends that no political party should be directing the Armenian Church. The Unity Committee continues to work hard, through correspondence, for unification.

Peter Kazarian inquired about Karabagh. Surpazan said their problems still exist; they are serious problems and will not be able to be solved immediately.

# Closing

With no further questions posed to Surpazan Hayr, the meeting closed with complimentary remarks from the Chair to all report presenters and their committees and to Der Garabed, and that with prayers our church operations will be kept healthy.

Father Garabed thanked the retiring Parish Council members and members of the other executive committees for serving the church with love and dedication. He congratulated the new Parish Council members and offered his continued counsel, support and guidance in the year ahead.

Mel Hagopian moved to adjourn the meeting. Sarkis Cherkinian seconded.
The meeting was adjourned at 5:05 p.m.

Surpazan Hayr led the assembly in the closing prayer.
