REPORT OF THE AUDITING COMMITTEE - 1964

The committee examined the Church Treasurer's account book and found it satisfactory. The examination was confined to:

1. Matching disbursement entries in the account book against issued checks.
2. Balancing the income entries against the disbursement entries.

The following represent the committee's findings based upon the above examination:

Income for 1964	\$ 11,666.56
Disbursements for 1964	<u>11,334.58</u>

Net Income \$ 331.98

The committee again suggests that a standard accounting system be instituted and followed with all account books maintained current and in the Church office and that two audits be performed each year.
