- 2. Names of all candidates (both those who won and those who did not). Same

- 4. Method of balloting (according to Bylaws Article 21, the election of Assembly Officers, Parish Council, Auditing Committee, Nominating Committee, and the Diocesan Delegates must be done by secret ballot). The elections were held by secret balloting.
