

To our first meetings with Bishop Shirvanian in August 1976 with respect to discussion as to incorporation and protection of the name "Diocese of The Armenian Church of Canada"; To our letter to the Federal Government concerning reservation of the said name for incorporation August 26th, 1976; To our letter to Bishop Shirvanian August 26th, 1976 advising as to the reservation and further advice with respect to such incorporation; To our meeting between Messrs. Chertkoff and Prattas with Bishop Shirvanian at this office on September 8th, 1976 with discussions concerning incorporation and processes of operation; To receipt of telephone call from Ottawa September 14th, 1976 advising as to the application and to our letter to Bishop Shirvanian September 15th, 1976 reporting and enquiring as to French name as is required by Canadian Government; To preparation and draft of application for incorporation without share capital under part 2 of Canada Corporations Act on September 21st, 1976; To our letter to Bishop Shirvanian September 30th, 1976 forwarding draft application for incorporation for review; To our discussion on November 4th, 1976 with Bishop Shirvanian indicating French name to be provided to Federal Government and to our letter to the Canadian Government November 4th, 1976 indicating the French name to be applied along with further information; To letter from Government of Canada November 9th, 1976 indicating consents which were required; To our letter to Bishop Shirvanian November 12th, 1976 notifying of the necessary consents and asking instructions; To our letter to Bishop Shirvanian June 15th, 1977; To our meeting with Bishop Shirvanian with Hovanes Topouzian, an emisary from His Holiness, along with Mr. Chertkoff and Mr. Kronis of this office; To our letter to Bishop Shirvanian July 13th, 1977


