Dear Mr. Tchilingirian;

I write this in continuation to my letter of May 21, 1983, regarding the above subject.

Your letter No.A-103 of May 18, 1983 was placed before the Parish Council and the question of the purchase of the land adjoining the A.G.B.U. Alex Manoogian Cultural Centre, which has been earmarked for building our new Church, was reviewed.

I am pleased to inform you that the Parish Council is still actively interested in continuing and finalizing the negotiations for purchase of the said land as outlined in our letter of April 26, 1983 and the subsequent discussions we had at the A.G.B.U. Centre on May 9, 1983.

With this end in view, arrangements have been made for official representatives of the Diocese i.e. Rev. Fr. Mampre Kouzouian, Chairman Diocese Council and Mr. Edward M. Chapian, Attorney of the Diocese, to come to Toronto, in order to inspect the land, the adjoining facilities and have an on the spot discussion with us regarding the purchase of the land in question.

Rev. Fr. Kouzouian and Mr. Chapien will be arriving in Toronto on Thursday June 16, 1983 and will be visiting the A.G.B.U. Centre from 1 - 3 p.m. the same day, where we shall also have lunch. You and Mr. Setrak Zaroukian are cordially invited to meet them at the Centre and also join us for lunch.

Meanwhile, it has been agreed between us that the sign post indicating that the site has been earmarked for "the new Holy Trinity Armenian Church" will be kept in place till the final outcome of the current discussions and negotiations. Mr. G.H. Fleming, P.Eng. Chief Building Official, Borough of Scarborough, Dept. of Buildings, has approved the placing of the abovementioned SIGN, vide Permit No.83-00246 dated January 25, 1983, which I understand is valid for one year.

Kindly acknowledge receipt of this letter at your earliest convenience.
