

FINAL JUDGMENT FOR DISSOLUTION OF MARRIAGE

THIS CAUSE came on for Final Hearing on Thursday, February 18, 1992, on the Petitioner/Husband's Petition for Dissolution of Marriage. Based thereupon, the court has heard testimony of the Husband and his witness, and being otherwise fully advised in the premises, finds as follows:

1. That the parties were married to each other on March 9, 1991, in Sunrise, Florida.
2. That the husband is a bona fide resident of, and has continuously lived in the State of Florida for more than six (6) months prior to the commencement of this action.
3. That this court has jurisdiction of the parties and the subject matter of this action.
4. That neither party is in the military service of the United States of America or any of its allies.
5. That there are no children born as a result of this marriage and none are contemplated.
6. That all matters of the parties pertaining to the division of property, debts, and financial rights and duties of each party

to the other have been resolved pursuant to the Stipulation entered into at a Mediation Conference on January 26, 1993. Said Stipulation is attached hereto as Exhibit "A".

7. That this court finds from the facts that appeared before it , that the marriage of the parties is irretrievably broken and that the same should be divorced. It is hereupon

ORDERED AND ADJUDGED:

A. That this Court has jurisdiction of the parties hereto and the subject matter of this action.

B. That the marriage of GARY CARELLI and IVY KIMBERLY CARELLI is irretrievably broken and that the bonds of matrimony heretofore existing between the parties be, and the same are, hereby dissolved. FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE, a vinculo matrimonii, to be, and the same is, hereby GRANTED.

C. That the Mediation Stipulation Agreement filed in this proceeding as Exhibit "A" was entered into voluntarily after full disclosure, and is approved and incorporated in this Judgment by reference, and the parties are ordered to comply with it.


