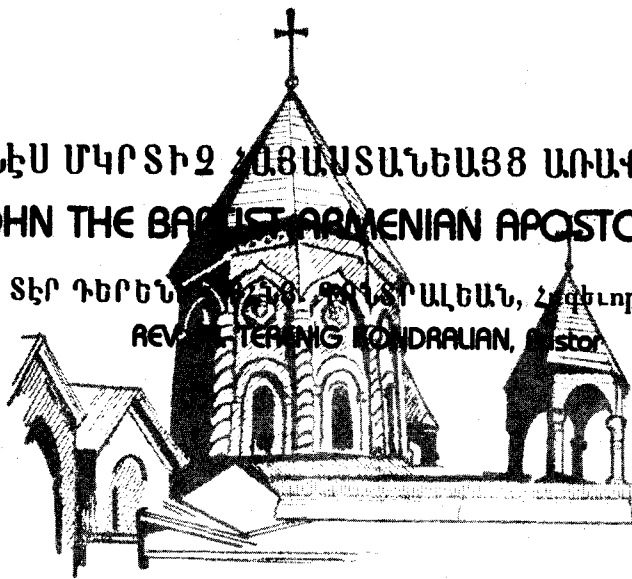

ST. JOHN THE BAPTIST ARMENIAN CHURCH, MIAMI, FLA.

An impromptu and unplanned meeting was held on Sunday, Dec. 29th, following church services with Archbishop Torkom Manoogian presiding. The purpose was to clarify certain issues concerning Father Jirayr Tashjian. The following were present; The Primate, Father Tashjian, Bedros Azarian, Nshan Shaljian and Zabelle Kay. Robert Zakarian was invited, by the Primate, to sit in on the meeting. Also, Zabelle Kay was asked to take the minutes in the absence of the secretary.

Hyre Soorp will be moving to Bedros Azarian's building on Jan. 1st. The monthly rental will be 190.00, including utilities (electricity and water). At the church's expense, the following items will be supplied; pay for painting the apt etc., new bedding (mattress, box spring, blankets, sheets and pillow cases, desk, 3 chairs and book shelves. Also, a telephone extension to his room from the church phone. His telephone bill shall be paid except for his personal long-distance calls. Moving expenses from Paris to Miami, plane fare and delivery of his books.

Life insurance, medical insurance and pension will be supplied by the Church.


The Archbishop will return here for 3 days, Jan. 24th, 25th & 26th. The regional conference meeting will take place on Jan. 25th. Parish Council will make all arrangements.

On Sunday, Jan. 26th, the Primate will celebrate the Divine Liturgy and a banquet will follow the services. The Divine Liturgy will commence at 10 AM and the banquet will start at 12.30 PM. Lighting of the candles, in celebration of the anniversary of our Church, will take place at the beginning of the banquet which will end at 2.30 PM.

The title, of the church-owned car, which, at the present time is in the name of Father Terenig Kondralian, must be transferred to the **Church's** name and all papers, pertaining to the car, must be returned. We have been paying 138.50 monthly to Ford Motor Credit Co.

The meeting ended with a prayer by the Primate..
