Dear Mr. Chirkinian:

It has been reported to us that your parish council allowed itself to reduce the salary of your parish priest, Fr. Hesrob from \$65.00 to \$55.00 a week. The reasons given were that he does not know the English language and that his administrative abilities are limited. We are very much disappointed for this action and would like to point out the fact that it is not fair to reduce the assigned salary of the church servant within any circumstances. It should also be noted that the recognized minimum salary of eur clergy is \$75.00 per week. However we did not, at the time, comment to your paying Fr. Hesrob \$65.00.

The Clergy Assembly of our Diocese which convened on November 13th & 14th heard of the case with concern, and found that it was an act of injustice. It should, moreover, be noted that in the event of Fr. Hesrob resigning from his position, it may take years before we shall be able to appoint another clergy for your church, because 18 parishes out of a total of 42 in our diocese, are without a clergy today.

We have had the opportunity of meeting some of your parishoners who, not only did not complain of your priest, but on the contrary, expressed their satisfaction in the performance of his duties. We are sure you realize that the duties of the parish council are to preserve peace and harmony in the community. With this in view we instruct you to settle the matter of Fr. Mesrob in a satisfactory way and keep us informed.

We take this opportunity to remind you also that in our Circular No. 29 dated February 13, 1957, we had instructed our parishes that deacons should not be elected as members of parish councils. Your parish assembly failed to comply with this instruction and elected some deacons for your parish council. During the next few months

you will call for a parish assembly to elect some parish council members. We advise you to bring this matter to the assembly's attention, in order to carry out the instructions of the above circular.
