



Dear Friend of the Diocese:

We are sending this special letter to you as the year draws rapidly to a close because something very important should be attended to before 1986 runs out.

As you know from the many stories that have appeared in the media, substantial changes in our national tax laws become effective January 1, 1987—less than fifty days away. Although full details have yet to be spelled out, there are some key points pertaining to deductions for charitable gifts, of which you must be aware.

After December 31 of this year, there will be a dramatic rise in the real cost of a charitable gift. At present, those individuals in the 50% tax bracket can make such gifts in the knowledge that every \$1,000 contribution only costs them \$500 after deductions. Starting with the new year, the after-tax cost to a donor of such an amount will be about \$720.

Also affected by the changes will be taxes on stocks or bonds donated to a charitable institution, such as ours. For example, the appreciated elements of property gifts (capital gains) will be subject to the alternate minimum tax, even though the full fair market value of the securities may still be deductible.

These and other drastic alterations in the tax laws make it very apparent that it will be to the advantage of contributors to make their donations now, before 1986 ends. There may be specific factors in your particular situation that can be explained by your tax counselor. What is certain is this: if you wait until after December 31, you could lose a number of important benefits.

We ask you to consider seriously making a special donation to the Diocese at this time. The many activities that are maintained – social service, clergy education, Armenian Language Lab., religious education, Choirs Association, Armenian Church Youth Organizations, upkeep of St. Vartan Cathedral – all depend upon your generosity for their support.

This is the time of the year when the days seem to go by at an accelerated pace. December 31 will be here in an instant. By making a special gift to the Diocese now you can still reap tax benefits that will disappear with 1986.

For those who may wish to donate securities, property or other non-cash items and are unsure of the tax implications, we will be pleased to provide counselling on such matters. If you will call our office, you will be directed to an appropriate source for this kind of information.

Be assured of our prayerful blessings as we enter the Christmas holy days.
