"Volunteer Interpreters" will be needed to assist each family member, during the initial Indoctrination and Learning period. The Soultanians speak Armenian and Farsi languages. Keep their household needs in mind and save those items such as; Bedding, Tables, Chairs, Kitchen wares, etc. you may wish to donate. Parish Coordinator, Mike Mikaelian, should be contacted to answer questions concerning any aspect of this program.





To date, several meetings have been held by the "Armenian Churches of Western New York" which includes the parishes of Niagara Falls, NY; Syracuse, NY; and the Armenian community of Rochester, NY. You have assigned Very Rev. Kegham Zakarian to serve as parish priest for this area.

The three churches have agreed on a stipend with Father Zakarian and are sharing the expenses (as well as the church services) on the following basis for a one year period ending April 30, 1986:

Niagara Falls,	NY	-	40%
Syracuse, NY		-	40%
Rochester, NY		-	20%

The churches have also agreed that Father Zakarian's main residence shall be in Rochester since they are in need of full organization in order to establish a working parish. Therefore, this necessitates that the parishes of Niagara Falls and Syracuse take on the additional cost of providing Father Zakarian's lodging, etc. when he visits these respective parishes.

The three churches have agreed on the following schedule for the months of June, July, and August:

June 2 - Niagara Falls June 9 - Rochester June 16 - Niagara Falls June 23 - Syracuse June 30 - Syracuse July 7 - Niagara Falls July 14 - Rochester July 21 - Syracuse July 28 - Niagara Falls August 4 - Syracuse August 11 - Niagara Falls August 18 - Syracuse August 25 - Niagara Falls

The schedule for the balance of the year will be made at the joint meeting to be held in July.

It has also been agreed that Father Kegham will spend Tuesday and Wednesday of each week in Rochester. He will then travel on Thursday to the parish where he will be celebrating BADARAK. He will leave that parish on Sunday and have Mondays off.

The meeting of the three parishes regarding Father Kegham Zakarian scheduled for November 17 in Syracuse was postponed by the Niagara Falls representatives. The meeting has been rescheduled for December 2nd in Rochester, N.Y.

Since talking to you last week, I have obtained additional information regarding the meeting held on November 4.

The projected budget was estimated at \$26,000.00 to be shared by Niagara Falls and Syracuse at \$11,500.00 each and \$3,000.00 by Rochester.

The lower budget estimate was arrived at by lowering Father Zakarian's stipend to \$10,400.00 per year. There are two questions regarding the stipend. First, would Father Zakarian be willing to accept it, and second, would it be acceptable to you or the Diocesan Council?

Speaking for myself, I do not believe these three parishes will be able to sustain a priest at this time.

#### ORDINATION OF DEACON HAGOP NALBANDIAN

On the weekend of September 16-17, 1978, Deacon Hagop Nalbandian, born in Beirut, Lebanon in 1954, and a graduate of the Seminary in Holy Etchmiadzin, was ordained and consecrated into the sacred priesthood being given the name of Father Zenob, at the St. Paul Armenian Apostolic Church in Syracuse, New York.

The holy order was conferred upon him by His Eminence Archbishop Torkom Manoogian, Primate of the Diocese of the Armenian Church of America. 

As a supplement to the enclosed questionnaire, you might find some further detail of interest.

The Armenian School of Syracuse began in its current form in 1971. Since then the enrollment has declined from 50 to 20 students. Of the current enrollment of twenty, approximately a dozen students can realistically be considered as regulars. During the same period faculty have declined from eight to three.

I will not be able to continue as principal next year. There is also a dire shortage of teachers, and the most reliable teacher in the entire community - in-<u>cluding adults</u> - is a fifteen year-old girl named Lorig Avakian. Continuation of the School is quite doubtful unless additional adult teachers can be recruited and some kind of coherent program is put together.

In addition to the general problem outlined above, I would like to bring to your attention a specific incident which was extremely destructive and demoralizing for us: Long in advance of last summer's Diocese-sponsored teacher training program I advised Miss Der Stepanian (by phone and in writing) of the urgent situation in the Syracuse Armenian community. I stressed that we needed any and as much help as possible from the Diocese. She was very responsive and sympathetic to our crisis. In spite of that, Lorig Avakian was first offered and then denied an invitation to participate in the program - because she was "too young." To say that such a decision was dogmatic is a euphemism - especially in light of the fact that it is so rare to find anyone from our little community who is (a) competent, and (b) eager and willing to participate in such a program. (Incidentally, Lorig had the support and committment from her parents to accompany her to New York.)

Frankly, we feel very isolated and abandoned. It seems that all the attention is directed to the large Armenian communities which are already thriving and really not in any great need of help. Meanwhile, a small community like Syracuse is having very grave difficulties.





The Armenian School of Syracuse began in its current form in 1971. Since then the enrollment has declined from 50 to 20 students. I will not be able to continue as principal next year. There is also a dire shortage of teachers, and the most reliable teacher in the entire community - <u>in-</u><u>cluding adults</u> - is a fifteen year-old girl named Lorig Avakian. Continuation of the School is quite doubtful unless additional adult teachers can be recruited and some kind of coherent program is put together.

In addition to the general problem outlined above, I would like to bring to your attention a specific incident which was extremely destructive and demoralizing for us: Long in advance of last summer's Diocese-sponsored teacher training program I advised Miss Der Stepanian (by phone and in writing) of the urgent situation in the Syracuse Armenian community. I stressed that we needed any and as much help as possible from the Diocese. She was very responsive and sympathetic to our crisis. In spite of that, Lorig Avakian was first offered and then denied an invitation to participate in the program - because she was "too young."
