MINUTES

FRIDAY JAN 24, 1986

- 1 The opening prayer was delivered by Very Rev. Fr. Khajag Barsamian, The meeting was then called to order by chairman Shake Ajamian @ 8:30 pm.
- 2 The minutes of the last meeting were read by Meliha Spinuzza, the only correction was that of the spelling of Biane Kapikian's last name. Scott Najarian then motioned to accept the minutes as corrected, second was by Gary Townsend.
- 3 Melina then gave the Treasurer's report as follows: \$ 24,738.69 in the security account \$ 379.54 in the checking account Scott made a motion to accept the report as read, second by Gary.

OLD BUSINESS

A) CALENDER

E) REGIONAL CONFERENCES

Mid-West : Held Nov. 30, 1985 in Detroit. His Eminence Archbishop Torkom Manoogian was in attendance. Topics discussed included: Regional Ball (Evanston) Regional Volleyball (Palos Heights) 3 Chapters were represented.

Mid-Atlantic : Held Nov. 15, 1985 in Wynnewood. Topics included: General Assembly / Sports Weekend (Wynnewood) Archbishop's Tournament (Bayside) 3 Chapters were represented.

New England : Held Dec. 7, 1985 in Providence. Very Rev. Fr. Baret Yeretzian was in attendance. Topics discussed were: Regional Ball (Providence) Regional Volleyball June 6-8, 1986 (Worcester) 5 Chapters were in attendance.

F) RESOURCE BOOKLET

It was discussed that the Resource Booklet is a very serious project that should be carried out. It was also voted on that a project board committee would be formed to help carry out the function of creating such a booklet. It was motioned by Gary that Shake be in charge of the booklet from this time forth and to continue after her term in C.C. expires in Sept of '86. Second on the motion was by Melina.

The specifics of the book were discussed and temporarily the council came up with the following idea :

The booklet could be a 5' x 7' looseleaf binder, each page would be for one individual only. This was determined for the ease of updating. Each page would contain biographic information and information on the individual's specialty.

Also it was decided that each council member develop a list of topics to be incorporated into the cover letter.

G) ADVISORY COMMITTEE

Because no present council member was at the meeting of the committee during the G.A., we did not understand completely what this committee was suppose to do. Therefore the present council came up with a list of issues for the committee to look into. They are :

- 3. Problems of relationship and interaction between the young adults and the other members of the Parish.
- 4. What changes(ideas) must occur to make the ACYDA a functioning organization?

Gary will work with the aid of Jim on the development of these issues to be sent to each committee member. Have each committee member develop their ideas and sent them back to us by Apr. 1. Rev. Fr. Madiros will be invited to our next C.C. meeting to be the spokesman for the committee. All correspondence would be sent in c/o Shake.

H) CHRISTMAS CARDS

As of this time the Christmas cards are in the hands of Sara. We will hold these cards and get them out for next year. Shake will take responsibility for getting Easter cards out on behalf of the C.C. .

J) 40th ANNIVERSARY COMMEMORATION

It was discussed that this anniversary be a joint effort by the Seniors and Juniors of the ACYDA. The possible dates and host chapters are below:

Discussion centered around the distribution of the profits towards the reprinting of "Sacraments and Prayers..." There was a suggestion made that the host of the N.E. and Mid-West balls match the 25% C.C. donation toward the reprinting with the stipulation that any excess be sent to Etchmiadzin.

100% of the NY proceeds will go towards the reprint.

K) CERTIFICATE OF APPRECIATION

Certificates are to be sent to individuals in appreciation for deeds they have done, whether it be on the national, regional, or local level. The individuals merits would be taken from monthly fact sheets or any council member who knows of a person.

L) BLACKLISTING

It was decided to sent out letters to those whom the Council feels have caused problems at past events. These people would be put on probation for the coming year. If it is found that the problems continue with these same people, they would be asked not to come to any events the following year. It was decided that Gary would formulate 2 letters:

1) Send a letter to all Parishes outlining the policy of enforcing the safe guards at weekends.

2) formulate a probation letter to be sent to those whom the Council feels should be on probation and to their respective parish priest.

NEW BUSINESS

A) COMMUNICATION

B) REGIONAL MEETING W/ CLERGY

A special meeting can be set up in each region with the clergy.

Possibility to have in conjunction with Regional meetings. Fr. Khajag will present the ideas to His Eminence Archbishop Torkom Manoogian. The ideas are:

1) Have a special meeting with only clergy and the respective Council member for the region.

2) A meeting with the clergy, Council member and youth of the region.

C) CALIFORNIA G.A. (Reported by Stephen Sarkisian)

Stephen reported the following points of information he found at the Cal. G.A. :

- C.C. runs the Assembly. Chairman of C.C. chairs the Assembly.
- All material was sent far in advance of the Assembly
- C.C. runs more of the events:
 2 Retreats
 - Sports Weekend (held in Fresno each year)
- G.A. held in different area each year
- General Directory of all dues paid members
- Discussion groups were formed on different topics. This was done at the end of the assembly. The conclusions that the groups came up with were presented at the following year's assembly.
- Proposal to allow Eastern and Canadian Dioceses to participate in their S.W.
 - As an individual : you can participate for a chapter only in individual sports. You also had to attend at least 6 of your chapters gen. membership meetings
 - As a chapter : You must meet Western Diocese requirements.
- Melina will check on the possibility of a rule change for our Constitution to allow members of the other Diocese to participate in our S.W.
- Possibility of a meeting between the two C.C.

D)

Hayr Soorp spoke about different programs which he thought concerned the youth of the ACYOA.

1) Non governmental U.N. - Diocese has been contacted that it can represented by 2 individuals during this program at the U.N.

2) Send a letter to appropriate congressmen of our regions for their support of article 192.

MINUTES OF THE 1984 GENERAL ASSEMBLY

ARMENIAN CHURCH YOUTH ORGANIZATION OF AMERICA Diocese of the Armenian Church of America

August 29 - August 31, 1984 Holiday Inn Alsip Palos Heights, Illinois

His Eminence Abp. Torkom Manoogian Primate

I. FIRST SESSION - Wednesday, August 29, 1984

A. Invocation

The first session of the 38th Annual ACYOA General Assembly was called to order at 7:55 p.m. by the 1983 General Assembly Chairman, Arda Nazerian (Bayside). His Eminence, Archbishop Torkom Manoogian, Primate of the Diocese of the Armenian Church of America led the delegates in an opening prayer service.

B. Roll-Call

George Jevarjian (Detroit), Recording Secretary of the ACYOA Central Council, called the roll. 27 of a possible 35 elected delegates were present. The Chair noted that a quorum was present and the 1984 Assembly could convene.

Two observers from the California Diocese, John Yaldezian and Tory Topjian were introduced.

Also in attendance was the Primate, Archbishop Torkom Manoogian, and Mr. James Magarian, Executive Secretary from the Diocese to the ACYOA.

C. Election of Assembly Chairman

The Chair opened nominations for 1984 Assembly Chairman.

Kurt Norian (Detroit) nominated Melina Spinuzza (Evanston) - seconded by Craig Eranosian (Providence) - Melina accepted.

Robert Shamgochian (Worcester) nominated Scott Najarian (Worcester) - Scott accepted.

George Jevarjian moved to close the nominations and Shake Ajemian (Bayside) seconded. Roll call - secret ballot vote.

Election results: Melina Spinuzza received a majority vote. Scott Najarian was thus the Vice Chairman of the Assembly.

Father Nerses Jebejian introduced two young people from Houston who came as observers to the proceedings.

D. Adoption of Agenda

Arda asked that an insert be made between XIX and XX in the Agenda allowing John Yalduzian and Dean Shahinian to address the Thursday evening session.

Motion to insert the above as XIX a. and b. was made by George Jevarjian and seconded by Nora Ovassapian (Evanston).

A motion was made by Sue Boyajian (Palos Heights) to change the starting time of the Thursday meeting to 6:00 p.m. instead of 7:45 incorporating the Educational Program as part of the Assembly proceedings.

Peter Bogosian (Palos Heights) moved to accept the change of time into the Agenda.

A motion was made to move XX a. and b. to XVII d. and e. Committee Reports from Session 4 to 3.

Craig Eranosian moved to accept the Agenda as amended - seconded by Nora Ovassapian. Motion passed.

E. Adoption of Rules of Procedure

Sue Boyajian (Palos Heights) moved to accept the Rules of Procedure - seconded by Peter Bogosian (Palos Heights).

Melina informed the Council that a Seargent-at-Arms and Parliamentarian will be appointed Thursday morning.

F. Welcoming Address of Host Chapter

The Chair invited Sue Boyajian, Chairman, General Assembly Host Committee of the Palos Heights Chapter of S. S. Joachim and Anne Armenian Church to address the delegates. Sue welcomed the Primate, clergy, Executive Secretary, ACYOA Central Council and all delegates to Palos Heights and wished them every success and a fun week-end.

G. Educational Presentation Educational Briefing - "Public Relations".

The Chair then turned the floor to Arda Nazerian for the educational presentation. Arda presented a very informative and interesting discussion of the difference between Publicity and Public Relations and the need to promote the ACYOA and its goals in the Churches as well as the Communities. A discussion followed regarding the possibility of lowering the age of the Senior ACYOA or the combining of the Juniors with the Seniors in order to encourage the youth of the Churches to remain active.

Arda also asked the delegates for their opinions regarding the publishing of a public relations or guidlines handbook including the goals and purposes of the ACYOA. The delegates felt that this would be of benefit to the organization. James Magarian, Executive Secretary, then gave a brief explanation of the function of the Assembly Committees.

The purposes of the ACYOA was read to the delegates by Melina.

The Chair entertained a motion to recess the Assembly until Thursday morning and was seconded by George Jevarjian. The Assembly recessed at 9:35 p.m.
