PROGRESS REPORT Armenian Church Youth Organization of America Diocese of the Armenian Church of America

August 1981

As per the request of the Primate and Executive Director of the Diocese, the following report is respectfully submitted by the Executive Secretary to the ACYOA regarding the National Youth Program of the Diocese - the ACYOA.

Part I. PROGRAMS

We have succeeded in re-establishing, expanding and establishing the following programs:

 Armenian Studies Programs: Cancelled entirely in 1980, the ASP has been firmly re-established as one of the most complete and worthwhile programs of the ACYOA and the Diocese. It has also been expanded to offer two other trips. The ASP includes the following: 1- Educational Tour to Armenia 2- "Journey" to Armenia 3- Jerusalem - "The Holy City"

Program 1 was filled to capacity, and was well received by the participants. Program 2 involved 7 participants who were given materials and guidence/instruction as they were part of a commercial tour to Armenia. The participants enjoyed the trip very much. Program 3 is currently in progress with 14 participants.

The entire program can only be viewed as successful - educationally, financially and in terms of good public relations for the ACYOA and the Diocese. We are anticipating a fuller response next year.

2) ACYOA St. Vartan Camp: Presently in its third year, the camp has had two highly successful sessions since a slow start in 1979. Over 100 participants registered for this past session held in July. Consideration is being given to offer two weeks of the program next year. There is some concern among ACYOA members in the Mid-West Region as to the current camp only practically available to Armenian children in the New England/N.Y.-N.J. area. We are intending to pursue the possibility of offering regional camp programs to those areas of the Diocese that might benefit and support such a program.

- 3) Mission Program: Once a highly attractive and motivating program, the Mission Program is re-established and currently planned for two parishes of our Diocese.
- 4) Archbishop's Essay Contest and Awards: This new program shall commence in January of 1982. It will offer awards in both Armenian and English categories, providing for more serious minded young adults a chance to express themselves and compete for awards. The winners will be printed in appropriate publications.
- 5) Chapter Chairmen's Roundtable Seminar: This program has expanded to include an educational teaching/learning experience for the participants. Featuring lectures and discussions involving group dynamics, organizational skills and administrative techniques, the leaders of the ACYOA Chapters have the opportunity to share experiences and become more sensitive to the needs of their membership as well as how to become good leaders themselves.

Other on-going and evolving programs include:

- 6) Scholarship Program
- 7) Archbishop Torkom Manoogian Basketball Tournament
- 8) Awards Program: Chapter "A" Award and Honorable Mention; Sam Nersesian Award
- 9) Regional Retreats
- 10) National Sports Weekend
- 11) Anniversary Balls
- 12) Martyr's Day Commemoration
- 13) ACYOA Day Celebrations
- 14) Publications

When all the abovementioned programs are efficiently operating and involving the majority of Armenian young adults (each to their own liking), the over all program of the Organization may be termed complete, or balanced. Unfortunately, many of the programs are not well executed at the parish level (and sometimes on the Central Council level as well) and potential participants are left out. Because we mainly deal with volunteers, and we would be without any semblance of an organization without them, we need patience and understanding that in some instances a program will not be well executed, the specifics poorly defined, participation limited and results frustrating. As in any church youth organization, the ACYOA should strive to offer programs and services that are attractive, offer solid experiences, as well as promote and teach the basic principles of the Organization and the teachings of the Church. The process should be enjoyable, comfortable and exciting.

Because we live in a multi-faceted society with a pluralistic fabric, our young people, like other young people, are not likely to attend programs, meetings, activities and events that are in any way leading them into frustrating, uncomfortable situations with little or no feeling of accomplishment or time well spent. We are currently faced with a value system that is not in line with the teachings of the Christian Church. This over-powering value system of our society is constantly invading the homes of our youth, while our teachings make token visits. Thus, we have to deal with our present situation and take into consideration all the variables and constants if we are to be effective at all. Unless our events and programs have meaning for the individual, or, offers something of necessary value or is unique, we cannot expect (realistically speaking) their participation and support especially if we continue to hover on the fringe of professionalism. (To seriously consider youth programming from a professional perspective, we need a respectable budget and a staff of field workers.)

Although program development and execution is a slow process, and certainly one that requires exertise, insight, and financial support, we intend to bring all our programs to a level at which we offer something of value to all our young adults - no matter the degree of their faith or ethnicity. One by one we shall introduce needed programs and update current ones, as well as eliminate the out-dated. Our primary resources are time and money - both of which are equally needed - however time is our biggest problem.

Part II. VISITATIONS

During the past 10 months, 20 parish visitations have been made on a formal or informal basis to communities with and without established ACYOA Chapters. We have succeeded in re-establishing several chapters, begun the initial stages in others, as well as have established for the first time Senior ACYOA Chapters in two communities. (Washington, D.C. and Houston, TX)

General observations regarding parish visitations is that the biggest problem at the parish level (although it remains a problem at all levels) is finding capable leadership from among the ranks of the young adults. Many parishes are in desparate need of solid leaders to organize, communicate ideas and goal orientation as well as maintain the simple operations of an ACYOA Chapter. (For example, a chapter will be operating fine with an average number of members, when the one ot two leaders of the chapter move away, go to college, marry, etc., and pull out - most of the time there will be no one to pick up the leadership roles and continue the chapter.)

The young adults are there, they exist, they somehow relate to their parish church, they are in many instances interested and concerned about their faith, they even volunteer their help when called upon. However, when asked to take on responsibility, to participate in a leadership role, to actually be accountable, they are quick to excuse themselves, to not be able to find the time, to simple reply in the negative

Yet, in those parishes where there exists one, two or three individuals who are of leadership calibre, who take on responsibility well, who enjoy organizing events and activities, there exists chapters who have a complete and full schedule of activities and who participate in many programs from the local to national levels. This is true in both large and small parishes.

Many times we are quick to "credit" or "blame" the clergyman for the success or failure of a given parish or ACYOA Chapter. This formula is usually not very accurate, nor does it help to understand the problem and find a solution. Yes, an energetic clergyman who can communicate well with youth, who is very dedicated to the concerns of youth, who can organize and follow up is certainly a valuable asset to the ACYOA and the Diocese. But this so called "qualified" clergyman is not the hinge of the local ACYOA Chapter. In many cases, we have very qualified clergymen with a small or sometimes inactive chapter. In other cases we have clergymen who are "unqualified" with active and growing chapters. In still other cases, where there is no permanent clergyman, we have operating chapters too. (The reverse of the aforementioned also exists.) Thus, there is no formula involving clergymen whereby one can calculate the success or failure of a given chapter. This is not to say that the role of the clergyman is not important. The importance Should be understood, and we shall not discuss it here.

The most energetic and healthy communities are those which have dedicated clergymen, along with dedicated participants of leadership calibre. It sometimes takes one to motivate these participants, to nurture them while they are young (in the Juniors perhaps); it sometimes means pouring alot of time and effort into a community with a potential of only 10-12 ACYOA members. But we are concerned with both the large and the small parish. We contacted selected individuals in various parishes with whom letters of support, encouragement, suggestions are sent. We call on them to speck concerning their ideas, problems, potentials and weaknesses. Personal contact is the most effective and rewarding means of developing a chapter. We are currently giving much thought into the possibility of developing a series of regional field workers to work with the Executive Secretary in trying to reach the many parishes from throughout the Diocese.

In conclusion, a solid program of events and activities that are diversified for all interests, that can stimulate and motivate our young people is of primary concern at the moment - in tandem with more personalized contact and support in terms of discussions, ideas and materials and resources. We intend to support our leaders who perhaps are the keys to active chapters, as well as teach and develop the skills of some of our potential leaders.

Yes, we need the clergymen to fulfill their roles; yes, we need participants with leadership potential; and yes, we need a well balanced, operating program that can motivate, satisfy and challenge a very diversified youth population - that, for all intents and purposes, may be viewed as assimilated into the mainstream of late 20th century American society.

It is by fully understanding the situation, as it exists in the various regions of our Diocese, that we may thereby develop the necessary courses of action.

Part III. DEVELOPMENT

The ACYOA has had a record of inefficient administrative and operative execution. Over the years, the ACYOA has begun various projects, started certain so called "standard" procedures, and have even tried to continue these from one Central Council to the next. Most of the time, however, they have been unsuccessful in carrying out these because of time, effort, dedication, proper planning, etc., etc.

During this past year, we have made a very concerted effort to finally establish some basic procedures to enable programs to be executed with some regularity; to enable administrative operations to be carried out with some form of professionalism and propriety. To a certain extent, we have succeeded in our efforts. However, we continue to develop these with the intention of not making more work, or adding to the amount of paper that is used, but to make communications easier, simple and direct; to design forms and directives that are fully understood, and to make the participation on the part of the chapters and members as basic and easy as possible.

The various programs and administrative operations that the ACYOA offers and directs have all been reviewed. Some are under consideration for elimination **or** modification. Forms that are simple and easier to fill out have been developed for use by Central Council members, Chapter Executive Officers, and applicants to the various programs. Although it might seem simplistic, and perhaps one might question why this had to be done, the reason is that most ACYOA programs and operations have been done quite haphazardly in the past relying on one individual with an electric typewriter to design some type of form, or develop a guidline, etc., etc.

Proper forms for scholarship application, nomination for awards, chapter visitation forms, chapter monthly fact sheets, membership renewal, chatper annual report, etc.,etc. have now been standardized to allow for proper completion, review, filing and comprehension. As new programs and procedures dictate, new forms will be designed following the now established standards allowing for some continuity. A more simplistic and proper filing system has been introduced. Prior to this, the entire filing system of the organization would change from one year to the next, from one individual to the next depending on the persons ability to understand simple filing procedures, as well as find where the last person place the desired item. It was completely disorganized and a considerable amount of time had, and continues, to be spent on it.

For our Armenian Studies Programs, we have made our first printing of a handbook for the participants. Although in its first printing it remains the most complete handbook in the last 11 years of the program. It has been requested by several travel agents for use in their commercial tours. Revisions will be made for the next printing to keep the handbook up to date and allow for some evolution.

Keghard, the quarterly publication of the ACYOA is entering its first transitional stages. A new coordinator/editor has been appointed and a fall issue under the new coordinator and staff is currently planned.

The publication has had several impressive issues since its first printing in 1978. Although it is highly literary and serious in nature, it did appeal to a cross-section of the ACYOA membership as well as subscribers. We are now considering changing the format and designing the <u>Keghard</u> to subtly include the teachings of the Church in an attractive layout and design as to have a greater majority of ACYOA membership read the publication. Cultural articles as well as current events issues will also be a part of the new look.

Until its postponement, the Diocesan montly publication, <u>BEMA</u>, was a valuable tool of the National Organization. More ACYOA members, and more importantly, <u>potential</u> ACYOA members, read about the Organization than ever before. The news articles of past events and activities, as well as announcements of coming programs were well done and read by **the** youth of our Diocese. More families received the <u>BEMA</u> than the other Armenian newspapers combined. We thus had a direct line to our youth - both those who relate to their Church and ACYOA, as well as those whose names we have yet to receive. We hope that publication will soon resume to enable our lines of communication, the most efficient thus far, to again enter the homes of our young people across the Diocese.

Until recently, when most of our time and attention has been focused on the upcoming General Assembly and National Sports Weekend, we had been compiling materials and preparing a handbook for chapters outlining, with some detail, "how to" participate in the various programs and operations of the ACYOA on local, regional and national levels. We feel that this handbook will be a vital tool in assisting potential leadership in executing their duties. We have found that many of our parishes/chapters are in need of direction and guidence. The wave of individualism of the 1970's may soon be subsiding as our members are asking questions to enable them to fully participate in the National Organization, and realize local potentials while utilizing as many resources as possible. We hope to complete the handbook as soon as possible and distribute it to all parishes. We have also been referring to handbooks printed by other denominations for their youth and have used some of the techniques and formats that they have found effective.

Although the annual National Sports Weekend is usually well attended and very popular, we are exploring the possibility of offering a National Cultural Weekend allowing those young adults with otherthan-athletic interests to participate and learn, compete, experience and be exposed to their cultural heritage. Arts competition, films, and various other cultural expressions will be a part of this unique weekend.

One of our most important endeavors is designing a network of regional field workers to increase contact and guidence with the chapters and membership of the parishes within a given geographical area. As we had mentioned before, personal contact and guidence are keys to the efficient and effective operations of the ACYOA. The Executive Secretary cannot realistically meet the needs of all the chapters in the Diocese, as well as work on developing new The Diocese is too large and the costs are simply prochapters. A staff of regional field workers would allow for more hibitive. contact between the Youth Office and the parishes, and certainly show a major difference within a short period of time. While development in this area takes some time, we hope that we are able to pursue this vital need and begin its operations soon.

Another area of development is the designing of proper certificates for the various programs. We issue awards and citations, without a standardized, or properly designed certificate for the individual to keep. (In some cases, a rotating trophy is given to the chapter or individual to keep for one year.) Certificates have been or will be prepared for the following: l)Special Recognition. 2)Sam Nersesian Scholarship. 3) Sam Nersesian Award. 3)Babayan Cup. 4) Kulhanjian Sportsmanship Trophy. 5) Archbishop's Essay Contest. 6) Archbishop Torkom Manoogian Basketball Tournament.

The aforementioned are part of the on-going development that is necessary if we are to maintain the ACYOA - which is in fact the National Youth Program of the Diocese of the Armenian Chuch of America. There are other developmental aspects that occur every day as the needs arise. Although this year marks the 35th anniversary of the founding of the Organization, we remain in our early stages of development and evolution - changing with the times in a concerted effort to meet the needs of our Armenian young adults, as well as lead them in the light of the Holy Church. As we had mentioned before, time and money are our primary resources. They are what we need the most of. Unfortunately, we cannot increase the amount of time needed - even today as we discuss this, many young adults are drifting further and further away from their Church and community. We must continue in our efforts and do as much as possible given the time and money available. We hope that the number of accomplishments and successful endeavors will increase.
