

Dear ACYOA Chairperson:

Young athletes from both the United States and Canada will be coming to Boston this Labor Day Weekend to participate in the 1993 ACYOA National Sports Weekend. Both team and individual sporting events will be offered. The Sports Committee is enthusiastically anticipating the largest and most talented sports field ever!

There are a few stipulations that must be fulfilled to participate in the sporting events. Athletes must purchase either the minimum eligibility plan (MEP) or the full package plan. It is mandatory that every athlete complete the individual sports registration and waiver forms. Each athlete must also be listed on the team rosters. As a team member, you are responsible for being at your scheduled game on time. Forfeiture will result in your team's absence. Due to the large field of teams, **absolutely no allowances will be made**. The individual athletic fee is \$10. The team fee for men's basketball, women's basketball and co-ed volleyball is \$150.





Almost all of the hospitals are closed due to lack of electricity, heat, supplies and food. Those that remain open have no anesthetics. Communicable diseases are on the rise. The situation has passed crisis and there is no end in sight.

Some members of the media should be commended for drawing some attention to this tragedy, but it is not enough. Thousands of people are starving. Babies are dying in hospitals due to lack of food, medicines and heat. This is no longer a minor situation. Armenia is in chaos and few know about it. The media has inundated the American public with coverage of the events in Somalia and Bosnia. Doesn't Armenia deserve the same? I urge you to bring this crisis to the attention of the world.

Six Weeks in the Holy Land

Personal Reflections on the Diocesan Jerusalem Summer Internship

The following essay is adapted from remarks delivered by Ms. Gononian during the 1992 ACYOA Assembly on Long Island, New York.

or six weeks this summer five interns accompanied by Deacon Serop Aljalian participated in the Diocesan Department of Youth Ministry's Jerusalem Internship Program.

Those who have traveled to⁻¹ Jerusalem will recognize my impressions as the enthusiasm which naturally overcomes anyone who visits the Holy Land; for those who have not had this pleasure. I hope this discussion will entice you to consider participating in the program next year.

Jerusalem is by far the most interesting and beautiful place that I have ever traveled to. The Armenian Partriarchate is a walled City consisting of the Cathedral of St. James, several churches, libraries, a school, social clubs, stores, a monastery, a seminary and a whole neighbor-

Sector Bart & Sta hood. Besides the clergy, approximately 200 families live in the vank and in surrounding properties. At any given time you can

see members of the clergy walking through the main courtyard dodging the soccer balls of the young children.

The Patriarchate is undergoing major renovation and rebuilding. There are construction and renovation projects going on all over the vank. The interns were responsible for the pre-renovation clean-up of Soorp Prgitch, a monastary located just outside the city wall.

This light manual labor consisted of the clearing out and Land. cleaning of rooms, halls, bathrooms and gardens that had been neglected for years. We were also responsible for the cleaning of headstones, monuments and the tombs of the former Patriarchs of Jerusalem, In addition to this work, each

member of the group also took on a project. Berj Kalajian from New York tought the seminarians daily

art classes. Gary Assadourian, also from New York, taugh the seminarians plano and drama. Stephen Sarafian from California was involved in the re-organization of the Gulbenkian and Seminary libraries. Margaret Tomanelli of New York and I were responsible for the filming, scripting, editing and overall production of an informative and ultimately fundraising video about the Patriarchate.

In return for our work, the Patriarchate provided us with beautifully renovated apartments, meals, daily Armenian classes.



Dear Ms. Shooshan:

I am writing this letter on behalf of St. David Armenian Church in Boca Raton, Florida, and specifically for the ACYOA of this church. I am currently on the Parish Council and hold the office of Treasurer.

Recently I obtained all of the financial records concerning the 1991 ACYOA National Anniversary Ball, held here in Boca Raton. I have reviewed their records and was able to ascertain that all expenses incurred were properly documented, with only a few minor dollar amount invoices not in file. I also took note that the Central Council gave the local ACYOA "seed" money of \$1,000., and also advanced an additional \$4,350. to help them pay their bills on a timely basis while they were still receiving deposits from the participants.

Those are the major facts that I was able to ascertain from the financial records that I reviewed.

After reviewing all the invoices, the prime concern that I had was with the printing bills, specifically those payable to Printcrafters Inc., for the printing of material for the ball. I have attached copies of all their invoices; please note that the total to Printcrafters was in excess of \$5,000. Shipping costa alone of approximately \$250.00 could have been avoided if printing was done locally. Why was a printer in Philadelphia selected for material to be used in Florida, when we have many fine printers here locally? Who made this selection? I was told that the local ACYOA was not involved in the selection process. Quantities printed were excessive and many errors and omissions were noted in the final product, too late for any changes to be made. Although objections were raised, nothing was done to give the local chapter support in their displeasure. The opinion here was that the excessive costs should not have been incurred and that the Central Council should have assisted the local chapter in some sort of relief. At the end of the ball, and at the conclusion of paying all bills, receiving all payments, making refunds, etc., the local chapter had approximately \$1,800. left in its treasury and still owed the Central Council \$2,175. The ACYOA was then advised by the Parish Council to close their account as they were also incurring service charges from the bank and their balance was slowly decreasing.

We made every good faith effort to get this problem resolved over a year ago and I personally wrote to Charles Shooshan and copied Papken Maksoudian requesting information about the status of the account and never received a response.

Since the ACYOA closed their books and are extremely disappointed with the financial results, they asked the Parish Council to assist them in clearing this matter. Not only did they not gain any financial rewards, but stand to lose money on the whole affair. All their work to make the affair a success, becomes meaningless. Several members have voiced their opinion that they would never again get involved as hosts in such an affair.

I would appreciate your comments as we are anxious to conclude this matter in a manner that would be acceptable to all parties involved.
