PROPOSAL TO THE 1988 ACYOA GENERAL ASSEMBLY TO AMEND THE ACYOA CONSTITUTION

AMENDMENT:

Article 13, Section 1 shall read:

The fiscal year shall be from January first to December thirty-first.

PRESENTLY:

Article 13, Section 1 reads:

The fiscal year shall be from July first to June thirtieth.

ADDITIONAL:

This amendment shall be effective on January 1, 1987.

RATIONALE:

The present fiscal year is often confusing, particularly in terms of dues collection and eligibility to participate in the National Sports Weekend.

PROPOSED AMENDMENT TO THE ACYOA CONSTITUTION SUBMITTED BY THE ACYOA CENTRAL COUNCIL

PROPOSED AMENDMENT: AMENDMENT TO BE NAMED: ATRICLE 12, SECTION 5

A detailed report, including financial records shall be kept by the Host Chapter. The reports and event proceeds shall be sent to the Central Council within ninety days of the event.

If written request is received by the Central Council before the deadline, the Central Council may extend the deadline by no more than an additional ninety days at their discretion.

The Sports Weekend Host Chapter shall offer an ... "Eligibility Package Plan" consisting of a minimum of Saturday evening dance and Sunday Avards Banquet and dance, and the cost of this "Eligibility Package Plan shall not exceed one-half of the cost of a Sports Weekend Package Plan, which includes all events offered by the host chapter.

AMENDMENT:

Article 5, Section 2 shall read:

Annual dues for ACYOA members shall be designated by the General Assembly. One-half of the amount shall be sent to the ACYOA Central Council Treasurer. The minimum annual dues shall be ten dollars (\$10.00). Dues must be forwarded to the Central Council Treasurer within the calendar year.

PRESENTLY:

Article 5, Section 2 reads:

Annual dues for ACYOA members shall be designated by the General Assembly. One-half of the amount shall be sent to the ACYOA Central Council Treasurer. The minimum annual dues shall be ten dollars (\$10.00). Dues become deliquent with the start of the third quarter of the fiscal year (January 1st).

RATIONALE:

This amendment will make dues collection and payment easier, as the chapters and Central Council will be working with calendar year dates.

To be considered a member of the national ACYOA, it is still in the best interests of individuals and chapters to pay dues early in the calendar year.

CONSTITUTIONAL AMENDMENT SUBMITTED TO THE 1988 GENERAL ASSEMBLY BY THE CENTRAL COUNCIL

PROPOSED AMENDMENT: ADD THE FOLLOWING:

ARTICLE 10, SECTION 14

THE ACYOA EXECUTIVE SECRETARY SHALL HAVE A NON-TRANSFERABLE PRIGHT OF VOICE AT THE GENERAL ASSEMBLY.

We propose to accept this Amendment with the following changes:

Article 10(of the amendment) is changed to Article 11, and that the section number is changed to number 17. We deemed that these areas of the Constitution were better suited for purposes of paralell structure.

- 4. During Lent there would be very few other events taking place.
- 5. May coincide with Spring break.
- 6. More serious during Lent and a shorter weekend.
- 7. Could be held in a non-parish city (i.e. Cancun)

RELIGIOUS COMMITTEE PROPOSALS

Whereas the nature of the ACYOA is intended to be a Christian youth representation of the church, and considering presently the order of committee reports is as follows: Jasse

- A. Budget
- B. Proposals
- C. Constitutional Ammendments
- D. Resolutions and Courtesies
- E. Programming
- F. Religious Programming
- G. Inter-Diocesan

We propose that the Religious Programming Presentation should assume its proper order of priority and supercede all other reports.

2. Whereas, the present National Assembly meets to promote the growth and enrichment of ACYOA. Presently, its agenda is in the format of all business meetings. We propose that the Assembly should exemplify this growth and enrichment of its community by including a "Last Supper" dinner on Thursday evening or by a closing Worship Service on Friday afternoon.

3. Whereas, the ACYOA should represent a balance of the true marks of the church, as established by the Blue Ribbon Committee and whereas Sports Weekend is a major representation of the existence of ACYOA; the present competition do not fulfill that balance. We propose that within the competition of Sports Weekend an area of Church Tradition and Bible Contest be included.

- 4. Whereas the purpose of the presentation of the A Award 1s to be awarded to that chapter which exemplifies and excels in fulfilling all areas of the meaning and purpose of ACYOA. Whereas presently the point system is deficient of any points awarded towards religious aspects. We propose that the A Award include twenty points if their Parish offers a Bible Study for its members and carries it through.
- 5. We, the Religious Committee, recommend that on Youth Sunday, designated presently as the 3rd Sunday of the month, the ACYOA have a "Youth Oriented English Meditation" during the Divine Liturgy. This would be supervised by someone with the knowledge necessary. An example would be the program that exists in the Watertown parish.
- 6. We recommed that a regional Bible Study be offered to "Cluster Parishes with specific themes in mind.
