We wish to make two observations.

We realize the importance of such social activities, but feel, nevertheless, that some balance must be introduced to our youth programs. No spiritual, no cultural programs at all? We direct your attention to this, and hope that at least a small measure of reorientation will be effected and that our youth will plan, and their publication reflect, programs of religious and cultural content, together with the social.

The second observation relates to the inclusion of the item on Armenian dissidents, which seemed to us out of place in such a publication. Nothing political should appear in our publications. 
