I am submitting this letter to His Eminence for his sanction in considering Very Rev. Fr. Baret Yeretzian as Pastor of the Holy Cross Armenian Church, Lawrence, Mass. Despite the previous communications which were sent to His Eminence concerning other clergy, our Parish considers it appropriate for Father Baret's appointment for several reasons. In addition, we feel that, at this time, with our parish heavily involved in its building obligations and expansion plans, Father Baret would guide our parishioners with a leader-ship of surety. In a recent meeting with Father Baret we discussed and tentatively agreed upon the following terms, pending the approval of this appointment by His Eminence.

Holy Cross would provide:

- 1. A \$15,000 annual stipend.
- 2. All housing and utility expenses.
- 3. An automobile with mileage allowance.
- 4. Medical and insurance costs.
- 5. Pension plan expenses.
- 6. Moving expenses to Lawrence.

We thank His Eminence for his considerations and acknowledge with gratitude and deepest respect the deliberations which involve the position of the Primate.

One of the two enclosed copies is to be signed and dated and sent to me, the other copy is to be kept for your records. As indicated by the Primate, this matter will be presented at the next Diocesan Council meeting set for August 16, 1985. It is important that you respond without delay. If there are any questions, please call me.

We hope and pray that the necessary approvals and your arrival to our parish will go smoothly and as quickly as the administrative system will allow.
