We, Bedros Aznoian and Paul Bogosian, both of Methuen, in said County, and Sarkis Verdanian of Lawrence, in said County, on oath depose and say that we are respectively, the President, Treasurer and Secretary of the Trustees under a Declaration of Trust made by Jacob B. Bagdoian et alii, dated April 16, 1928, recorded with North District of Essex, Registry of Deeds, Book 541, Page 555; that the said Sarkis Verdanian is the keeper of all records not only of said Trustees, but also of the records of the meetings of the members of a voluntary association known as the Armenian Apostolic Church at Lawrence; that since the last recorded record of the election of nineteen (19) Trustees under said Declaration of Trust which was recorded on February 1st, 1934, with the North District of Essex, Registry of Deeds, Book 575, Page 367, and an amendment thereto recorded on March 25, 1939, in the North District of Essex, Registry of Deeds, Book 621, Page 212, the following named persons have, by virtue of death, resignation or for other valid reasons have ceased to be Trustees under said Declaration of Trust: Leo Parnagian, Kachador Faradian, Krikor Krikorian, Louis Zerigian, Giragos H. Giragosian, A. M. Azarian, Kachig Balian, Merderos Chilingerian, Bedros G. Babigian.

That, as set forth in Article 14 as amended by said document recorded with North District of Essex, Registry of Deeds, Book 575, Page 367, the remaining Trustees from time to time, in each instance complying strictly with "the provisions and methods prescribed by the constitution of Armenian Apostolic Churches of America", have at duly warned meetings filled the vacancies caused by such resignations and deaths and have elected as Trustees the following named persons who have all accepted said appointments and who are all now duly and properly constituted Trustees under said Declaration of Trust: Bedros Aznoian, Paul Bogosian, Sarkis Verdanian, Peter H. Azarian, Moushegh K. Hagopian, Jack J. Kachanian, Casey Kazanjian, Melkiset Krikorian and Charles Sirmaian.
