Dear Father Ghevont:

We have enclosed a copy of a map which marks off the geographical boundaries of your parish in relation to the sister parishes of Haverhill and Lawrence. Also included is a listing of the towns and areas in Massachusetts, New Hampshire, Maine and Vermont that belong in each jurisdiction.

These subdivisions must be respected according to the following conditions:

- 1. If a parishioner voluntarily seeks to become a member of any parish, even outside a prescribed jurisdiction, he cannot be prevented from doing so.
- 2. No parish may actively solicit or otherwise encourage the membership of those who live outside its jurisdiction.
- 3. If a parishioner moves outside the jurisdiction of a parish, he may, if he so chooses, retain his membership in his old parish despite his new residence outside its jurisdiction.
- 4. A parish may seek members in areas continguous to its boundaries if such does not represent infringement on the jurisdiction of other parishes.
- 5. Any differences that cannot be resolved locally are to be directed to the attention of the Primate.
