This action, by writ and complaint, claiming a dissolution of the marriage of the parties and other relief, as on file, came to this Court on May 25, 1982, and thence to later dates when the defendant appeared pro se, but made no defense, and said action was claimed for the hearing list and when the plaintiff appeared to prosecute the claim for a dissolution of said marriage.

The Court, having heard the evidence finds the following:

1. The wife, by the name of Patricia M. McCahill and whose prior married name was Patricia M. Lampe, was lawfully married to the husband on August 25, 1976 at New Britain, Connecticut.
2. One party has resided continuously in this State twelve months next before the date of the filing of the complaint or next preceding the date of this decree, and all statutory stays have expired.
3. The marriage between the parties has broken down irretrievably.
4. The plaintiff and the defendant have no minor children issue of their marriage.
5. No other minor children have been born to the plaintiff since the date of the marriage of the parties.

Whereupon it is adjudged that the marriage of the parties to this action be and it is hereby dissolved and they are each hereby declared to be single and unmarried.

AGREEMENT
