

At the 1985 Annual Parish Assembly held on January 27, 1985, the Parish Assembly voted to maintain Fr. Vartan's stipend at the 1984 level of \$ 19,600 for 1985, as opposed to the Parish Councils recommended amount of \$ 22,100 for 1985, as reported in the minutes of the Parish Assembly.

At it's February 11, 1985 meeting the Parish Council corrected the Parish Assembly's action and reinstated Fr. Vartan's stipend back to the recommended amount of \$ 22,100 for 1985, as agreed upon with Fr. Vartan and in accordance with the Diocese Stipend Committee directives.

We ask for your review and approval of our action.

Background and Reasons Follow:

This Parish has not been able to meet the minimum stipend guide lines of the Diocese. Our situation was reviewed with the Stipend Committee, the Parish Council was asked to come to an agreement with Fr. Vartan. This was done on December 23, 1981, and a schedule of increases was agreed to and implemented. The proposed stipend in the 1985 budget was in effect a continuation of that agreement, with a cost of living adjustment.

It is the position of the Parish Council that this agreement as stipulated by the Diocese was violated. The Parish Council's reinstatement of the \$ 22,100 amount is required to maintain the above mentioned agreement.
