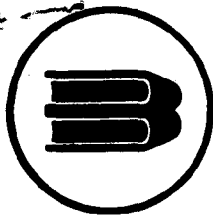

BOOKCRAFTERS TERMS OF SALE

- 1 ORDER AND ACCEPTANCE.** All orders based upon this estimate include the terms and conditions contained on the face and reverse hereof. All orders and changes therein shall be in writing. Within ten (10) days of receipt of any order, BookCrafters may accept or reject such order without liability. All orders are accepted at BookCrafters' home office in Chelsea, Michigan. All estimates and contracts are subject to revision within ten (10) days of receipt of materials from Customer. All contracts are subject to revision in price with increases in wages or material prices over which BookCrafters has no control. Estimates are based on work being performed during regular straight-time working hours and conditions prevailing at date of estimate.
- 2 ORAL AGREEMENTS.** Neither party is bound by oral agreements or representations which are contrary to the terms and conditions herein.
- 3 MANUFACTURER'S LIEN.** In consideration of the acceptance of any order, it is agreed that a manufacturer's lien for all work theretofore or thereafter performed shall attach to all property of Customer at any time while in the possession of BookCrafters. The extension of credit or the acceptance of notes or guarantees of payment, whether or not the amount claimed was incurred in connection with such property or otherwise, shall not affect such lien.
- 4 EDITION BINDING. Receipt of Customer material.** All printed sheets shall be properly jogged, cut to size, and imposed for BookCrafters' equipment. BookCrafters shall not be required to hand-count sheets or other material supplied by Customer or his agent. The basis of count of sheets shall be the folded and gathered record made as soon after receipt as practicable.
- 5 CUSTOMER FURNISHED MATERIAL.** All camera copy, art work and other materials supplied by Customer for reproduction shall be clean, properly ordered, prepared in full compliance with the standards of the industry and shall have all paste-ons and strip-ins securely affixed so as not to become dislodged during ordinary handling. BookCrafters shall not be held liable to any extent whatsoever for any defects in the completed product occurring as a result, in whole or in part, of any defects in Customer supplied materials.
- 6 EXAMINATION FOR DEFECTS.** The estimated price includes the following examination of the completed work: freeing the end papers, noting that the book is cased properly, once fanning through the leaves preparatory to wrapping. BookCrafters has no obligation to perform any proofreading operations and is not responsible for editorial continuity. Customer-supplied materials must bear folios, page numbers, signature identifications or collating references. BookCrafters has the right to place full reliance upon such instructions and their positioning as final guides to the printing, folding, gathering and sewing of the completed work. BookCrafters will not be responsible or liable in any way for defects in paper, nor for errors within folded signatures when submitted only for binding. Where a special examination for defects is desired, a separate and distinct written agreement must be made.
- 7 DEFECTIVE OR DAMAGED BOOKS.** Customer will examine BookCrafters' finished product and must notify BookCrafters of any defects in, or damage to, the completed product within 30 days of the date upon which the first shipment of said product leaves BookCrafters' production facility. Failure of Customer to notify BookCrafters of any defect or damage within this 30 day period constitutes acceptance by Customer of that product and recognition by Customer that said product was delivered to the carrier in acceptable condition. In the case of defective books, where responsibility attaches, BookCrafters' liability shall be limited to correcting and repairing such books. Where such corrections and repairs are not practicable, or at any other time at the election of BookCrafters, BookCrafters' liability may be discharged by giving to Customer credit for such defective or damaged books at the overrun price attributable to such books. In addition, where materials used in the production of such books have been supplied by Customer, Customer shall be credited with the cost of his materials consumed in the production of such defective or damaged books.
- 8 INDEMNITY.** It is expressly understood and agreed that the Customer covenants to indemnify BookCrafters against any and all claims, demands, recoveries, attorney fees and costs which may be incurred by BookCrafters in any suit which may be brought against BookCrafters or others by reason of (1) any violation or infringement of any proprietary right to copyright, (2) any libelous, obscene, or unlawful matter contained in the writings that are subject matter of this contract, (3) Customer's breach of any term, covenant, representation, or warranty of this contract, or (4) anything whatsoever that might prejudice the securing to BookCrafters or its assigns of the full benefit of the rights herein granted.
- 9 GOVERNING LAW AND JURISDICTION.** This agreement shall be deemed to have been made in Washtenaw County, Michigan and shall be interpreted, and the rights and liabilities of the parties determined, in accordance with the laws of the State of Michigan. Customer and BookCrafters agree that any suit which may be filed as a result of any controversy arising under the terms hereof shall be filed only in a court of competent jurisdiction located in Washtenaw County, Michigan. Customer acknowledges that it is doing business in the State of Michigan, agrees that the State of Michigan is a reasonably convenient place for the trial of any action which may be filed and consents to the jurisdiction of the Michigan courts for the resolution of any dispute which may arise hereunder.
- 10 DISCLAIMER OF WARRANTIES. BOOKCRAFTERS GIVES NO WARRANTY, EXPRESS OR IMPLIED, AS TO MERCHANTABILITY, FITNESS FOR PURPOSE SOLD, DESCRIPTION, QUALITY, OR ANY OTHER MATTER WHATSOEVER. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE EXPRESS TERMS CONTAINED HEREIN.**
- 11 FULFILLMENT.** Fulfillment services are provided by BookCrafters at prices as contained herein and as contained in a separate pamphlet available to Customer. The prices for said services may be altered by BookCrafters without notice to Customer to reflect prevailing market rates. Customer agrees to pay for fulfillment services at then existing prices. Customer agrees that all orders for and provision of fulfillment services shall be governed by the terms and conditions contained herein and in the then operable pamphlet.
- 12 PAYMENT AND TERMS.** Customer agrees to make payment in accordance with the terms contained on the face and reverse hereof. BookCrafters may elect to declare all unpaid balances due immediately due and owing at any time upon expiration of the payment period set forth on the face hereof. Should customer fail to make payment in full of all sums owing, including accrued interest, within ten (10) days of mailing by BookCrafters of a demand for immediate payment, then Customer agrees to compensate BookCrafters for all costs reasonably incurred in collecting said sums, including payment of reasonable attorney fees incurred by BookCrafters.
- 13 SKETCHES, COPY DUMMIES,** and all preparatory work created or furnished by BookCrafters shall remain its exclusive property and no use of same shall be made, nor may ideas obtained therefrom be used, except upon compensation to be determined by the owner.
- 14 ART WORK, TYPE, PLATES** (including lithographic plates), engravings, electrotypes, negatives, positives, and other items when supplied by BookCrafters shall remain its exclusive property, unless otherwise agreed in writing.
- 15 ALTERATIONS.** Proposals are only for work according to the original specifications. If through Customer's error, or change of mind, work has to be done a second time or more, such extra work will carry an additional charge, at current rates for the work performed.
- 16 STANDING TYPE MATTER,** plates (including lithographic plates), and negatives will not be held after completion of the order except by special agreement and charge therefor.
- 17 OVERRUNS AND UNDERRUNS** not to exceed 10% of the amount ordered shall constitute an acceptable delivery, and the excess or deficiency shall be charged or credited to Customer pro rata for paper stock, presswork and binding, exclusive of makereadies.
- 18 CUSTOMER'S PROPERTY.** BookCrafters shall charge Customer, at current rates, for handling and storing Customer's stock or Customer's printed matter held more than thirty (30) days. All Customer's property that is stored with BookCrafters is at Customer's risk, and BookCrafters is not liable for any loss or damage thereto caused by fire, water leakage, theft, negligence, insects, rodents, or any cause beyond its control. It is understood that the gratuitous storage of Customer's property is solely for the benefit of the Customer.
- 19 UNLESS OTHERWISE SPECIFIED,** the price estimated is for preparing a single shipment. BookCrafters' responsibility for shipments ceases with the delivery to the carrier. Claims for loss or damage should be presented to the carrier.
- 20 DELAYS IN DELIVERY.** All contracts are made contingent upon wars, strikes, fires, floods, accidents, availability of material or other contingencies beyond BookCrafters' control.
- 21 REPAIRS, CHANGES,** trimming, mortising, anchoring, special proofing, or similar work required on materials which are furnished by Customer, including but not limited to drawings, engravings, electrotypes, and negatives, shall be billed at current market rates.
- 22 PAPER STOCK** furnished by Customer shall be properly packed, free from dirt, grit, torn sheets, bad splices, etc., and of proper quality for BookCrafters' printing requirements. Additional cost due to delays or impaired production on account of improper packing or quality shall be charged to Customer.
- 23 COLOR PROOFING.** Because of the difference in equipment and conditions between color proofing and pressroom operations, a reasonable variation in color between color proofs and the completed jobs shall constitute an acceptable delivery.
- 24 FREIGHT.** Prepaid shipments made by BookCrafters will be invoiced at cost plus a handling fee of 5%---(minimum \$5.00)
