
Also, members pay their dues on that day, therefore, in order to avoid confusion, we start at 10 am, and continue until 3:00 pm.

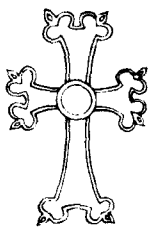

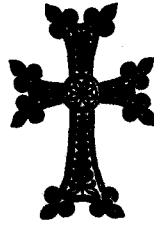
