DECREE ABSOLUTE OF DIVORCE

WHEREAS the Petitioner has instituted divorce proceedings against Respondent;

WHEREAS the Respondent has not appeared within the prescribed delays and default has been taken against her ;

WHEREAS the Court, on May 22, 1974 after having examined the Exhibits filed and heard the proof and the submissions of Petitioner's Counsel, issued a decree nisi of divorce:-

1.- declaring that the Petitioner LEON NAZOYAN whose marriage with the Respondent Dame ROZA MANOUKIAN was solemnized on November 6, 1971, at St. Gregory the Illuminator Cathedral at Outremont, district of Montreal, be divorced from the Respondent, unless sufficient cause be shown to this Court, within three months from the date hereof, why this decree should not be made absolute;

THE COURT HEREBY DECLARES the said decree nisi to be now absolute and the Petitioner LEON NAZOYAN whose marriage with the Respondent Dame ROZA MANOUKIAN was solemnized on November 6, 1971, at St. Gregory the Illuminator Cathedral at Outremont, district of Montreal, be divorced by these presents from Respondent ;
