Dear Mr. Stoneson:

We wish to acknowledge receiving your letter of December 5 informing our parish council of the Primate's request to have Fr. Paree, our Pastor to be Camp Director for St. Vartan Camp in 1984.

I can assure you that our parish council members recognize the importance of St. Vartan Camp Program and will be supportive of this assignment as we have been in the past.

With reference to the fifth paragraph of your letter and the needs of our parish during our Pastor's two weeks absence, we assume that clergy will be made available to us for the two Sundays in question through the Diocesan office and the appropriate exspenses for the clergy will be met either through the Diocesa or through the St. Vartan Camp Program.

In addition, we are sure you will recognize that Fr. Paree's assignment to the camp program does not begin and end with his two week absence from our parish. It does require considerable amount of his time and effort prior to the camp season. Again this is not a serious problem from our point of view. We do feel however that his activities as a Camp Director should not include fund raising activity for the camp and that the financial needs for the camp program should be dealt with either through the Diocesan budget or through the St. Vartan Camp Committee itself. We trust that the committee will take appropriate steps to relieve Fr. Paree of any fund raising responsibilities so he may concentrate his efforts in planning for the camp season and making it a success in all other aspects.

We would appreciate your confirmation that our understanding of the above points are not in conflict with the understanding you have or those of the Primate.

H.E. Archbishop Torkon Mancogian has accepted your 1983 parish annual report, and enclosed is his letter of approval.

However, there are a few discrepancies which require your immediate attention:

- a) In Section I of Financial Report the total amount of Receipts and Donations should be \$63,532.67 instead of \$63,542.67. Consequently, the total receipts on page two of the same report should be \$253,304.93 instead of \$253,207.43, a variance of \$97.50.
- b) The election of the assembly officers were not held in accordance with Article 14 (a) and (b) of the Bylaws.
- c) The Parish Council report is presented in the first person, singular, on behalf of the chairman. Since this is the report of a group of elected officers, it would be advisable to have it prepared for the signatures of the President (Priest) and the Secretary, in addition to the Chairman.

Please consider the above points in preparing your next year's report and thanks.
