Dear Father Kasparian:



This year, your parish has fallen behind schedule, thus resulting in a deficit of \$200,000.00 of our annual budget. Presently you are in the arrears amounting to \$5,509.00. The lack of financial support from the parishes has drastically affected the operation of our Diocesan Departments and their work and ministry to you.

Noting that your assessment has not been received and is not current with your scheduled obligation, we ask that you make every effort to assure timely payments so that we might be able to maintain a consistent level of operation at the Diocese which will ultimately benefit your parish and community.

We are in receipt of your letter of March 28, 1994 wherein you have requested permission to change the name of your church.

I have given careful consideration to your rationales to a name change, but I am afraid that I find them unpersuasive; nor do the practical circumstances demand such a radical measure as altering the consecrated name of an Armenian sanctuary.

While I am sympathetic with the request of your community, as expressed through its special assembly, it is also important to understand that the sacrament of consecration -- like all the sacraments of the church--are serious and binding matters, which ought not to be broken lightly. Once again I do not give my permission to change the name of Holy Shoghagat Armenian Church.




