Gentlemen:

I would like to begin this letter by introducing to you the East St. Louis Armenian Independent Club, an organization who has recently purchased a church for the community of East St. Louis, Illinois. This church building, including church, on the first floor, and hall in basement was purchased at a price of \$22,000, with \$6,000 down payment and mortgage payments at \$125 per month for the coming 15 years.

Our main purpose in writing to you is that we are interested in dedicating our church, so that we may in the future be able to hold church services for the Armenian people of East St. Louis. It is our understanding, since we know so very little about the rules and regulations of the Armenian Religion, that there are many aspects to be considered in the dedication of an Armenian Church that do not prevail in the other denominations of religion.

The church as it was before we purchased it was a Trinity Lutheran Church, with an altar arrangement that we understand is not appropriate for the Armenian service, since we have heard that the Armenian altar should be in a particular direction from the congregation.

Another factor that we have been told which has to be considered is the affiliation with the Mother Armenian Church from which derives the factor of obtaining a priest who will consider giving a sermon in an Armenian Church of one kind of affiliation or another. Also, whether the Armenian Church, wherever or whatever kind it may be, is to belong to a Mother Church after dedication, and under what circumstances.

It would be appreciated if you would consider this letter with the utmost importance and let us have your answers to the various questions above, which are to us very important in order that we may be able to proceed with the necessary arrangements to start our church on the right road for the future of our community.

The Armenian Apostelic Church, which stands as one of the greatest of National Christian churches, traces its history to two of the Apostles, Saints Thaddeus and Bartholomew, who brought Christianity to Armenia during the first century. In the year 301 A. D., Saint Gregory the Enlightener founded the Armenian Church in Holy Etchniedzin, Armenia. To this day, Holy Etchniedzin is revered as the Holy See of the Armenian Church.

Through the efforts of Saint Gregory, a vast number of the people, King Tiridates and the royal court, were converted to Christianity and they embraced the faith devoutly. Armenia thereby became the first nation in the world to proclaim Christianity as the state religion. Despite a tragic history of persecution and massacres, the nation and her people in the Disspora have remained faithful during the centuries to their church and to the spiritual authority exercised by His Holiness, the Catholicos Patriarch of All Armenians.

The Armenian Church first took root in America when the Rev. Fr. Hovsep Sarajian arrived in 1889 as the first Armenian priest to come to this country; and in the same year the Divine Liturgy of the Armenian Apostolic Church was celebrated for the first time in America at the Church of Our Eaviour in Worcester, Mass. In the years which followed, His Holiness the Catholicos issued encyclicals establishing Dioceses in America as well as in other parts of the world. Since 1889, eminent priests and bishops have served in the numerous parishes which grew and spread throughout the United States; and American born young men are now enrolled in schools of theology in this country, as well as in the renowned St. James Monastery in Jarusalem, in preparation for Holy Orders in the Armenian Church.

In 1955, His Eminance Archbishop Mampre Calfayan, Primate of the Armenian Church in America, attended the consecration of His Holiness Vazken I, who became the 130th Catholicos Patriarch in Apostolic succession to the throne of the Holy See in Etchmiadzin since the time of Saint Gregory the Enlightener.

Dear Mr. Chirkinian:

It has been reported to us that your parish council allowed itself to reduce the salary of your parish priest, Fr. Mesrob from \$65.00 to \$55.00 a week. The reasons given were that he does not know the English language and that his administrative abilities are limited. We are very much disappointed for this action and would like to point out the fact that it is not fair to reduce the assigned salary of the church servant within any circumstances. It should also be noted that the recognized minimum salary of our clergy is \$75.00 per week. However we did not, at the time, comment to your paying Fr. Mesrob \$65.00.

The Clergy Assembly of our Discess which convened on November 13th & 14th heard of the case with concern, and found that it was an act of injustice. It should, moreover, be noted that in the event of Fr. Mesrob resigning from his position, it may take years before we shall be able to appoint another clergy for your church, because 18 parishes out of a total of 42 in our diocese, are without a clergy today.

We have had the opportunity of meeting some of your parishoners who, not only did not complain of your priest, but on the contrary, expressed their satisfaction in the performance of his duties. We are sure you realize that the duties of the parish council are to preserve peace and harmony in the community. With this in view we instruct you to settle the matter of Fr. Mesrob in a satisfactory way and keep us informed.

We take this opportunity to remind you also that in our Circular No. 29 dated February 13, 1957, we had instructed our parishes that deacons should not be elected as members of parish councils. Your parish assembly failed to comply with this instruction and elected some deacons for your parish council. During the next few months

you will call for a parish assembly to elect some parish council members. We advise you to bring this matter to the assembly's attention, in order to carry out the instructions of the above circular.

Dear Archbishop Manoogian,

Again let me take this opportunity, on behalf of the Parish Council of the St. Shoghagat Church in East St. Louis, to convey our congratulations and best wishes to Your Grace upon his installation as Primate of the Armenian Churches in America.

Your Grace, I have been instructed by the Parish Gouncil to write you several matters that we consider very important.

First, the matter of Easter and Holy Week services. Father V. Papazian advises us that he will be unable to be here to conduct services for Palm Sunday, Easter Sunday, or for that matter, the Sunday following Easter.

The nearest Armenian church being in Chicago, three hundred miles away, leaves our people without Easter Services. To make matters worse, the dissident church in this area has a steady priest and will hold Easter services as they have in the past.

Under circumstances like these how can we hold our people and try to solidify the position of our young church in this community? We feel this matter to be of utmost importance and hope that Your Grace will make an arrangement, possibly with one of the churches that have two resident priest, so that the people in our community will be able to hold Sourp Badarak on this most memorable Easter Day.

As the printing and mailing of announcements takes time, an early answer would be deeply appreciated.

Since the consecration of our church, almost three years ago, we have had many visting priests, who conducted services in our church. Father Papazian has conducted services about fifteen times in 1958. We are most appreciative to all of the priests but we contend that a church's and a priest's

duty to a community is much more than conducting services on Sunday. Our bhurch is new and needs guidance and help. None of the church organs have received this help. Our choir is continually growing worse and more disorganized for lack of leadership. We cannot be expected to learn if no one will teach us or lead us.

We are aware of the shortage of priests in our discess, but we know that other churches, consecrated as long as two years after ours, have a regular priest. We cannot understand this in view of the fact that we have requested and have been promised the "very next" priest that was ordained. We have repeated this request many times, orally and in writing. Our community stands ready and able to support a resident priest.

To say the very least, we are most distressed with the situation here and feel that a short personal visit in the very near future from Your Grace, or the Vicar-General, would be most beneficial for us. Our entire community awaits your visit.

### Your Grace:

We, the undersigned members of the Holy Shoghagat Parish Council, having been informed of the contents of your letter dated November 21 in which you state our resignations unacceptable, do out of respect for the wishes of Your Grace, the love of our Church and the requests of many sincere parishoners, promise our full cooperation as Parish Council members during the remainder of our respective tenures of office. We take this action notwithstanding the fact there has been no change in the policies and utterances of those who created this situation and who now say that the very fact nothing at all was said, officially proves all the lies and half truths circulated about the Parish Council and others are true.

Your Grace, on this matter we are relying upon your infinite wisdom and sense of justice to rectify further smear of our names as it is not our wish to seek justice in areas other than that of the Church. We have, in a word, decided not to "knuckle under" the well organized minority faction that is attempting to gain control of the Church through many deceptions for the satisfaction of their individual egos.

We again pledge our full co-operation, Your Grace, as long as, and only as long as, the written By Laws of the Constitution of the Armenian Church are not violated in any way. Where there are efforts to by pass or misinterpret the Armenian Church By-Laws, we promise that we will be equally vigorous in our opposition of any attempt to make a mockery of the Church rules and the Armenian Church for which they stand. We are confident Your Grace will concur with us in this stand, for it was Your Grace, who during his last visit here, emphasized the importance of adhering to the By-Laws in everything we did.

More specifically, we refer to Section Eight of the By-Laws that deal with Church membership, eligibility to vote and eligibility to hold any elective office. It is our intention to uphold these and all Sections of the Church By-Laws before, during, and after the forthcoming preliminary and regular Parish Assemblies. May we add that your suggestion to hold the meetings in the presence. of the Vicar General is an especially good one, considering the tensions that exist here. Your Grace, putting these facts in writing is distinctly distasteful to us, but you must have sensed the shameless feelings that almost erupted into violence at the ACYOA meeting at which you presided during your visit here. We, therefore, make these suggestions out of practical considerations for the situation is no less explosive now. It is a matter of fact everyone is awaiting these annual meetings to voice opinions pro and con on the situations existing here. We regretfully point out that any unruly meeting will truly shatter this parish.

In closing may we refer to the October-November issue of the Armenian Church Monthly:

"True unity can come only in an atmosphere of Christian brotherhood and mutual respect."

Let there be no mistake, this unity does not exist in our parish nor is it being promoted by those who have vowed to do so.

Your Grace:

In response to your letter dated August 24, we wish to inform you of the decisions taken at the September 11 meeting of our Parish Council.

Under separate cover you will receive a letter of resignation from Hayr Gomidas submitted to this Parish Council. According to the church bylaws, we are forwarding it to Your Grace. The Council took no action on the resignation except that we strongly urged Hayr Gomidas to reconsider his decision.

As Your Grace probably knows, we are celebrating this year the tenth anniversary of the consecration of our church. During the course of these ten years, we have had Hayr Gomidas for the past two years and Deacon Levon Daghlian for one year. Suffice it to say that both of them have proved inexperienced and unable to generate the badly needed motivation that is the basic responsibility of a leader. In short, we have not in the past ten years had anyone who has given us more than a service on Sundays.

Your Grace, the Council feels that since we had no priest for seven years and only trainees for the last three, we would be derelict in our duties as council members if we did not point out this situation to you.

The past ten years have taken their toll in membership, finances, enthusiasm, and, most important, Christian spirit, to the point where we can no longer endure another blunder. It is impossible in a few short paragraphs to relate the history of our first ten years and impress upon Your Grace the seriousness of our situation.

For these reasons we respectfully submit that our Parish needs and deserves the highest priority and consideration of Your Grace so that this time we may be blessed with an experienced and competent Priest whether he be young, old, celibate or not.

Since we feel that Hayr Vahrij does not meet the above requirements and that his main efforts will be directed toward his education, the Council does not accept him as our Priest, and we hereby notify you of this decision.

We are sure Your Grace will see the wisdom in our decision and give our request his earliest consideration.

Forgive the delay in answering your letter however, it just reached my attention. I will try to answer the several inquiries that it included.

Firstly, I have included an abridged "Armenian Church Directory" which should assist you.

Secondly, the Armenian-American community numbers some 500,000 souls, the majority of which are affiliated with the Church in one way or another. I suggest you directly contact the other Dioceses for the statistics pertaining to them.

Thirdly, I have included reprints of sections from The Church of Armenia by Malachia Ormanian, former Armenian Patriarch of Constantinople, which deal with the positions of the Armenian Church vis-a-vis other churches and denominations. While the book was printed many years ago (1910), its texts regarding Dogma and Church Doctrine are still in force.

Finally, I have enclosed a transliteration chart which corresponds to the pronunciation of classical Armenian. Today, the Eastern Armenian pronunciation is similar to the classical Armenian while Western Armenian differs slightly from the classical.
